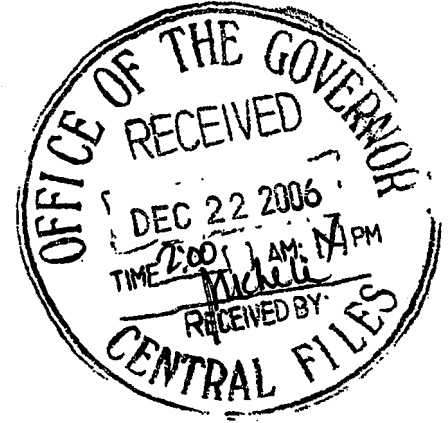





**AN ACT TO DEAPROPRIATE \$140,000.00 FROM THE
SUMS APPROPRIATED TO *I LIHESLATURA* AND TO
REAPPROPRIATE SAID SUM TO THE "EVERY CHILD

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Deappropriation and Reappropriation.** The sum of
3 \$140,000.00 is deappropriated from the sums appropriated to *I Liheslatura*
4 prior to December 31, 2006, and reappropriated to the "Every Child is
5 Entitled to an Adequate Public Education Fund." Notwithstanding any other
6 law or rule, the Fiscal Officer of *I Liheslatura* is authorized to reduce the

- 1 allotment to Senator Klitzkie by an amount equal to the sum deappropriated
- 2 by this Section.
