



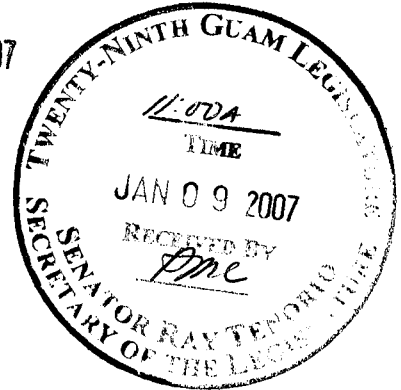





**AN ACT TO *AMEND* §34103(b) OF ARTICLE 1,
CHAPTER 34, TITLE 10 GUAM CODE
ANNOTATED, RELATIVE TO CHANGING THE
LENGTH OF PET LICENSES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. §34103(b) of Article 1, Chapter 34, Title 10 G.C.A. is hereby**
3 ***amended to read:***

4 “The license shall be valid for three (3) years from the date of issue if the pet
5 has received a three (3) year rabies vaccination at the time of issuance. Otherwise,

- 1 the license shall be valid for the time remaining on the rabies certificate plus a forty-
- 2 five (45) day grace period.”
