AN ACT TO OFFICIALLY NAME THE AREA NOW REFERRED TO AS THE "DEDEDO FLEA MARKET" THE "MAYOR JOSE A. RIVERA MARKETPLACE", AND TO HAVE A PLAQUE PLACED ON THE SITE COMMEMORATING THE LATE MAYOR RIVERA'S ROLE IN ESTABLISHING THE MARKET FOR THE RESIDENTS OF DEDEDO.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Name Change. The name of the area currently referred to as
- 3 the "Dededo Flea Market" shall be changed to the "Mayor Jose A. Rivera
- 4 Marketplace." Such change shall take place upon enactment of this Act into law.

- 1 All references in government of Guam documentation and signage shall reflect this
- 2 change.
- 3 Section 2. Commemorative Plaque. The Department of Parks and
- 4 Recreation (DPR) shall design and have produced an appropriate commemorative
- 5 plaque to be placed at the site that bears the late Mayor Rivera's name. DPR shall
- 6 work with the Mayors' Council of Guam and the Dededo Mayor's Office to
- 7 determine the appropriate wording, design and location for the plaque.
