





**AN ACT TO OFFICIALLY NAME THE AREA NOW REFERRED TO AS THE "DEDEDO FLEA MARKET" THE "MAYOR JOSE A. RIVERA MARKETPLACE", AND TO HAVE A PLAQUE PLACED ON THE SITE COMMEMORATING THE LATE MAYOR RIVERA'S ROLE IN ESTABLISHING THE MARKET FOR THE RESIDENTS OF DEDEDO.**

1           **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2           **Section 1. Name Change.** The name of the area currently referred to as  
3 the "Dededo Flea Market" shall be changed to the "Mayor Jose A. Rivera  
4 Marketplace." Such change shall take place upon enactment of this Act into law.

1 All references in government of Guam documentation and signage shall reflect this  
2 change.

3 **Section 2. Commemorative Plaque.** The Department of Parks and  
4 Recreation (DPR) shall design and have produced an appropriate commemorative  
5 plaque to be placed at the site that bears the late Mayor Rivera's name. DPR shall  
6 work with the Mayors' Council of Guam and the Dededo Mayor's Office to  
7 determine the appropriate wording, design and location for the plaque.
