**AN ACT TO *AMEND* SECTION 8141(b) OF TITLE 4 OF THE  
GUAM CODE ANNOTATED PERTAINING TO THE  
SCOPE OF THE GOVERNMENT OF GUAM  
RETIREMENT FUND'S ATTORNEY POSITION.**

1        **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2        **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds it  
3 necessary to clarify the scope of the attorney position at the Government of Guam  
4 Retirement Fund, as well as the scope of the Attorney General's representation of  
5 the Fund.

1           **Section 2.** §8141(b) of Title 4 of the Guam Code Annotated is *amended* as  
2 follows:

3                           "(b) the Board of Trustees may employ an attorney  
4 to assist and represent it in all civil matters, including  
5 civil litigation matters, which concerns the Board. The  
6 Board of Trustees may set the terms and conditions of  
7 employment for the attorney and his compensation. "

8           **Section 3. Effective Date.** This Act shall be effective upon enactment.
