COMMITTEE REPORT

BILL NO. 34 (EC) AN ACT TO ADD A NEW §§17 TO THE “EXHIBIT B” ATTACHMENT TO §22958 OF ARTICLE 10, CHAPTER 22, DIVISION 2 OF TITLE 5, GUAM CODE ANNOTATED, PROVIDING TWO MILLION DOLLARS (\$2,000,000.00) FOR ROADWAY REPAIRS AND RESURFACING OF PALE SAN VITORES ROAD, AND FOR UPGRADES AND REPAIR TO THE TUMON AREA INFRASTRUCTURE.

INTRODUCTION AND REFERRAL

Bill No. 34(EC), "AN ACT TO ADD A NEW §§17 TO THE "EXHIBIT B" ATTACHMENT TO §22958 OF ARTICLE 10, CHAPTER 22, DIVISION 2 OF TITLE 5, GUAM CODE ANNOTATED, PROVIDING TWO MILLION DOLLARS (\$2,000,000.00) FOR ROADWAY REPAIRS AND RESURFACING OF PALE SAN VITORES ROAD, AND FOR UPGRADES AND REPAIR TO THE TUMON AREA INFRASTRUCTURE, was introduced by A.R. Unpingco, L.F. Kasperbauer Ph.D., and Mark Forbes on January 24, 2005. The bill was subsequently referred by the Committee on Calendar to the Committee on Tourism, Maritime, Military and Veterans Affairs on January 25, 2005 (see attachment).

PUBLIC HEARING

On February 15, 2005, a public hearing was conducted by the Committee on Tourism, Maritime, Military and Veterans Affairs on Bill No. 34(EC). Committee Chairman Antonio R. Unpingco called the public hearing to order at 9:00 a.m. in the Legislative Public Hearing Room. Committee members present were: Senators Bob Klitzkie, Frank B. Aguon, Jr., Eddie J.B. Calvo, Mike Cruz, Rory Respicio and Speaker Mark Forbes. Non-committee members present were: Vice Speaker Joanne M.S. Brown and Senator Adolpho B. Palacios.

Chairman Unpingco called the following individuals forward to provide public testimony on Bill No. 34(EC):

1. Gerald S.A. Perez, Administrator, Guam Economic Development and Commerce Authority (GEDCA), written/oral
2. David B. Tydingco, President, Guam Hotel & Restaurant Association (GHRA), written/oral
3. Carl Petersen, Board Member and Chairman, Destination Improvement and Maintenance Committee, Guam Visitors Bureau (GVB), written/oral
4. Joe Punzalan, Guam Waterworks Authority (GWA), oral
5. Marc Gagarin, Department of Public Works (DPW), oral

Testimony was also received from:

1. Joseph F. Camacho, Vice President, Finance U.S. Group, DFS Guam, written

SUMMARY OF TESTIMONY

Mr. Gerald S. A. Perez, Administrator, GEDCA, testified that the stated purpose of Bill No. 34(EC) complies with the bond's definition of an infrastructure project. He informed the committee that approximately \$4.9 million exists as unexpended and unobligated as a result of projects being completed below the budgeted amounts. Mr. Perez asked that the remaining balance *after* the amount contained in Bill No. 34(EC) is obligated be reserved

until DPW completes all payment requests related to the proposed project. In closing he stated that GEDCA fully supports the need to expend the funds.

Mr. David B. Tydingco, President, GHRA, thanked the Chairman and the Committee for its quick action to hear Bill No. 34(EC). He added that the specific uses of the fund have been identified by a working group composed of DPW, GWA, and GVB. He asked for an expeditious approval of the bill.

Mr. Carl Peterson, GVB Board member and Chairman, Destination Improvement and Maintenance Committee, expressed thanks to the bill's sponsors for their expedient action in introducing and hearing the bill. He explained that part of GVB's mission is to improve the destination as a product. Product improvement means physical maintenance, beautification and upgrading of Guam's economic zones and the island as a whole. He stated that if Bill No. 34(EC) were to see passage, GVB aims to start construction and repair in the northbound lane of Pale San Vitores Road from the intersection of the new Tumon Police Precinct to the end of the boulevard at the intersection of the Westin Guam Resort and Outback Steak House. He asked for the passage of the bill as quickly as possible to begin immediate rectification of the situation prompting its introduction.

Mr. Joseph F. Camacho, Vice President, Finance U.S. Group, DFS Guam testified in favor of the bill's passage to correct a serious safety hazard and eyesore in the heart of Guam's tourism district. He noted the uneven and extremely slippery conditions, slow traffic flow, and flooding during heavy rains.

DISCUSSION

Vice Speaker Brown asked Marc Gagarin why the deplorable roadway situation has taken place. He replied that he had little involvement with the project, but his best guess was the use of the paver blocks contributed to the problem since they are not suited to carrying the type of loads common in Tumon. He added that the plan is to use stamped concrete and asphalt in the affected areas.

Speaker Forbes followed up by asking if "anyone was culpable" for the shoddy road construction, and does the government have any recourse? Mr. Gagarin answered that the contracts with the Contractor and the A/E firms contain sections on performance of work. He went on to say that the acceptance of the project by the government does *not* relieve the Contractor or A/E firms of liability. Speaker Forbes urged the witnesses present to make every effort that this project, and all other projects for that matter, be coordinated with all concerned so that a multi-million dollar roadway would not be dug up because "someone forgot something".

Mr. Tydingco mentioned that GVB had asked its Legal Counsel to look into the culpability issue and hoped to have something to report to the GVB Board in a few weeks. Chairman Unpingco asked to be kept abreast of any developments.

Chairman Unpingco asked Mr. Punzalan if the roadway had to be dug up to "hook up" the customers. Mr. Punzalan replied that the waterlines were inland from the roadways, and in most cases were inland of the sidewalks, too.

Chairman Unpingco asked Mr. Perez when the bonds would be paid off. Mr. Perez did not know exactly when, and said he would provide that information to the Committee at a later date.

Chairman Unpingco asked Mr. Gagarin how long the project would take and would the work be performed at night. Mr. Gagarin said the project will take 6-8 months from issuance of the Notice to Proceed, and that the work would be performed in the daytime since there are liability issues when working at night that make work tenuous at best.

There being no other questions, the hearing on Bill No. 34(EC) was concluded.

COMMITTEE FINDINGS

The Committee on Tourism, Maritime, Military and Veterans Affairs find that there is an urgent need to provide the funds necessary to carry out the immediate repair and resurfacing of the roadway from the northbound lane of Pale San Vitores Road from the intersection of the new Tumon Police Precinct to the intersection of the Westin Guam Resort and Outback Steak House, and to provide for the identified infrastructure hook-ups in the affected area. The Committee also finds that there are sufficient unexpended and unobligated monies remaining from the Phase II project funding to cover the approximate \$2.0 million needed to complete Phase I.

The Committee also finds that there exists a serious need to better coordinate these capital improvement projects so as to avoid the need to spend additional public monies on unnecessary repairs, additions, or refurbishing. The \$2.0 million needed to complete Phase I could have been put to a better use IF all parties involved had taken the extra step to communicate and coordinate their individual needs and schedule of activities.

COMMITTEE RECOMMENDATIONS

The Committee on Tourism, Maritime, Military and Veterans Affairs recommends that Bill No. 34(EC) be reported out to the full body with a recommendation **TO DO PASS**.



Mickelson struggled with his driver in a 3-under 68, but no one mounted a serious challenge Sunday. He never led by fewer than three strokes over the final 18 holes.

Mickelson survived shots deep into the desert and into the water, then capped his round with a 26-foot birdie putt from the fringe on the 18th to the wild cheers of the friendly throng. With chants of "A-S-U!" and "Go Lefty!" from the crowd everywhere he went, Mickelson finished at 17-under 267 on the Tournament Players Club course.

Scott McCarron and Kevin Na, at 21 the youngest player on the PGA tour, tied for second at 12 under. McCarron shot his second consecutive 65, and Na had a 69.

just 25 when he won in a playoff with Justin Leonard in 1996.

After a 2-over 73 in the first round, Mickelson was 19 under in the last 54, including an 11-under 60 in the second round Friday, tying the course record with his lowest score in an official PGA Tour event.

He earned \$936,000 for his 24th tour title.





I would like to thank the Chairman, Senator Antonio Unpingco and members of the Committee on Tourism, Maritime, Military & Veteran's Affairs for the opportunity to provide testimony on Bill No. 34.

I would offer the following comments regarding Bill 34, which provides Two Million Dollars (\$2,000,000.00) for roadway repairs and resurfacing of Pale San Vitores Road, and for upgrades and repair to the Tumon area.

The Guam Economic Development and Commerce Authority (GEDCA) fully supports the need to expend funds in the bond construction accounts, as this is one of the initiatives recommended in the Governor's Economic Recovery Plan to facilitate immediate capital expenditures.

As per the Infrastructure Improvement Bond Indenture, amounts in the Construction Fund are to be applied for the purpose of implementing infrastructure improvement projects pursuant to the authorizing legislation. An infrastructure improvement project is defined by law to mean any infrastructure improvement project approved in connection with the prior obligations (Tumon Area Infrastructure construction projects) and any other project subsequently approved by statute for implementation with moneys derived from the prior obligations. I herein confirm that the stated use proposed in Bill 34, does comply with the bond's definition of an infrastructure improvement project.

Further, recent reconciliation of the Capital Projects Fund by the Department of Administration show that as of September 30, 2004, approximately \$4,875,646 exists as unexpended and unobligated as a result of projects being completed below the budgeted amounts. We recommend that the remaining balance after the provision in bill 34, be reserved until DPW completes all payment requests related to this project.

In closing, I would like to reiterate to the Legislature that the timely expenditures of all bond proceeds would be extremely beneficial in Guam's demonstration of financial responsibility and accountability in the eyes of the bond market.



I am a member of the Guam Visitors Bureau Board of Directors and chairman of GVB's Destination Improvement and Maintenance Committee. Thank you for the opportunity to allow GVB to testify in favor of Bill 34 (EC) that will provide two million dollars (\$2,000,000) for roadway repairs and resurfacing of Pale San Vitores Road and for upgrades and repair to the Tumon Area Infrastructure. We want to thank the bill sponsors, Senator Unpingco, Senator Larry Kasperbauer and Speaker Mark Forbes, for your expedient action in introducing and hearing this bill.

Our mission at GVB is to efficiently and effectively promote and develop Guam as a safe and satisfying destination for our visitors and also for our residents to benefit from our activities. One of the key roles we've been entrusted with to achieve our mission, is to improve our destination as a product. Product improvement means physical maintenance, beautification and upgrading of our tourist economic zones and island as a whole.

Thousands of visitors, island residents and employees cross or drive through this street everyday risking injury. Traffic flow is also affected since cars virtually come to a stop to cross the section in disrepair. Flooding during heavy rain still continues to plague the area.

The current condition of the street hurts Guam's image as a quality destination. As you are aware, Tourism, Guam's number one industry, continues to recover from the effects of SARS and the war in Iraq. In 2004, Guam saw a 31% increase in visitors over 2003. A 16% increase is targeted for 2005.

Funding is key to repairing the roads. Please approve Bill No. 34 to provide \$2 million for roadway repairs and resurfacing of Pale San Vitores Road and to upgrade and repair the Tumon area infrastructure.

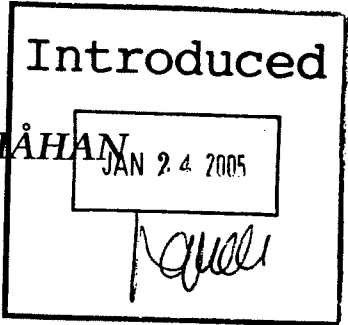
