



AN ACT TO *ADD* A NEW SUBSECTION 11 TO §3126 OF CHAPTER 3 OF TITLE 17, GUAM CODE ANNOTATED, RELATIVE TO MAKING LITERACY AN OBJECTIVE OF AN ADEQUATE PUBLIC EDUCATION.

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new Subsection 11 is *added* to §3126 of Chapter 3 of Title 17,
Guam Code Annotated, to read:

4 "(11) that curricula be consistent with the 'No Child Left Behind Act'
5 or successor legislation that would allow students to achieve Literacy goals
6 established by the Guam Education Policy Board."
