AN ACT TO AMEND §23111 OF CHAPTER 23, DIVISION 2, TITLE 5, GUAM CODE ANNOTATED. TO RELATIVE AUTHORIZING THE **USE** GOVERNMENT OF **GUAM** TRAVEL **MILEAGE** BENEFITS TO SUPPORT OFF-ISLAND MEDICAL REFERRALS AND OFF-ISLAND STUDENT TRAVEL INVOLVING ACADEMIC, SPORTS AND CULTURAL ACTIVITIES.

BE IT ENACTED BY THE PEOPLE OF GUAM:

1	Section 1. Medical Referral and Education Mileage Bank Account.
2	§23111 of Chapter 23, Division 2, Title 5, Guam Code Annotated, is hereby
3	amended to read:
4	"§ 23111. The Senator Edward J. Cruz Medical Referral and
5	Education Mileage Program.
6	(a) Title. This Section may be cited and referred to as the "Senator
7	Edward J. Cruz Medical Referral and Education Mileage Program."
8	(b) Medical Referral and Education Mileage Program. There is
9	hereby created within the government of Guam an accrued travel mileage
10	program for the use of travel mileage earned as a result of travel paid by the
11	government of Guam through the use of government of Guam credit cards.
12	This program shall be known as the Senator Edward J. Cruz Medical
13	Referral and Education Mileage Program (MREMP) to be administered by

- (4) *Travel benefit* means a program designed by an airline that awards accrued mileage and benefit programs to its clients.
- (d) Requirement. All accrued mileage earned through the use of credit cards for travel by employees of the legislative, judicial and executive branches, including, but *not* limited to, all government agencies, instrumentalities, autonomous and semi-autonomous agencies, public corporations, the University of Guam, the Guam Community College, the Guam Visitors Bureau, the Department of Education, all elected officials, individual consultants of the government of Guam, and members of boards and commissions, as well as non-government persons traveling at government of Guam or federal government expense, *shall* be available to support off-island medical care, and off-island student travel involving academic, sports and cultural activities.

The following agencies, instrumentalities, and autonomous agencies of the government of Guam *shall* use their respective accrued mileage account to support off-island medical referrals and off-island student travel based on the following distribution guideline:

- (1) Department of Administration fifty percent (50%) of the accrued mileage maintained by this entity *shall* be used to send eligible students to participate at off-island academic activities, including, but *not* limited to, Close-Up and the Junior Statesmen of America. The remaining fifty percent (50%) *shall* be used to support off-island medical referrals pursuant to Subsection (f).
  - (2) Department of Education, Guam Community College,

University of Guam – one hundred percent (100%) of the accrued mileage maintained by these entities *shall* be used to send eligible students to participate at off-island academic activities, including, but *not* limited to, Close-Up and the Junior Statesmen of America.

- (3) Guam Power Authority, Guam Waterworks Authority one hundred percent (100%) of the accrued mileage account maintained by these entities *shall* be used to send eligible students to participate at off-island sports competitions.
  - (4) Antonio B. Won Pat Guam International Airport

Authority, Guam Visitors Bureau, Jose D. Leon Guerrero Port Authority of Guam – one hundred percent (100%) of the accrued mileage maintained by this entity *shall* be used to send eligible students to participate at off-island cultural activities, including, but *not* limited to, arts and humanities competitions and international cultural festivals and exchanges.

(5) Guam Legislature, Unified Judiciary of Guam – one hundred percent (100%) of the accrued mileage maintained by these entities *shall* be used to send eligible students to participate at off-

island academic activities, including, but *not* limited to, Mock Trial and National Forensic League competitions.

- (6) All agencies, instrumentalities, autonomous agencies, and public corporations of the government of Guam not mentioned in items (1) through (4) of this Subsection shall use their accrued mileage to send eligible students to participate at off-island academic, sports and cultural activities, as authorized by the Superintendent of Education.
- (e) Eligibility.
- (1) The following persons are eligible for participation to receive the mileage for off-island medical care:
  - (A) patients under the Medically Indigent Program; patients under other DPHSS income-based health programs as approved by the Director of the Department of Public Health and Social Services; and patients with serious medical illness and financial need as determined by the Director of DPHSS pursuant to the Administrative Adjudication Law.
  - (B) all health care staff (physicians, nurses, technicians) providing direct care to the patient being transported, as approved by the Medical Director of the Guam Memorial Hospital Authority, or his/her designee.
  - (2) Patient eligibility *shall* be based upon:
  - (A) financial need as identified under the requirements of the Medically Indigent Program, or under the requirements of other DPHSS income-based health programs, or by any other needs based requirements for patients with any medical illness as prescribed by the Director of the Department of Public

- an attending physician.
- A student who is authorized by the Superintendent of Education to participate at an off-island academic, sports or cultural activity is also eligible for participation to receive the mileage benefits.
- (f) Authorized Use. Fifty percent (50%) of the accrued mileage account, administered by the Department of Administration, shall be used to send patients off-island, through a certified medical referral for patients, to a destination determined by the patient's duly licensed physician with the concurrence of the Medically Indigent Program Coordinator of the Department of Public Health and Social Services.
- Other Travel Benefits. All other travel benefits, including, but (g) not limited to, volume purchase discounts and accrued number of ticket purchases for free flight benefits and promotional travel benefits shall be accrued and used for the purpose of this Program. The Director of Administration shall establish procedures for management of these benefits and for distribution as requested by the Medically Indigent Program Coordinator of the Department of Public Health and Social Services, or his/her designee.
- Credit Card Agreement; Accrued Mileage Program. The Guam Legislature, the Unified Judiciary of Guam, and departments, agencies, instrumentalities, autonomous agencies, and public corporations of the

government of Guam *shall* exercise due diligence and seek to enter into an agreement with a bank(s) on Guam for a credit card(s) to use as payment for travel for employees traveling on government and/or federally funded travel, and to accrue travel mileage through a participating airline(s), which *shall* be used in accordance with the provisions of this Act. Each department, instrumentality, autonomous agency, and public corporation of the government of Guam *shall* maintain their respective accrued mileage program, which *shall* be used exclusively to support off-island medical referrals and off-island student travel involving academic, sports and cultural activities, pursuant to the distribution guidelines set forth in items (1) through (6) of Subsection (d). The Department of Administration *shall* be responsible for maintaining an accrued mileage account for all travel under its purview.

(i) Rules and Regulations. The Director of the Department of Public Health and Social Services in collaboration with the Director of the Department of Administration *shall* jointly promulgate rules and regulations, specifically for the use of accrued mileage for off-island medical referrals, within sixty (60) days from the date of enactment of this Section. The Superintendent of Education *shall* in collaboration with the heads of all agencies, departments, instrumentalities, autonomous agencies, and public corporations of the government of Guam, to include the Executive Director of the Guam Legislature and the Administrator of the Courts, *shall* promulgate rules and regulations, specifically for the use of accrued mileage for off-island student travel involving academic, sports and cultural activities. These rules and regulations *shall* be promulgated pursuant to Article 3, Chapter 9 of Title 5, Guam Code Annotated, the Administrative Adjudication Act, Rule Making Procedures.

1 (j) Transfer fee or other related fees and taxes. In the event a 2 transfer fee or other related fees and taxes is required to secure off-island 3 travel, as authorized herein, such fee(s) *shall* be borne by the traveler."

Section 2. Transition and Implementation. The Director of the Department of Administration, the Director of the Department of Public Health and Social Services, and the *Ayuda* Foundation *shall* exercise due diligence to avoid disruption in the processing of travel for medically indigent patients during the period prior to the effective date of this Act. Unused travel mileage earned from credit card purchases, prior to the implementation of this Act, *shall* be reserved for off-island medical referrals and off-island student travel, subject to the rules and regulations promulgated in accordance with §23111(i) of Section 1 of this Act.

Section 3. Effective Date. This Act shall be effective no later than 90 days following enactment.

Each department, instrumentality, autonomous agency, and public corporation of the government of Guam *shall* maintain their respective accrued mileage program, which *shall* be used exclusively to support off-island medical referrals and off-island student travel involving academic, sports and cultural activities, pursuant to the distribution guidelines set forth in items (1) through (6) of Subsection (d). The Department of Administration *shall* be responsible for maintaining an accrued mileage account for all travel under its purview.

(i) Rules and Regulations. The Director of the Department of Public Health and Social Services in collaboration with the Director of the Department of Administration *shall* jointly promulgate rules and regulations, specifically for the use of accrued mileage for off-island medical referrals, within sixty (60) days from the date of enactment of this Section. The Superintendent of Education *shall* in collaboration with the heads of all agencies, departments, instrumentalities, autonomous agencies, and public corporations of the government of Guam, to include the Executive Director of the Guam Legislature and the Administrator of the Courts, *shall* promulgate rules and regulations, specifically for the use of accrued mileage for off-island student travel involving academic, sports and cultural activities. These rules and regulations *shall* be promulgated pursuant to Article 3, Chapter 9 of Title 5, Guam Code Annotated, the Administrative Adjudication Act, Rule Making Procedures.

1 (j) Transfer fee or other related fees and taxes. In the event a 2 transfer fee or other related fees and taxes is required to secure off-island 3 travel, as authorized herein, such fee(s) *shall* be borne by the traveler."

Section 2. Transition and Implementation. The Director of the Department of Administration, the Director of the Department of Public Health and Social Services, and the *Ayuda* Foundation *shall* exercise due diligence to avoid disruption in the processing of travel for medically indigent patients during the period prior to the effective date of this Act. Unused travel mileage earned from credit card purchases, prior to the implementation of this Act, *shall* be reserved for off-island medical referrals and off-island student travel, subject to the rules and regulations promulgated in accordance with §23111(i) of Section 1 of this Act.

**Section 3. Effective Date.** This Act *shall* be effective no later than 90 days following enactment.

Vice Speaker Benjamin J.F Cruz announced Bill No. 44-32 (COR) and deferred to Speaker Judith T. Won Pat, Ed.D. as the main sponsor.

**Speaker Won Pat** stated that if enacted Bill No. 44-32 (COR) would authorize the use of mileage earned through credit card purchases authorized by the government of Guam to support student travel involving academic, sports and cultural activities. Speaker Won Pat stated that ten million miles of mileage earned through governmental travel has been accrued through the government of Guam's use of credit cards in the purchase of airline tickets. Speaker Won Pat stated that the miles are separate from those required by P.L. 31-117 for medically indigent patients. Speaker Won Pat stated that the unused ten million miles would assist families on Guam that send their children to various academic, sports and cultural activities.

**Senator Cruz** noted that no one was available to testify, but that Senator Carlotta Leo Guerrero had intended to provide oral testimony in support of the legislation, but had to leave due to the lengthy discussion on Bill No. 45-32 (COR). Senator Cruz thanked his colleagues and members of the panel for their comments then asserted that the record will be open for ten days so that residents may submit their testimonies.

#### III. Summary of Written Testimonies Submitted

- Jon Fernandez, Superintendent of Education
   Superintendent Fernandez supports the legislation as participation in off-island events affords
   our island's public school students the opportunity to interact with other student organizations
   on higher levels both nationally and internationally. Superintendent Fernandez stated that
   whether it is for an academic, sports or cultural event, off-island travel definitely strengthens
   the academic, physical and social development of our students. (Superintendent Fernandez's
   written testimony is attached.)
- 2. Former Senator Carlotta Leon Guerrero, Executive Director, Ayuda Foundation Senator Leon Guerrero supports all efforts to capture as many travel benefits as possible through government purchasing and feels that significant miles can be created for the benefit of other populations with travel needs. Senator Leon Guerrero, however, suggested that I Liheslatura remove language in current law (P.L. 31-117) which mandates that miles generated by government of Guam employee travel be turned over to the Ayuda Foundation to support off-island medical referrals. (Senator Leon Guerrero's written testimony is attached.)

#### **IV. FINDINGS AND RECOMMENDATION**

The Committee on General Government Operations and Cultural Affairs finds that the implementation of the P.L. 31-117, also known as the *Senator Edward J. Cruz Medical Referral Mileage Bank Account Act*, was enacted with the intent to capture airline miles earned through government employee travel and to dedicate these miles to support off-island medical referrals through their donation of miles to the Ayuda Foundation.

The Ayuda Foundation is a non-profit organization that helps to improve the delivery of healthcare services in Guam and throughout Micronesia. Through United Airlines, mileage account members are able to donate a portion of their miles, without having to pay transfer fees, to support off-island medical travel including those authorized through P.L. 31-117. Government of Guam employees that travel off-island through United Airlines are required to deposit their miles earned on travel to the Ayuda Foundation, in accordance with P.L. 31-117.

The Committee finds, however, that the donation of airline miles to the Ayuda Foundation can only be done if the government employee travels with United Airlines, as the airline is the only carrier that has an established relationship with the Ayuda Foundation. The Committee finds that airline miles earned by government employees that travel with other airlines remain with those employees.

In the interest of fairness, the Committee has substituted Bill No. 44-31 (COR) to include additional amendments to §23111 of Chapter 23, Division 2, Title 5, Guam Code Annotated. The Committee removed language which mandates employees to deposit airline miles earned on government-funded travel.

Substituted Bill No. 44-32 (COR) further amends §23111 of Chapter 23, Division 2, Title 5, Guam Code Annotated, and establishes the Senator Edward J. Cruz Off-Island Medical Referral and Education Mileage Program. In summary, the additional amendments contained in Bill No. 44-32 (COR), as Substituted by the Committee, propose the following:

1. That the Guam Legislature, Unified Judiciary of Guam, and all other departments, agencies, instrumentalities, autonomous and semi-autonomous agencies, and public corporations of the government of Guam seek to enter into credit card agreements with a bank, or banks, on Guam, which shall be used to pay for airline tickets for employee travel. Such credit card agreements shall include the earning of travel mileage with participating airlines.

That the Guam legislature, Unified Judiciary of Guam, and all other departments, agencies, instrumentalities, autonomous and semi-autonomous agencies, and public corporations of the government of Guam make available their respective accrued travel mileage to be used specifically to support off-island medical and off-island student travel involving academic, sports, and cultural activities, based on a distribution guideline established in Section 2 of Bill No. 44-32 (COR), as Substituted by the Committee.
- 3. That the Department of Public Health and Social Services, in collaboration with the Department of Administration, develop rules and regulations, pursuant to the Administrative Adjudication Law, specifically governing the use of accrued travel mileage for off-island medical referrals.
- 4. That the Department of Education, in collaboration with all departments, agencies, instrumentalities, autonomous agencies, and public corporations of the government of Guam, to include the Executive Director of the Guam Legislature and the Administrator of the Courts, develop rules and regulations, pursuant to the Administrative Adjudication Law, specifically governing the use of accrued travel mileage for off-island student travel involving academic, sports, and cultural activities.
- 5. That, in the event a transfer fee is required to secure off-island travel, as authorized through Bill No. 44-32 (COR), as Substituted by the Committee, such fee shall be borne by the traveler.
- 6. That the Department of Administration, the Department of Public Health and Social Services, and the Ayuda Foundation, shall exercise due diligence to avoid disruption in the processing of travel for medically indigent patients during the period prior to the effective date of Bill No. 44-32 (COR), as Substituted by the Committee.
- 7. That unused mileage earned from credit card purchases, prior to the implementation of Bill No. 44-32 (COR), As Substituted by the Committee, shall be reserved for off-island medical referrals and off-island student travel, subject to the rules and regulations promulgated in accordance with the legislation.

I Liheslatura further finds, however, that approximately Ten Million (10,000,000) miles, which were accrued through government of Guam credit card purchases, remain unused. These miles are separate and apart from those miles required by P.L. 31-117 to be available for travel by medically indigent patients.

It is, therefore, the intent of *I Liheslaturan Guåhan* to authorize the use of mileage earned through government of Guam credit card purchases to support student travel involving academic, sports and cultural activities. *I Liheslatura* intends to help provide students in Guam's public schools the means to participate in various academic, sports and cultural activities off island, which will contribute to strengthening their academic, physical and social development.

Cruz Medical Referral and Education Mileage Bank Account Program (MREMBAP) to be administered by the Department of Administration for all travel conducted by employees of government agencies, instrumentalities, autonomous agencies, public corporations and the Executive Bbranches of the government of Guam to deposit all accrued travel mileage by virtue of receiving travel authorization payments into the MRMBA. The Guam Legislature, Unified Judiciary of Guam, and other agencies, instrumentalities, autonomous agencies, and public corporations of the government of Guam that purchase airline tickets through the use of credit cards, shall administer their respective accrued travel mileage program pursuant to the requirements of this Section.
- (c) Definitions. For the purposes of this Section the following words and phrases are defined to mean:

Account means the Senator Edward J. Cruz Medical Referral and Education Mileage Bank Account Program established under this Section.

Accrued mileage means those miles accrued by the government of Guam, specifically the Department of Administration, the Guam Legislature, Unified Judiciary of Guam and other agencies, instrumentalities, autonomous agencies, and public corporations of the government of Guam that use credit cards to purchase airline tickets an employee and/or consultant traveling on government or federal paid travel in the government account or in the employee's frequent flyer travel benefit program.

# Department means the Department of Administration.

*Employee* means all persons employed within the government of Guam, whether classified or unclassified, or full-time, part-time, temporary or limited-term basis; all elected officials, judges, mayors, individual consultants, and members of boards and commissions.

# Student means a person enrolled in a Guam Department of Education school.

Travel benefit means a program designed by an airline that awards accrued mileage and benefit programs to its clients.

(d) Requirement. All <u>accrued mileage earned through the use</u> of credit cards for travel by employees of the legislative, judicial and executive branches, including, but not limited to, all government

instrumentalities, autonomous and semi-autonomous agencies, public corporations, the University of Guam, the Guam Community College, the Guam Visitors Bureau, the Department of Education, all elected officials, individual consultants of the government of Guam, and members of boards and commissions, as well as non-government persons traveling at government of Guam or federal government expense, shall be available to support off-island medical care, and off-island student travel involving academic, sports and cultural activities. ,as a condition of receiving local or federal monies under a travel authorization (TA) contractual allotment for travel, or any government of Guam monies, used directly or indirectly for expenses incurred for official government travel, shall donate all mileage accrued to the Ayuda Foundation, if the mileage accrued has not already been credited to a government of Guam mileage bank account. The employee shall sign a waiver form donating accrued mileage from any travel benefit on whatever airline into the MRMBA, or directly to the Ayuda Foundation as identified in <del>§ 23117.</del>

The following agencies, instrumentalities, and autonomous agencies of the government of Guam shall use their respective accrued mileage account to support off-island medical referrals and off-island student travel based on the following distribution guideline:

(1) Department of Administration - Fifty Percent (50%) of the accrued mileage maintained by this entity shall be used to send eligible students to participate at off-island academic activities including, but not limited to, Close-Up and the Junior Statesmen of America, etc. The remaining Fifty Percent (50%) shall be used to support off-island medical referrals pursuant to §23111(f).

- (2) Department of Education, Guam Community College,

  University of Guam One Hundred Percent (100%) of the accrued
  mileage maintained by these entities shall be used to send eligible
  students to participate at off-island academic activities including, but
  not limited to, Close-Up and the Junior Statesmen of America, etc.
- (3) Guam Power Authority, Guam Waterworks Authority One Hundred Percent (100%) of the accrued mileage account maintained by these entities shall be used to send eligible students to participate at off-island sports competitions.
- (4) Antonio B. Won Pat Guam International Airport

  Authority, Guam Visitors Bureau, Jose D. Leon Guerrero Port

  Authority of Guam One Hundred Percent (100%) of the accrued

  mileage maintained by this entity shall be used to send eligible

  students to participate at off-island cultural activities including, but

  not limited to, arts and humanities competitions, international

  cultural festivals and exchanges, etc.

- (5) Guam Legislature, Unified Judiciary of Guam One Hundred Percent (100%) of the accrued mileage maintained by these entities shall be used to send eligible students to participate at offisland academic activities including, but not limited to, Mock Trial and National Forensic League competitions, etc.
- (6) All agencies, instrumentalities, autonomous agencies, and public corporations of the government of Guam not mentioned in §23111(d), items (1) through (4), shall use their accrued mileage to send eligible students to participate at off-island academic, sports and cultural activities, as authorized by the Superintendent of Education.
  - (e) Eligibility.

- (1) The following persons are eligible for participation to receive the mileage for off-island medical care:
- (A) patients under the Medically Indigent Program and patients under other DPHSS income-based health programs as approved by the Director of the Department of Public Health & Social Services; and
- (B) all health care staff (physicians, nurses, technicians) providing direct care to the patient being transported, as approved by the Medical Director of the Guam Memorial Hospital Authority or his/her designee.
- (2) Patient eligibility shall be based upon:

(A) financial need as identified under the requirements of the Medically Indigent Program or under the requirements of other DPHSS income-based health programs;

- (B) lack of availability of required medical services on Guam; and
- (C) urgency and severity of illness, as documented by an attending physician.
- (D) student is enrolled in the Guam Department of Education and is authorized by the Superintendent of Education to participate at an off-island academic, sports or cultural activity.
- (f) Authorized Use. <u>Fifty percent (50%) of Tthe accrued mileage</u> account, <u>administered by the Department of Administration</u>, shall be used to send patients off-island, through a certified medical referral for patients, to a destination determined by the patient's duly licensed physician with the concurrence of the Medically Indigent Program Coordinator of the Department of Public Health & Social Services.
- (g) Other Travel Benefits. All other travel benefits, including, but not limited to, volume purchase discounts and accrued number of ticket purchases for free flight benefits and promotional travel benefits shall be accrued and used for the purpose of this Program. The Director of Administration shall establish procedures for

management of these benefits and for distribution as requested by the Medically Indigent Program Coordinator of the Department of Public Health & Social Services, or his/her designee.

# (h) Deposit of Mileage.

(1) The Department is hereby authorized to become a member of the travel benefits program as it relates to travel mileage instituted by any and all airlines serving Guam, and shall enter into an agreement with an airline to accrue travel mileage credits for employees traveling on government and/or federally funded travel.

(2h) Credit Card Agreement; Accrued Mileage Program. The Guam Legislature, Unified Judiciary of Guam, and Ddepartments, agencies, instrumentalities, autonomous agencies, and public corporations of the government of Guam shall exercise due diligence and seek to enter into an agreement with a bank(s) on Guam for a credit card(s) to use as payment for travel for employees traveling on government and/or federally funded travel, and to accrue travel mileage through a participating airline(s), which shall be used in accordance with the provisions of this Act. Each department, instrumentality, autonomous agency, and public corporation of the government of Guam, shall maintain their respective accrued mileage program which shall be used exclusively to support off-island

medical referrals and off-island student travel involving academic, sports and cultural activities, pursuant to the distribution guidelines set forth in §23111(d), items (1) through (6). The Department of Administration shall be responsible for maintaining an accrued mileage account for all travel under its purview.

(3) Employees not using the Department's credit card shall be personally liable to deposit any travel miles accrued directly to the *Ayuda* Foundation via whatever airline website, which has agreed to accept mileage credits on behalf of the *Ayuda* Foundation. The employee shall be required to submit the confirmation copy of the accrued mileage deposit(s) made, and shall be included in the required travel report submitted to the Certifying Officer or equivalent of their respective department within ten (10) days upon their return from off-island funded travel.

(i) Reporting. The employee traveling on government and/or federally funded travel who does not use the credit card with the Department shall submit a copy of the form evidencing the deposit of mileage into the *Ayuda* Foundation to the Certifying Officer or equivalent of the department or agency, who shall maintain a reporting of all accrued mileage by employees traveling on government and/or federally funded travel. The Certifying Officer or

equivalent of the department or agency shall submit a monthly report to the Travel Section of the Department of Administration of all accrued mileage. The Travel Section shall reconcile the report with the *Ayuda* Foundation on a monthly basis to ensure that the accrued mileage deposited by the department or agency is correct, and shall submit a quarterly report to *I Liheslaturan Guåhan* to include, but not be limited to, total miles accrued and donated per agency, total miles used for medical purposes, and any balances that remain. An audit shall be conducted of the MRMBA on an annual basis by the Office of Public Accountability, and submitted to *I Liheslaturan Guåhan* no later than September 30.

(j) Penalties. Any violation of this Section shall result in the following:

(1) An employee who fails to submit the confirmation copy of transfer of mileage to *Ayuda* evidencing the transfer of mileage pursuant to Subsection (h) of this Section, shall pay the amount equal to the cost the airline mileage program charges for the purchase of miles times the mileage accrued on the completed travel. If the employee fails to submit the confirmation copy, the total amount shall be deducted from the employee's salary for four (4) pay periods or until the total amount is paid in full.

(k) Indemnification. The government of Guam shall indemnify and hold harmless the participating airline(s) thereof for any loss subject to an agreement, and provided that such loss is not a result of the negligence of the airline(s). *I Maga'lahen Guåhan* is hereby authorized to enter into such an indemnification agreement pursuant to this Section.

(li) Rules and Regulations. The Director of the Department of Public Health and Social Services in collaboration with the Director of the Department of Administration shall jointly promulgate rules and regulations, specifically for the use of accrued mileage for off-island medical referrals, within sixty (60) days from the date of enactment of this Section. The Superintendent of Education shall in collaboration with the heads of all agencies, departments, instrumentalities, autonomous agencies, and public corporations of the government of Guam, to include the Executive Director of the Guam Legislature and the Administrator of the Courts, shall promulgate rules and regulations, specifically for the use of accrued mileage for off-island student travel involving academic, sports and cultural activities. These rules and regulations shall be promulgated pursuant to Article 3, Chapter 9 of Title 5, Guam Code Annotated, the Administrative Adjudication Act, Rule Making Procedures.

(m) Travel Authorization Signatory Exemption. For the purposes of this Section, any accrued mileage used out of the MRMBA for the Wings for Life Program will not be subject to the signatory parties as required with standard government travel authorization requests. Authorized signatories to approve the transfer of accrued mileage to ensure expedited travel shall be the Director of the Department of Public Health and Social Services and the Director of the Department of Administration only.

- (nj) Transfer fee. In the event a transfer fee is required to secure off-island travel, as authorized herein, such fee shall be borne by the traveler.
- 12 (nk) Effective Date. This Section shall become effective on
  13 October 1, 2011no later than ninety (90) days following enactment."

Section 2. Transition and Implementation. The Director of the Department of Administration, the Director of the Department of Public Health and Social Services and the *Ayuda* Foundation shall exercise due diligence to avoid disruption in the processing of travel for medically indigent patients during the period prior to the effective date of this Act. Unused mileage earned from credit card purchases, prior to the implementation of this Act, shall be reserved for off-island medical referrals and off—island student travel, subject to the rules and regulations promulgated in accordance with §23111(i).

Hafa Adai Mr. Chairman,

Thank you for giving me an opportunity to brief you on the Ayuda Foundation's Wings for Life program and how the government wide transfer of travel miles is affecting the program.

For background information, the Department of Public Health and the Department of Administration are our working partners in the program that uses United Airlines travel miles to move medically indigent patients off island for health-care that is not available on Guam. The travel miles come into the Ayuda Foundation from 2 sources:

- anonymous donations of miles on the United Airlines website for those who wish to donate to a charitable cause (estimate daily hits on website is 6-7 million)
- the miles donated when a Government of Guam employee travels

Of concern to us was the United Airlines view that they are being adversely affected by this program because Gov Guam workers are using other airlines in order to avoid turning their miles over.

United Airlines is the only airline that has put together a travel miles donation program that allows donations of miles that are less than a leg of a journey. It is possible through the United website to donate just 50 miles to Ayuda. We use the donated miles to benefit the poorest members of our community.

As a lawmaker you know that with the implementation of law, over time a track record is created of what's working and what's not and how to fix what's not working. We are at that point now. United believes that the mandatory turn over of miles is causing Gov Guam travelers to make other choices so they can keep the miles for their own family's travel/emergency needs.

We have been advised that if this situation continues it is possible that United Airlines HQ might decide to eliminate the travel miles donation program (that Continental created and United now controls) in order to return themselves to a level playing field with the other airlines serving Guam instead of losing travelers because of it.

Miles are generated in 2 ways, one is when a traveler gets on a plane, and the other way is when purchases are made on a credit card that generates travel miles. We support all efforts to capture as many travel benefits as possible through government purchasing and feel that significant miles can be created for the benefit of other populations with travel needs.

In the 7 years that this voluntary program has been in existence, Continental-United Airlines has provided an airline ticket to over 500 patients, plus a caregiver in many cases, so over 1,000 people have been flown off island, free, for needed medical care. We believe this program brings tremendous relief to the General Fund.

Thank you for this chance to fight for a program that helps the poorest members of our community at a time when they are afraid, vulnerable and most in need of a helping hand.

Executive Director Ayuda Foundation Comments on Legislative Bill No. 44-32 (COR)

The bill is seeking to transfer approximately 10 Million in air travel mileage which is separate and apart from those air travel miles identified by P.L. 31-117. Such air miles will be used to fund student travel involving academics, sports and cultural activities as approved by the Superintendent of Education. Because such air travel mileage is earned by the Government of Guam, specific airlines serving Guam may charge a transfer fee for transferring from Government of Guam to each student, resulting in significant fiscal impact to the annual appropriations of the Guam Department of Education. As an example, Delta Airlines charge a fee of \$0.01 per mile plus \$30.00 transaction fees. Using this as example, the potential fiscal impact could be as low as \$70,000, based on the following assumptions:

- Transfer fees used by Delta Airlines are \$0.01 per mile plus a \$30 transaction fees.
- In a given fiscal year, approximately 500 students will travel to the United States, all using the travel mileage available for GDOE that Delta has agreed to accommodate.
- Approximately 5,500,000 travel air miles will be consumed by these 500 students.
- Each student is a separate transaction fee.

For United Continental, the potential fiscal impact can be as high as \$82,500, which is based on a transfer cost \$15 per increments of 1,000 air miles for a total Mileage Plus transfer of 5,500,000.

Both airlines do have a limitation of 4 transfer events per account which means that the Department of Administration will need to negotiate with the airlines to allow unlimited transfers under the Government of Guam account.

Thank you for the opportunity to provide comment on Bill 44-32.

AN ACT TO AMEND \$23111(g)(2) OF CHAPTER 23, DIVISION 2, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO AUTHORIZING THE USE OF MILEAGE EARNED THROUGH CREDIT CARD PURCHASES AUTHORIZED BY THE GOVERNMENT OF GUAM, TO SUPPORT STUDENT TRAVEL INVOLVING ACADEMIC, SPORTS AND CULTURAL ACTIVITIES.

I understand the intent of Bill 44-32 and agree that the airfare transportation for qualified Guam representatives involved with educational, sporting and cultural activities must be supported. However, DOA has concerns and we are including the following comments.

It appears §23111(g) is a typographical error. The section pertaining to the "Deposit of Mileage" is §23111 (h), Chapter 23, Title 5 GCA.

Section 2. "Mileage Accrued Through Use of Credit Card Purchases." of Bill No. 44-32 reads as follows:

"(2) The Department shall enter into an agreement with a bank on Guam for a credit card to use as payment for travel for employees traveling on government and/or federally funded travel, and to accrue mileage, which shall be used exclusively for student travel involving academic, sports and cultural activities, as authorized by the Superintendent of Education. Authorized activities include, but shall not be limited to off-island events outlined in P.L. 31-132, including arts and humanities competitions, international cultural festivities and exchanges, the Junior Statesman Foundation, the National Science Fair, the Mock Trial, and the Forensic League, and the Close Up."

While the intent of Bill 44-32 is honorable, the inclusion of the above Subsection (2) into §23111 will only create further confusion and unnecessary delays in processing any travel requests for both MIP and

Student beneficiaries. There are several important points that must be considered prior to approval of Bill 44-32:

1) The government currently transfers accrued mileage to the *Ayuda Foundation's* "Wings for Life Program" without penalties and fees for transfer of mileage. This agreement was established with Continental Airlines who agreed to waving fees for these transfers because Continental was one of the corporate sponsors of the *Ayuda Foundation*.

United Airlines has taken over Continental Airlines and may not support the transfer of miles without fees associated with the transfer to any organization not listed on the United Airlines Mileage Donation section of the United Airlines website. Based on United Airlines' current rules

- i. The cost under the United Airlines Mileage is \$15.00 per 1,000 miles;
- ii. Minimum transfer is 2,000 miles per account
- iii. Maximum limit for each recipient is 15,000 per calendar year;

The current mileage program is problematic and has many unresolved issues. We highly encourage the legislature to correct the existing mileage program before making any additional provisions to the chapter.

Furthermore, it is my recommendation that rather than amend §23111 (g), Chapter 23, Title 5 GCA, a new subsection, perhaps §23113, be added specifically for the Guam Department of Education (GDOE) that is reflective of *The Senator Edward J.Cruz Medical Referral Mileage Bank Account Act*.

#### Rules for the MileagePlus Program

Important: The following provisions form the basis of the MileagePlus® Program. These provisions are intended to protect you, the members of the MileagePlus Program (the "Program"), and United Airlines and its affiliates (collectively, "United"). Your participation in the Program will be governed by these provisions, and it is your responsibility to read and understand all of them. For more information, contact the MileagePlus Service Center or visit the MileagePlus website at MileagePlus. On These Program Rules cannot be superseded or changed, except in writing from United Airlines. Any reference herein to United shall be deemed to also refer to MileagePlus Holdings, LLC.

#### General conditions

- MileagePlus membership and benefits, including the Premier Program, are offered at the discretion
  of United Airlines and its affiliates, and United has the right to terminate the Program and/or the
  Premier Program or to change the Program Rules, regulations, benefits, conditions of participation
  or mileage levels, in whole or in part, at any time, with or without notice, even though changes may
  affect the value of the mileage or certificates already accumulated.
  - 1a. United may, among other things, withdraw, limit, modify or cancel any award; increase the mileage, cash required, applicable co-pays or number of certificates required for any award; modify or regulate the transferability of awards or benefits; add an unlimited number of blackout dates; or limit the number of award seats available to any or all destinations. Members, in accumulating mileage or certificates, may not rely upon the continued availability of an award or award level, and members may not be able to obtain all offered awards or use awards to all destinations or on all flights.
- 2. Participation in the MileagePlus Program (the "Program") is subject to any terms and conditions, rules, regulations, policies and procedures ("Program Rules") that United may, at its discretion, adopt from time to time. United has the sole right to interpret and apply the Program Rules. Any fallure to follow Program Rules, United's contract of carriage, United's fare rules, any abuse of Program privileges, any violation of law, rule or regulation, any conduct detrimental to the interests of United, any fraudulent activity or attempted fraudulent activity, or any misrepresentation of any information furnished to United or its affiliates by any member, or anyone else acting on the member's behalf, may result in the termination by United of such member's membership, the loss or cancellation of accrued mileage, certificates, awards or benefits, or both, or the loss of other Program benefits. Terminated members shall not be eligible to participate in any aspect of the Program, and members whose accounts have been terminated shall not be eligible to enroll with new accounts.
- 3. United reserves the right to audit any and all MileagePlus accounts at any time to ensure compliance with the Program Rules, without notice to the Program member. During the course of an audit or investigation a member's account information may be shared with any third party with whom United has contracted to assist in performing such audit or investigation. In the event that an audit reveals discrepancies or possible violations, United may delay the processing of award redemption requests, cancel any outstanding award redemptions, withhold statements or suspend the MileagePlus account of a member pending completion of the audit. While the account is suspended, the member may continue to accrue miles in the account, but no mileage redemptions or other transactions will be permitted and any outstanding award redemptions will be cancelled. Cancelled award redemptions must be surrendered to United upon United's request. Upon completion of the audit, if a discrepancy or violation has been determined by United, in addition to any other remedies described herein, mileage may be removed from the account of the member to remedy such discrepancy or violation with or without notice to the member.
- 4. Each member shall be responsible for remaining knowledgeable as to the Program Rules and the amount of mileage in such member's account. United shall attempt to advise active members of

various matters of interest through such means as may be appropriate, such as account summaries, emails, newsletters and its website, but United shall have no liability for any failure to do so. United will not be responsible for correspondence lost or delayed in the mail. Each member shall be responsible for advising United of any change of address, and United shall have no liability for misdirected mail or any consequences thereof. The most current Program Rules may be found on mileageplus.com and this is the final authority on the Program Rules.

- 5. The accumulation of mileage or certificates and the redemption of awards are subject to specific Program Rules enacted by United. Each member is responsible for reading those materials in order to understand such member's rights and responsibilities under the Program. No mileage, benefits, certificates or awards earned or granted under the Program may be transferred or assigned except as expressly permitted by United in writing or under programs fully authorized and/or sponsored by United.
- 6. The MileagePlus Program is maintained for the benefit and participation of individual or small business members only. Only individuals and small businesses are eligible for MileagePlus membership, and each individual or small business member may maintain only one account in the Program. Duplicate accounts in the Program will be subject to cancellation and only the applicable credited mileage, excluding any enrollment or other bonus, will be transferred to any remaining account. Only one member may be enrolled per Program account. Program membership account numbers are nontransferable. Only the member named on the account will be entitled access to account information. Account information is United's proprietary information and members may access information only for the purpose of obtaining information about their account. No member may delegate or grant access (via power of attorney, contract, or otherwise) to a third party. Account information may be reproduced for use by the applicable member but must contain copyright and proprietary notices and redistribution in any way requires United's written permission.
- Accrued mileage and certificates do not constitute property of the member. Neither accrued mileage nor certificates are transferable (I) upon death, (II) as part of a domestic relations matter, or (iv) otherwise by operation of law.

#### Prohibition of sale or barter

8. The sale or barter or attempted sale or barter of any such mileage, certificates, awards or benefits other than as authorized and/or sponsored by United is expressly prohibited. Any mileage, certificates, awards or benefits transferred, assigned or sold in violation of the Program Rules, in addition to exposing the member to the penalties otherwise associated with violations, may be confiscated or canceled. The use of award tickets that have been acquired by purchase, barter or other conduct in violation of Program Rules may result in termination of membership, cancellation of accrued mileage, certificates, awards or benefits, confiscation of the tickets, denial of boarding with respect to the ticket holder, and, at United's discretion, completion of the travel only upon payment of an applicable fare.

#### Account activity

- Any member who has failed to earn mileage for a calendar month may, at United's option, be excluded from receiving newsletters, statements, correspondence or other materials, including notifications of Program changes or special promotions, until the next quarter in which such member earns mileage.
- 10. Any member who fails at any time to engage in account activity for a period of eighteen (18) consecutive months is subject to termination of such member's membership and/or forfeiture of all accrued mileage as of the last day of the 18th month. Activity includes (without limitation) earning flight miles on United or earning or redeeming miles with a MileagePlus partner (as defined in Rule 12), redeeming miles for award travel, buying miles or transferring miles.
- 11. "Account Activity", for purposes of these rules, shall be deemed to occur when a member accrues mileage in such member's account in any manner as outlined and set forth in these Rules, or as otherwise approved by United, or when the member redeems any MileagePlus or partner award by the use of mileage in the member's account. In cases where mileage is for any reason removed from an account, as for example the redemption of an award, and there is a subsequent cancellation of the award or removal of miles and a return of the miles to the member's account, the cancellation of the award or removal and return of the mileage to the account shall not qualify as "Account Activity."

#### United Airlines - MileagePlus Program Rules

#### **Partners**

- 12. The MileagePlus Program "partners" include airlines, rental car companies, hotels or other entities who offer products or services as awards in the Program and who permit the accrual of mileage to members who utilize their products or services. The partners are independent entities, and United is not responsible for the nature or quality of products or services provided by those partners, nor for any solicitation efforts by those partners. Mileage accrual offered to Program members for utilizing a partner's product or service can vary based upon the type of membership and details on specific partner offers are as published.
- 13. United shall have no liability for partner withdrawals from the Program or for award changes or cancellations caused by partner withdrawals, discontinued United or partner service, or award or mileage accrual cancellations for any other reason. United may change the amount of mileage required for partner offers or awards or impose other restrictions upon the use of partner offers or awards, with or without notice.
- Routing and destinations for award travel on airline partners are determined by our individual travel
  partners.
- 15. By participating in the MileagePlus Program, members understand and acknowledge that their names, addresses and other account information may be shared with some or all MileagePlus partners and that they may receive promotional materials, mailings and emails from United and its partners. A member may, however, opt-out of receiving any such materials by advising United (via the MileagePlus Service Center in writing or by accessing such member's account profile information at mileageplus.com and changing the profile to indicate their desire to be excluded from any such partner mailings or communications.

#### Mileage accrual

- 16. Miles will be accrued in such member's MileagePlus account only when the member avails themselves of the means of accrual recognized under the Program. Members may not accrue mileage for the utilization of services by anyone other than themselves, whether air transportation or otherwise, except to the extent that mileage may be earned for purchases made through authorized debit or credit cards or as expressly allowed under the applicable MileagePlus partner's offer.
  - 16a. United, in its sole discretion, may permit MileagePlus individual members to credit mileage earned for flights on other airlines to their Individual MileagePlus accounts, and other airlines or entities may, by agreement with United, permit their program members to credit to their accounts mileage earned for flights on United. In such cases, unless otherwise expressly provided, such mileage may be credited in only one frequent flyer or loyalty program.
- 17. Members must supply a PIN and/or password when conducting certain transactions in writing, by phone or on the Internet for security or other purposes. A PIN and/or password may be required to make reservations, redeem miles, change address and other services. Members are responsible for maintaining the confidentiality of their PIN and password, as applicable. United is not responsible for stolen PINs or passwords and will not re-credit miles for redemptions using the member's PIN or password.
- Mileage can be accrued only after the member's official enrollment date, and can be applied only to the member's account,
  - 18a. In the case of air travel, mileage will be credited only for flights actually flown by the member. Such mileage will be credited in accordance with the terms and conditions of the Program in effect at the time of travel, not at the time that air travel is purchased, booked or reserved. Mileage credit will not be awarded for flight cancellations. United expressly reserves the right to establish additional means of accruing mileage, to delete or modify any or all of the means currently recognized or to exclude specific types of transactions or tickets from the accumulation of mileage, in each case, with or without notice.
- 19. Mileage for air travel may be accrued only for paid travel on regularly scheduled flights.
- If United or any MileagePlus partner improperly denies a member an accrual or benefit, liability will be limited to the equivalent of that accrual or benefit.
- Class-of-service bonus miles, if any, will be credited according to the fare paid, not the cabin flown, and will not be credited on any upgrade.

#### United Airlines - MileagePlus Program Rules

- 22. Air mileage will not be credited for award travel, including tickets issued as MileagePlus awards and tickets purchased using a combination of miles and money; on travel industry or reduced tickets; consolidation tickets; or on tickets which are Issued subject to any accumulation of MileagePlus credit. In addition, some fares or tickets, including those sold over the Internet, at United's discretion, may be excluded from eligibility for mileage accrual.
- 23. Car and hotel mileage will be credited only for qualifying published rates, and not for special promotional accommodations, rentals or tickets, industry discounts, group rates or special promotional rates. For hotel and car rental mileage accrual, consecutive night stays or consecutive car rentals at the same hotel/car rental agency will be considered as one stay/rental, regardless of the number of check-ins or rentals.
- 24. Only the member associated with the MileagePlus account number which is used with partner transactions may receive mileage credit for partner services.
- 25. United reserves the right to make bonus miles and promotional offers by United or MileagePlus partners selectively available to certain members at any time, based on flight activity, geographic locations, Program participation, or other factors determined at United's sole discretion.
- 26. United will, in most cases, credit its members' accounts with accrued mileage. However, each member shall have the responsibility to ensure that such member's mileage is properly credited. Where a member contends that mileage has been earned but not credited, or in cases where United deems verification is required, United reserves the right to require proof of accrual from the member, including but not limited to copies of ticket coupons for flights daimed to have been flown or copies of receipts or similar documentation verifying any transactions claimed to have been performed. Any claims for mileage by the member and proof of accrual must be received by United within twelve months after the date such mileage was claimed to be earned. Certain partners may have valid retro-credit claim periods that differ. Please check mileageplus.com for details.

26a. Each member shall have the responsibility to notify United of any erroneous or fraudulent mileage deduction from such member's account within twelve (12) months of the date of the deduction. United will review such member's claim and reserves the right to require proof, documentation or certification from such member during the review. Crediting back to such member's account the miles claimed to be erroneously deducted will be determined by United in its sole discretion after review and United's decision will be considered final.

#### Mileage expiration

- Mileage accrued in a member's account shall be maintained in the account until it is redeemed for an award or until it expires, whichever occurs first.
- 28. Mileage accrued shall only be subject to expiration on the last day of the eighteen (18) months after the last account activity in the member's account. Activity includes flying, using your Mileage Plus credit card and more (see rule 10). In cases where mileage is for any reason removed from an account, such as for the redemption of awards, and later returned, the return of the mileage to the account shall not count as account activity.

#### Award redemption

- 29. The awards available to be redeemed and the amount of mileage necessary to redeem each award will be set by United and published to the members, United shall establish the process for award redemption, but redemption shall basically mean the exchange of mileage in a member's account for a specified award.
- 30. Awards may, at the request of the member, be issued by MileagePlus in the name of the member or in the name and for the use of any other person. Such awards will be issued only after a member validates their account via use of PIN, password or other security measures that United has in place at the time of the award request.
- 31. Mileage earned in two or more different accounts may not be combined to redeem any award.
- Travel on MileagePlus award tickets will be subject to the tariff, contract of carriage, ticket terms, and re-accommodation policies of the carrier on which travel is scheduled.
  - 32a. Redemptions of any non-air awards will be subject to the additional terms and conditions associated with redemption of the applicable award, including any terms or conditions established by the partner that is providing any such non-air award.

#### United Airlines - MileagePlus Program Rules

- 33. After an award ticket is issued, a service charge may be imposed for each change requested by the member that necessitates the reissuance of the ticket. See <u>award ticket fee chart</u> for applicable fees.
  - 33a, After any award, other than an air award, is issued, a service charge may be imposed for each change requested by the member, which necessitates the reissuance, adjustment or cancellation of the award.
- 34. Award tickets, awards and certificates may be subject to applicable departure taxes, federal inspection fees, passenger facility charges and other fees, charges or taxes, and the person utilizing the award is responsible for the payment of any such items that may apply.
- 35. Any valid unused award ticket or certificate may be returned to MileagePlus for a service charge. The mileage used to redeem the award will be credited to the member's account and be subject to expiration (see rules 10 and 28). When a reservation is made or non-air award is redeemed but then is subsequently cancelled or returned in accordance with the Program's applicable rules at that time, recrediting of the member's award miles taken in connection therewith will be subject to a service charge. Any return of mileage to the account shall not constitute account activity. For purposes of clarification, some award tickets may not be eligible for recredit of miles and will so state.
- 36. The award structure is subject to modification, cancellation or limitation at United's discretion, with or without notice. The amount of mileage required to redeem any award may be substantially increased, any award may be withdrawn, and restrictions on any award or its redemption may be imposed at any time.
  - 36a. The accumulation of mileage does not entitle Program members to any vested rights with respect to any awards or the Program. Awards for air travel shall be valid only to destinations served both at the time of the issuance of the award ticket and at the time of departure, and neither United nor its partners shall be liable for schedule changes that result in the cancellation of service to any destination. If a member falls to comply with any published award rules for air travel, at United's sole discretion, such member may be accommodated on a different flight than originally selected, seated in a lower class of service, denied ticketing or boarding, or be subject to other action as provided herein, and such member will not be entitled to compensation in connection with any such action.
- Upgrades will not be allowed on special promotional accommodations, rentals or tickets; industry discounts; consolidation tickets; group rates or special promotional rates.

#### International membership

 Participation in the MileagePlus Program may be prohibited or restricted in some countries. Nothing in these Rules should be read to override or circumvent any such foreign laws.

## Small Business Network Members

- 39. Each member of the Program that is not an individual shall be subject to each of the rules set forth above. In addition:
  - 39a. Each such member shall be a business that (i) is duly organized and validly existing in the United States under the laws of the jurisdiction of its organization, and (ii) is enrolled in the MileagePlus small business network ("Small Business Network").
  - 39b. Each Small Business Network member is responsible for ensuring that participation in the Program complies with the applicable policies and practices of such small business. Any act of a Small Business Network member's owners, directors, officers, employees, agents or contractors shall be deemed to be an act of such member.
  - 39c. Notwithstanding the prohibition in Rule 6 above regarding delegating or granting access to third parties, Small Business Network members may participate in the Program by means of an authorized representative of the business shall be the individual designated by the member as its primary contact. By participating in the Program, each member represents that the individual designated as its authorized representative has been duly appointed and authorized as such and that the authorized representative of the business is at least eighteen (18) years of age. Each member shall be responsible for ensuring they record and maintain account information in such manner so as to comply with the policies and practices of their business. Requests for changes to a member's account, such as a change of the authorized

representative, will not be honored without the member satisfying established requirements for account validation.

39d. In addition to the restrictions in Rule 7 above, none of accrued mileage, certificates or awards are transferable as part of a transfer of or assignment by a business.


39e. A Small Business Network member providing mileage awards to its employees for employee recognition or incentive purposes, as opposed to wages or compensation for services, shall not constitute a violation of Rule 8 above.

39f. Small Business Network members are not eligible to accrue mileage for flight activity.

39g. Miles may not be accrued by the Small Business Network member's account and any individual member account(s) (including any member account of such Small Business Network member's owners, directors, officers, employees, agents or contractors) for the same qualifying account activity, except as expressly allowed under the applicable MileagePlus partner's offer.

#### Comments on Legislative Bill No. 44-32 (COR)

The bill is seeking to transfer approximately 10 Million in air travel mileage which is separate and apart from those air travel miles identified by P.L. 31-117. Such air miles will be used to fund student travel involving academics, sports and cultural activities as approved by the Superintendent of Education. Because such air travel mileage is earned by the Government of Guam, specific airlines serving Guam may charge a transfer fee for transferring from Government of Guam to each student, resulting in significant fiscal impact to the annual appropriations of the Guam Department of Education. As an example, Delta Airlines charge a fee of \$0.01 per mile plus \$30.00 transaction fees. Using this as example, the potential fiscal impact could be as low as \$70,000, based on the following assumptions:

- Transfer fees used by Delta Airlines are \$0.01 per mile plus a \$30 transaction fees.
- In a given fiscal year, approximately 500 students will travel to the United States, all using the travel mileage available for GDOE that Delta has agreed to accommodate.
- Approximately 5,500,000 travel air miles will be consumed by these 500 students.
- Each student is a separate transaction fee.

For United Continental, the potential fiscal impact can be as high as \$82,500, which is based on a transfer cost \$15 per increments of 1,000 air miles for a total Mileage Plus transfer of 5,500,000.

Both airlines do have a limitation of 4 transfer events per account which means that the Department of Administration will need to negotiate with the airlines to allow unlimited transfers under the Government of Guam account.

AN ACT TO AMEND §23111(g)(2) OF CHAPTER 23, DIVISION 2, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO AUTHORIZING THE USE OF MILEAGE EARNED THROUGH CREDIT CARD PURCHASES AUTHORIZED BY THE GOVERNMENT OF GUAM, TO SUPPORT STUDENT TRAVEL INVOLVING ACADEMIC, SPORTS AND CULTURAL ACTIVITIES.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan

finds that the implementation of the government of Guam's mileage

program, specifically the Senator Edward J. Cruz Medical Referral Mileage

5 Bank Account Act (referenced as "P.L. 31-117"), recognized the difficult

6 financial environment many families on Guam continue to face when a

7 family member requires medical treatment abroad. The use of mileage

8 earned through government travel to help indigent citizens receive medical

treatment, not currently available on Guam, continues to offer much
needed hope for patients and their families.

*I Liheslatura* further finds, however, that approximately Ten Million (10,000,000) miles, which were accrued through government of Guam credit card purchases, remain unused. These miles are separate and apart from those miles required by P.L. 31-117 to be available for travel by medically indigent patients.

It is, therefore, the intent of *I Liheslaturan Guåhan* to authorize the use of mileage earned through government of Guam credit card purchases to support student travel involving academic, sports and cultural activities. *I Liheslatura* intends to help provide students in Guam's public schools the means to participate in various academic, sports and cultural activities off island, which will contribute to strengthening their academic, physical and social development.

# Section 2. Mileage Accrued Through Use of Credit Card Purchases.

§23111(g)(2) of Chapter 23, Division 2, Title 5, Guam Code Annotated, is hereby *amended*, to read:

# "(g) Deposit of Mileage.

(1) The Department is hereby authorized to become a member of the travel benefits program as it relates to travel mileage instituted by any and all airlines serving Guam, and shall enter into an agreement with an airline to accrue travel mileage credits for employees traveling on government and/or federally funded travel.

(2) The Department shall enter into an agreement with a bank on Guam for a credit card to use as payment for travel for employees traveling on government and/or federally funded travel, and to accrue mileage-, which shall be used exclusively for student travel involving academic, sports and cultural activities, as authorized by the Superintendent of Education. Authorized activities include, but shall not be limited to offisland events outlined in P.L. 31-132, including arts and humanities competitions, international cultural festivals and exchanges, the Junior Statesman Foundation, the National Science Fair, the Mock Trial, the Forensic League, and Close Up."

**Section 3. Memorandum of Agreement.** The Director of the Department of Administration shall establish a Memorandum of Agreement with the Superintendent of Education to effectively administer the provisions of this Act. The terms and conditions of the Memorandum of Agreement shall not be in conflict with the rules and regulations established for the *Senator Edward J. Cruz Medical Referral Mileage Bank Account*, as required by §23111(l) of Chapter 23, Division 2, Title 5, Guam Code Annotated.

- Section 4. Unused Mileage. Unused mileage earned from credit
- 2 card purchases, prior to the implementation of this Act, shall be reserved
- 3 for student travel, subject to the terms and conditions of the Memorandum
- 4 of Agreement established in accordance with Section 3 of this Act.
- 5 Section 5. Effective Date. This Act shall be effective upon
- 6 enactment.
