Committee Report Digest

I. OVERVIEW

The Committee on Education, Public Library and Women's Affairs convened a public hearing on Tuesday, April 2 2013 at 2:00 p.m. in *I Liheslatura's* Public Hearing Room. Among the items on the agenda was the consideration of Bill No. 58-32 (COR) - V.A. Ada - An act to amend §§6602 and 6603 and to add a new §6703 to Chapter 6 of 17GCA relative to protection of student information.

Public Notice Requirements

All legal requirements for public notices were met, with requests for publication sent to all media and all Senators on March 25, 2013 (5 Day Notice), and March 30 and 31, 2013 (48 Hour Notice) via email. Copies of the hearing notices are appended to the report.

The public hearing was called to order at 2:00 p.m.

II. SUMMARY OF TESTIMONY AND DISCUSSION

- **Speaker Won Pat, Ed.D.** announced that Bill No. 58-32 (COR) will be heard, the Speaker invited Deputy Superintendent Malay and Chief Bordallo to testify and asked Senator V. Anthony Ada the main sponsor of the bill to deliver opening remarks.

from the procurement law and he is attempting to bring everyone back under the umbrella of the Guam procurement law. He stated that he was elated to hear from GCC that they had no objection to amending the law and the President would testify in support of the bill.

- **President Okada, Ed.D.** testified in support of the bill. The President's written testimony is appended to the committee report.

- **Vice Speaker Cruz** had no questions to ask the President, but he stated the President eloquently explained the intention of the bill and that his office is in receipt of a letter from Attorney John T. Brown in support of the bill and it will be forwarded to the committee.

- **Majority Leader Respicio** clarified for the record that Vice Speaker Cruz has oversight of government procurement, however he referred the bill to the Committee on Education since it took away a specific authority of the College.

- **Senator Pangelinan** asked if the College needed to develop their own rules and regulations for procurement or just adopt the wholesale government procurement rules and regulations.

- **President Okada, Ph.D.**, stated that the bill puts GCC back in line with the rest of the government of Guam and there is nothing that they have identified that requires them to have their own rules and regulations. She stated basically we want to be placed back in line with the rest of the government.

- **Senator Pangelinan** asked if the constructions projects would be under DPW.

- **President Okada, Ph.D.**, replied no.

- **Senator Pangelinan** asked the President to clarify her statement about the bill placing GCC back with the rest of the government.

- **President Okada, Ph.D.**, replied at this time GCC has free rein based on the current law, in other words the board of trustees can develop their own rules and regulations as deemed necessary.

- **Senator Pangelinan** stated that it has to be consistent with law.

- **President Okada, Ph.D.**, replied the law is very broad. She stated that during a procurement class being offered at GCC, it was made clear in their discussions with Attorney John Brown that GCC should be offering procurement courses that are consistent and right now GCC is not consistent with Guam procurement law, because they can develop, create and the board can approve certain rules and regulations, which not necessarily happen with the rest of the government of Guam.

- **Senator Pangelinan** stated that GCC wants to lead by example.

- **President Okada, Ph.D.**, replied that is correct.

- **Senator Ada** stated the bill intends to strikeout donations and asked if the removal of donations would hamper GCC's ability to seek donations.

- **President Okada, Ph.D** replied no, since donations falls under the authority of the foundation.

- There being no additional testimonies by witnesses or comments by Senators, Speaker Won Pat, Ed.D. stated the committee will continue to accept written testimonies for the next ten (10) days and she declared that Bill No. 53-32 (COR) has been duly heard and concluded the public hearing of the bill.

III. FINDINGS AND RECOMMENDATIONS


The Committee Education, Public Library, and Women's Affairs finds that Bill No. 53-32 (COR) is supported by the Guam Community College to correct the current statute which inadvertently gave the College autonomous procurement authority.

The Committee Education, Public Library and Women's Affairs to which was referred "Bill No. 53-32 (COR) - B.J.F. Cruz - An act to repeal 17 GCA § 33105 and to amend 17 GCA § 31109; relative to the procurement authority of the Guam Community College." does hereby report out said legislation with the recommendation TO DO PASS.

2 **Section 1.** § 33105 of Title 17 of the Guam Code Annotated is hereby

6 **“§ 31109. Powers of the Guam Community College and Board.**

7 The Guam Community College and Board shall have all the powers
8 necessary and convenient to carry out and perform the purposes and
9 provisions of this Division except the power to levy and collect taxes or
10 special assessments including the following in addition to other powers
11 granted in this Division, it may:

12 (a) have perpetual succession except if this Chapter shall expire

2 kind and nature necessary or convenient to the exercise of its powers

Honorable Senator Cruz and Committee Members,

I would like to thank you for the opportunity to submit written testimony concerning Bill No. 53-32, "relative to the procurement authority of the Guam Community College."

The Guam Community College supports this legislation. About a year ago, the college updated its enabling legislation by replacing the term "vocational education" with "career and technical education," to be in line with federal legislation and initiatives that recognize career and technical education. In doing this, we also had the opportunity to update other language in the legislation, specifically as it relates to the GCC procurement authority. GCC's goal is to work toward the enactment of legislation that clearly states that GCC is authorized procurement power in accordance with and pursuant to 5 GCA. The current language of Section 33105 of Chapter 33 of Title 17 of the Guam Code Annotated appears to overreach this goal, as it instead grants the College authority to promulgate its own services and procurement regulations. We believe that the current statutory language does not meet the needs of GCC and that it is only necessary for the College to be authorized procurement power, and that it is not necessary for the College to be authorized to promulgate its own rules for procurement. We believe that Bill 53-32 corrects the current legislation which inadvertently gave GCC autonomous procurement authority.

I do submit that having received 12 consecutive clean audits, GCC has been extremely responsible with regard to our stewardship of public funds and our procurement efforts over the past 12 years.


In fact, over the past several months, we have been working with J. Thomas Brown and Gerry Perez to offer procurement courses for government agencies. To date, 66 people in 15 government agencies and several private entities have completed our procurement courses, the first of which provides an introduction to, and an understanding of, the public procurement process.

Dear Madam Speaker,

I write in support of the referenced Bill, and in thanks for the cooperation of GCC President Mary Okada, and the assistance of Vice Speaker BJ Cruz, and the collaboration of GCC Counsel Catrina Campana, in bringing this Bill to the floor.

This Bill mitigates two anomalies in existing law. First, it eliminates a unique power not given to any other GovGuam agency subject to the procurement law, the power to promulgate its own procurement regulations. Second, it empowers GCC with the full authority to conduct its own decentralized procurement of supplies, services and construction within the scheme of the procurement law, a power it did not fully possess under existing law.

GCC intends to become the pre-eminent local procurement training and education institution on Guam, and I hope to assist it with that goal. Indeed, I hope it extends that role to all of Micronesia. Coincidentally, I only became aware of the first anomaly in the course of teaching procurement at GCC.

I write in support but will be off-island on the scheduled hearing date, so respectively ask that this letter be accepted as testimony on the matter.




