## II. COMMITTEE PROCEEDINGS

**Chairman Vicente Pangelinan.** Bill number 76 introduced by Senator Frank Aguon Jr., which is “An act relative to establishing a mechanism that will ensure the immediate implementation of the mandates of the Criminal Injuries Compensation Commission, and providing amendments therein, in order to require the timely compensation of crime victims and their families for injuries incurred; through amending §§161.15, §§161.125 and §§161.130 of Title 8, Guam Code Annotated”. We have signed up to testify, Mr. Phil Tydingco from the Attorney General’s office and we would like to call him forward and of course give an opportunity to the author of the legislation to give us a synopsis of his bill.

### **(a) Bill Sponsor Summary**

**Senator Frank Aguon.** Just a couple of things for the audience who is watching. The good Speaker highlighted some of these provisions. I think that one of the things that we need to recognize and I don’t know if the Attorney General Tydingco will be able to rule here. My findings with a little bit a research was that since 2007, this Commission has not been empanelled and in tying that in with a particular division of the Criminal Injuries Compensation Commission, which requires that any victim or their family members who would like to avail themselves of possibly getting compensation through this particular fund that they will have 18 months from the date of the conclusion of their court case to be able to file their application. If you look at the lag time based on their concerns, I have written to the Chief Executive, asking him and also encouraging him, and understand that the Attorney General has also done likewise to try to work on identifying members that he can appoint to this particular commission so that it can be immediately activated.

If we can go section by section just so that you, my colleagues, and the public can understand.

The first section would extract the requirement for the attorney and the commission. Only because the Office of the Attorney General in another provision is outlined as provided as being the legal representative for this particular position. The section portion of Section One also provides for a mechanism.

Mr. Speaker, I hope that this will be acceptable for some of our colleagues because of the lag time, but now that we have an elected Attorney General I think that maybe one of the ways in ensuring that despite the requirement for Commission members to be appointed that at least a mechanism be provided so that the Commission can continue to operate, should there be insufficient members appointed at any point in time. Then obviously the others are self-explanatory.

For the annual reporting, I know that right now in the law it’s an annual report, but it’s being proposed to be amended to reflect a semi-annual report so that the issues whether there’s insufficient members or the commission has not met or has not had any activity over the course of a 6 month time frame. At least it’ll bring to your attention, Mr. Chairman to yourself or to members of this body if that report is provided that there has been no activity and I just wanted to highlight why it was provided.

Finally I just want to show that one of these statements that was relayed to us in a previous discussion was that there could be \$400,000 in this particular fund and it has not been provided to our victims and their families through this mechanism and I hope that with your support and with our colleagues' support that we can get this process going and re-activate the activities of the Commission and get the victims and their families their appropriate compensation. Thank you Mr. Speaker.

**Chairman Vicente Pangelinan.** Thank you very much Senator Aguon. Mr. Tydingco?

**(b) Testimony**

**Mr. Phil Tydingco.** Good Morning Chairman Pangelinan, Senator Respicio, Senator Mike San Nicolas, Senator Tom Ada, Senator Yamashita, Senator Frank Aguon, and Senator Tony Ada. I am Phil Tydingco, Chief Deputy on behalf of Attorney General Rapadas and the Office of the Attorney General.

We support Bill 76-32. We thank the good Senator Frank B. Aguon, Jr. for introducing this. We ask you and urge you to please support this bill. I believe that it's been told to me that when I came back to the AG's back in 2007 that the Commission hadn't met for a few years - even before that. Part of the problem of getting people appointed was that they had to at least be an attorney. But when you look at the statutory requirements of the Criminal Injury Compensation Commission a chapter that also has another provision says the Attorney General Office not only provide administrative support, but is also the attorney for the Commission and quite frankly it's saddening or embarrassing that we had difficulty getting my profession to participate or at least the Administration had difficulty getting some people to participate.

We've been given names and there are a host of reasons I don't need to get into about why some folks don't want to serve on these boards or commissions. I think by deleting the requirement that at least one member be an attorney, it would have an opportunity to make sure that we can get a quorum of three - if we have at least five members and one is not an attorney. The statute already requires the Attorney General to be the lawyer in the absence of a quorum so that the Commission does not remain inoperative; that the AG or the Deputy or the Office be able to administer the program and keep it going and still take the applications and act on it. The statute sets out the procedures and what qualifies for compensation and I can tell you that I know the language has been pretty good and we periodically have to remind Department of Administration that the money needs to be kept separate and apart - that's generated through the fines that's paid by the defendants.

We do receive periodically these monies from the courts and judiciary to be deposited into that account and I believe there's more than a little over \$400,000 - that's the last recollection that I have. I know that the Attorney General Rapadas has been very diligent and since he's become the Attorney General, he's sent a letter to the Governor, annually, if not semi-annually to remind him that we need this board appointed. In the event that there's no quorum we would like to be able to still administer the Criminal Injuries Compensation Fund, so that we can get that to these

families. There are many families, that even though they have restitution orders sometimes especially for the most serious violent crimes, those perpetrators or defendants are obviously unable to compensate restitution especially when they're sitting in prison.

Even if they're earning money, it's at a lower rate; at the very least some monetary compensation can be provided to the victims, especially for victims of homicide for funeral expenses or medical expenses that can be reached through this fund that's sitting there and not being administered because we either don't have a quorum or no one has been appointed for various reasons beyond the control of the administration. We ask you to support this. I believe there are safe guards now requiring a semi-annual report. Certainly these are separate accounts at DOA that have to be audited and those are the safe guards that you can count on in the event we're unable to get the quorum going. Thank you.

**Chairman Vicente Pangelinan.** Thank you very much, Mr. Attorney General. Senator Aguon did you any additional comments? Senator Ada.

**Senator Tom Ada.** Thank you Mr. Chairman. I find this an interesting provision on page 2 of Section 1 Section 1(a) that in the absence of a quorum or a minimum appointment of 3 members of the Commission, the Attorney General or his deputy are hereby granted the same powers and authority under this Chapter to carry out the purpose and requirement of this Chapter. The way I interpret this is that if we can't get a quorum then it's of no consequence because now the AG can step in and be the Commission. Am I interpreting that correctly?

**Mr. Phil Tydingco.** If there's no quorum, in order for this body to operate, then the AG's office can operate the fund and act on an application. If there is no board or commission then nothing happens.

**Senator Tom Ada.** So in essence, if we can't even get the Commission members who are appointed to show up to make quorum, now if they show up – great, if they don't then there's no consequence because the AG is going to step in. If that's the case, then why even waste anybody's time going through the confirmation process? Again if they show up or not it's of no consequence because the AG can step in and do the work of the commission.

**Mr. Phil Tydingco.** You're hypothetical there; that presumes and assumes that people will agree to have their names nominated and will be assumed to be disingenuous about wanting to participate in showing up. I don't think it's intended for the AG to step in when there's no quorum. For example, five people are appointed and only two showed up because the other three have perfectly reasonable excuses, it seems to me that the AG who steps in under those circumstances would be unreasonable and I don't think that we should assume again with that hypothetical that all the parties here are going to be unreasonable, because the two didn't show up. I think this is for the circumstance that the evidence clearly shows that there has been no quorum and there has not been anybody running it. Under those circumstances, I think reasonable people will conclude that why can't the agency continue to administer until you get the board up. It's not so much that it's a waste of time, it's the difficulty of getting people appointed. You're absolutely right if we assume that your hypothetical is reasonable. Then yes you don't have to have a Commission. You could just let the agency or the Attorney General

administer it and not include as a safeguard if you want community involvement. These are policy questions that you folks are entitled to make. You're right Senator Tom if that's the circumstance then you can certainly amend it and not have a commission.

**Senator Tom Ada.** Thank you very much.

**Chairman Vicente Pangelinan.** Senator Respicio?

**Senator Rory Respicio.** Thank you very much Mr. Chairman. Attorney General, the statute provides a remedy in itself; it says the vacancy in the Commission shall affect its powers if any member of the Commission is unable to act because of absence, illness, or other sufficient cause. The Governor may make a temporary appointment and such appointee may have all the powers and duties of a regular member of the Commission for the period of their appointment. So in reading this and if the Governor does make a temporary appointment, will that temporary appointment still be subject to the confirmation of the Legislature?

**Mr. Phil Tydingco.** No, not with the way the statute - that particular provision of that statute will be the ideal back up in the event.... certainly if we go back to Senator Tom Ada's hypothetical, that provision should kick in so that you wouldn't have the AG arbitrarily or maliciously use the role of the Commission simply because they had a reasonable reason for not showing up and there being no quorum. The purpose for that back up appointment provision that was put into the statute.... however the evidence has not been acted on and I can't explain that and I have no idea why that did not occur.

**Senator Rory Respicio.** My point is that there's a back up in place that these temporary appointments will not have to be subject to legislative confirmation and the Governor today can appoint the five members necessary and this Commission can be up and running until such time that he wants to fill these on a more permanent basis and it'll be subject to the advice and consent. So what he's proposing is a back up to the back up.

**Mr. Phil Tydingco.** What it's proposing is what the evidence show, which is the Commission hasn't been able to operate, because the regular appointment provision and the backup appointment provisions have not been working. Again these are policy calls and if the intent is to get the Commission up and running or rather to get the fund operating and getting the money to the victims and the families of these victims. If for some reason we just can't get the members then it's on the AG and his office to take those applications and act on them in accordance with all the rules and procedures that's laid out in the statute.

**Senator Rory Respicio.** Who would then say based on what Senator Ada's points out - he raised in the absence of a quorum resulting from permanent vacancies of a commission.

**Mr. Phil Tydingco.** Lack of appointment – sure to clarify it, you wouldn't have Senator's Tom Ada's hypothetical.

**Senator Rory Respicio.** Also, when you have a hearing that is announced and someone doesn't show up because of traffic or something – due to a lack of quorum.

**Mr. Phil Tydingco.** What you're saying is due to a lack of appointment. Pursuant to those other two provisions

**Senator Rory Respicio.** But if the Attorney General or his deputy were acting on behalf of the Commission because of a lack of appointments, so they would still have to follow the other provisions of the chapter right? They would have to announce the hearing date and conform to open government law.

**Mr. Phil Tydingco.** It's a commission, it's a board; they are subject to that.

**Chairman Vicente Pangelinan.** Senator San Nicolas?

**Senator Mike San Nicolas.** Thank you Mr. Chairman. You know I always appreciate Senator Tom Ada's sharp eye, because the question he raises now, does raise a concern for me and that is -- if a commission is created and they are suppose to be acting with some powers and if the commission does not meet and the Attorney General then exercises those powers, in the event that we need any recourse in calling in some..... compensation or what was paid out. That would create different liabilities for different groups. If the commission couldn't meet and the AG made the decision, and that decision was called into question, which would be responsible for answering that? Would it be the Commission or would it be the Attorney General?

**Mr. Phil Tydingco.** If I understand your questions, whoever is making the decision. If the evidence shows that person A or body B made the decision, then you would be able to prove who made the decision. I don't have Chapter 161 in front of me but I recollect that there may be some due process procedures. I'm working off from my memory. Again, this is assuming that an Attorney General would be arbitrary and capricious. Again I don't see that. The intent here is that the application is for the purposes of compensating the victims and their families. But certainly and to be absolutely clear, putting the language due to a lack of Governor appointed members..... so we don't have a body lay dormant and that whatever lies for 7 years -- just because we can't reach a quorum. It's not unusual. In other statutes where in the absence of a body, we have other agencies to keep running itself. The purpose here is to keep the Commission running so that we can operate the fund. It's just a shame that we can't get this money to the victims.

**Senator Mike San Nicolas.** I agree entirely Mr. Tydingco and I don't think anyone is trying to act capriciously and I don't intend to suggest that. We all make mistakes and in the event that a mistake is made and we need to be adjudicated that the lines of adjudication are clear so that adjudication can happen as quickly as possible. I do agree with the intent of this bill and the sentiments that you shared that we need to expedite and streamline this process, because people who are victimized shouldn't be made to wait.

But I also want to make sure that we're not going to be creating another potential problem, because we're not able to address the initial problem which is the inability to get the Commission working the way it was originally intended - by getting the necessary appointments, by making sure they understand that they participate to the fullest or making sure that the temporary

appointment proceedings that Senator Respicio mentioned are being prioritized by the authority needing to prioritize that. I'm just asking this question to make sure that we have clear lines of understanding and I want to make sure that we clarify that before we enact this into law. Thank you Mr. Chairman.

**Chairman Vicente Pangelinan.** Thank you Senator San Nicolas. Senator Yamashita?

**Senator Aline Yamashita.** Thank you very much Speaker ben. Everything being discussed is very critical in ensuring that we're doing things the right way. I just want to bring you back to the idea that there's so much bureaucracy that it seems that we go through this and it doesn't, as you said go to the family and the victims. I was with Father Mike the other day and he was saying that there's a pot of \$400,000 sitting and that's suppose to go to help the victims get back to life. I'm not going to ask why we can't seem to get members on the Board. Again this is another commission where we can't seem to get the process going so these folks are nominated and we go through the process.

I go back to thinking that we need to review all these councils, commissions and boards and I think it was the last legislature that we started talking about that or we actually passed something in the budget law. It's really too bad that one more time it's the folks that we want to help that are left out. I appreciate your support for this. I support it and if this is what it's going to take to get it moving then that's what we need to do. I wish there was no need for it, but the reality of our island today is that there's a huge need and God Bless those people out there who are doing their own fundraising and pulling loans on their own and collecting money for other people to help people get back on with their lives. We really need to get back and move on this and make it a sense of urgency.

**Mr. Phil Tydingco.** It's really urgent. It just occurred to me Senator Mike, we did not come up with this idea or suggestion for the AG's office. As lawyers, we would prefer that a commission or body do it to make the decision and we would just want to represent them as lawyers. We would be wearing an executive or an administrative hat, but we are willing to relent that anxiety about doing that because the bottom line is we need to get the money to the victims.

**Chairman Vicente Pangelinan.** Thank you very much. Senator Aguon, did you have any additional comments?

**Senator Frank Aguon.** Thank you very much Attorney General. Thank you very much for sharing your perspective. Just to address some of the issues that are being raised; one is in regards to the quorum - one of Senator Ada's biggest concerns - may originate from the absence of a quorum, rather than the absence of a minimum of three appointed members. If they assume this responsibility and you are sensitive to the requirements of paying the victims and their families, then perhaps that may be a different approach. Since 2007, there has yet to be appointed members of this Commission and in the meantime our victims and their family members who could have otherwise received some of the funds to support their efforts have gone on the wayside. I say by the wayside because there are some provisions in here - and I'm glad that Senator Respicio brought up the temporary appointment - I did recognize that and it still comes back to the idea that since 2007 or even a couple years back there was absolutely no sufficient

appointments provided here. I just want to thank our colleagues and the purpose is understood and how the legislation is considered and amended so that we can get that realized and I think that's the most important aspect and Mr. Speaker I thank you for having the hearing on this legislation. Si yu'us ma'ase.

**Chairman Vicente Pangelinan.** Thank you very much. Senator Tony Ada?

**Senator Tony Ada.** Nothing Mr. Speaker.

**Chairman Vicente Pangelinan.** I also like to thank Senator Mike Limtiaco for joining us this morning. Mr. Tydingco, could we just possibly make a decision that if there's no appointments, that we get members of the Executive branch that are sitting in a place where they have influence over the payments over the collections of these funds to just administer it? For example, the Director of Administration who have these funds in their custody or the Department of Corrections who have the prisoner in their custody and is responsible for allocating the fines paid into the funds and get those people to make the decision.... basically all you want to do is get the payments to the victims. Just a technical question: Are the payments to the victims only from the restitution ordered by the court for that specific perpetrator or is it from the General collections and can collection from one person go to pay restitution for another victim not his victim?

**Mr. Phil Tydingco.** Again I don't have the full statutory scheme in front of me. The way I understand how this operates; restitution that is ordered from court is separate from the Criminal Injuries Fund. When you start from that premise a court may order restitution and that would be an obligation upon the defendant due then. The Criminal Injuries Compensation Fund is generated from the fines.

**Chairman Vicente Pangelinan.** The fines set by the defendant?

**Mr. Phil Tydingco.** The fines that are set by the statute. That says, ok you commit aggravated assault you have got to pay in addition to ordering restitution for whatever out of cost pockets may be as part of the order. There's also the fine that may be up to \$10,000.

**Chairman Vicente Pangelinan.** For that defendant?

**Mr. Phil Tydingco.** For that defendant, and that fine goes into the Criminal Injuries Fund. Those fines that are collected as part of the Criminal injuries Fund in a check issued to the Office of the Attorney General deposits it into the Department of Administration. The statutory schemes for the Criminal Injuries Commission also recognizes that sometimes when a fine is paid but the restitution can't be made at that point, this is another mechanism to get the compensation to the victims.

**Chairman Vicente Pangelinan.** But my question: Is the money that's assessed that is not necessary the only amount...

**Mr. Phil Tydingco.** The fine is not linked to the victim, the fine is linked to the fund.



**Chairman Vicente Pangelinan.** Ok

**Mr. Phil Tydingco.** The fine is linked to the fund because...

**Chairman Vicente Pangelinan.** So, the Commission can decide -- there's \$10,000 that was deposited from one single defendant, he paid that fine and that's all the money he had. Other than what that fine was accessed; the Attorney General or the Commission can come in and pay that victim.

**Mr. Phil Tydingco.** The checks that come in from the Judiciary is whatever they collect. **BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1.** §§161.15 of Chapter 161 of Title 8, Guam Code Annotated, is hereby amended to read as follows:

**“§ 161.15. Creation of the Criminal Injuries Compensation Commission.** There is, within the government of Guam, a Criminal Injuries Compensation Commission (Commission’) which shall be composed of five (5) members appointed by I Maga’lahen Guåhan with the advice and consent of I Liheslantura. ~~One (1) member of the Commission shall be an attorney who has been admitted to practice in Guam for at least five (5) years. The Commission is within the Department of Law for administrative purposes. Annually, the members~~ shall elect a chairperson of the Commission.

1 (a) *If the Governor fails to appoint at least three (3) members to the*  
2 *Commission pursuant to statute within ninety (90) days upon*  
3 *enactment of this Act, ~~In the absence of a quorum or minimum of~~*  
4 *~~three appointed members of the Commission, the Attorney General~~*  
5 *or his Deputy are hereby granted the same powers and authority*  
6 *under this Chapter to carry out the purposes and requirements of*  
7 *this Chapter until such time the Governor appoints at least three (3)*

9 Section 2. §§161.125 of Chapter 161 of Title 8, Guam Code Annotated,  
10 relative to Commission staff is hereby amended to read as follow:

11 “§§161.125. **Commission Staff.** Supervisory, administrative and clerical  
12 personnel necessary for the efficient functioning of the Commission may be  
13 appointed, **by the Attorney General. The Department of Law or Office of the**  
14 ***Attorney General shall provide administrative support for the effective***  
15 ***operation of the Commission.***

16 Section 3. §§161.130 of Chapter 161 of Title 8, Guam Code Annotated,  
17 relative to providing periodic reports on Commission activities, is hereby amended  
18 to read as follow:

19 “§§161.130. **Semi-Annual Report.** The Attorney General shall transmit  
20 **semi-**annually to *I Maga’lahi* and to *I Liheslatura* a report of the Commission’s  
21 activities under this Chapter, including the name of each applicant, a brief  
22 description of the facts in each case, and the amount, if any, of compensation  
23 awarded. **Such reports shall be due no later than January 30 and June 30 of**  
24 **each year.** The Attorney General shall transmit the report, together with a
