



**AN ACT TO AMEND §106119(k) AND (o) OF PART A OF
ARTICLE 1, CHAPTER 106 OF TITLE 11, GUAM CODE

ACCOUNT FUNDS FROM THE TREASURER OF
GUAM TO THE GUAM HOUSING CORPORATION'S
HOUSING TRUST FUND.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the implementation of P.L. 31-166, the “*First-time Homeowner Assistance*

1 *Program Act*”, which was enacted in January 2012, recognized that the cost of a
2 single-family home continues to be out of reach for a number of potential first-time
3 homeowners. The anticipated realignment of U.S. Armed Forces in the region
4 continues to invite potential growth in Guam’s housing industry. Such real estate
5 activity, however, may leave potential first-time homeowners with little to no
6 options for realizing their dream of owning a home.

7 *I Liheslatura* further finds that the *First-time Homeowner Assistance*
8 *Program Act* further recognized that additional legislation might be required,
9 specifically designating revenue sources for the program, in order to assist as many
10 qualified borrowers.

11 It is, therefore, the intent of *I Liheslaturan Guåhan* to provide an additional
12 source of revenue to assist potential first-time homeowners and their families
13 through the First-time Homeowner Assistance Program. *I Liheslatura* intends to
14 authorize the transfer of dormant and unclaimed bank account funds from the
15 Treasurer of Guam to the Guam Housing Corporation’s Housing Trust Fund, by
16 amending §106119(k) and (o) of Chapter 106, Title 11, Guam Code Annotated.

17 **Section 2. Dormant and Inactive Accounts and Unclaimed Funds.**

18 §106119(k) and (o) of Part A of Article 1, Chapter 106 of Title 11, Guam Code
19 Annotated, are hereby *amended* to read:

20 “(k) All funds transferred to the Treasurer of Guam pursuant to the
21 provisions of this Section *shall* escheat to the Territory of Guam one (1) year
22 subsequent to the date such transfers occurred.”

23 “(o) There *shall be no* statute of limitations as to claiming dormant
24 bank accounts. All claims against the government of Guam for balances of
25 accounts which have been transferred as inactive or dormant accounts to the
26 government of Guam by any bank must be initiated by a claim against the

1 government of Guam under the Claims Act, within one (1) year of the date
2 of transfer.”

3 **Section 3. Fiscal Year 2013 and Fiscal Year 2014 Dormant and**
4 **Inactive Account Revenue.** During Fiscal Year 2013 and Fiscal Year 2014, the
5 Treasurer of Guam *shall* deposit, up to \$1,653,440 for Fiscal Year 2013 and up to
6 \$900,000 for Fiscal Year 2014, funds escheated pursuant to §106119 of Chapter
7 106 of Title 11, Guam Code Annotated, into the Housing Trust Fund established in
8 Article 10 of Chapter 4, Title 12, Guam Code Annotated. Such funds *shall* be used
9 in accordance with the provisions of the *First-time Homeowner Assistance*
10 *Program Act*, and are in addition to all other funds authorized by current law for
11 the *First-time Homeowner Assistance Program*.

12 **Section 4.** The Department of Administration *shall* report each transfer
13 made to the Guam Housing Corporation (GHC) pursuant to this Act within five
14 days. The Guam Housing Corporation *shall* report to *I Liheslatura* (the
15 Legislature) at the end of each fiscal year the results of the transfer of escheated
16 funds in terms of homeowner assistance, and *I Liheslatura* (the Legislature) *shall*
17 review the adequacy of funding to the First-time Homeowner Assistance Program.

18 The GHC *shall* encumber the transferred funds within 12 months of the
19 transfer, and be disbursed within 18 months of said transfer date. Funds *not*
20 encumbered or expended *shall* revert to the General Fund.

21 **Section 5.** All funds made available by this Act *shall only* be expended on
22 grants for First-time Homeowners.

23 **Section 6. Effective Date.**

24 (a) Subject to Subsection (b) of this Section 6, §106119(o) of Title 11,
25 Guam Code Annotated, as amended by this Act, applies to actions in which the
26 cause of action accrues on or after the effective date of this Act.

1 (b) For causes of action that are governed by §106119(o) of Title 11,
2 Guam Code Annotated, and accrued prior to the effective date of this Act, the
3 period of limitations *shall* be one year from the effective date of this Act, or the
4 expiration of the period of limitations in effect prior to the effective date of this
5 Act, whichever occurs first.

Committee Report

Bill No. 79-32 (COR): An Act to amend §106119(K) of Chapter 106, Title 11, Guam Code Annotated, relative to authorizing the transfer of dormant and unclaimed bank account funds from the Treasurer of Guam to the Guam Housing Corporation's Housing Trust Fund.

I. OVERVIEW

The Committee on Appropriations, Public Debt, Legal Affairs, Retirement, Public Parks, Recreation, Historic Preservation and Land convened a public hearing on May 14, 2013 at 2:00 pm in *I Liheslatura's* public hearing room.

II. COMMITTEE PROCEEDINGS

Chairman Vicente Pangelinan. The next bill on the agenda is Bill No. 79, introduced by Speaker Won Pat, relative to authorizing the transfer of dormant and unclaimed bank account funds from the Treasurer of Guam to the Guam Housing Corporation's Housing Trust Fund. I have signed up to testify Mr. Anthony Blas, Mr. Frank Florig, Mr. Martin Benavente and Mr. Carlos Camacho.

Before we receive testimony, we will ask the author of the bill to give us a synopsis of the bill.

(a) Bill Sponsor Summary.

Speaker Won Pat. Thank you Mr. Chair. This bill will authorize the transfer of dormant and unclaimed bank account funds from the Treasurer of Guam to the Guam Housing Corporation's Housing Trust Fund. Public Law 18-37, passed in 1986, which is the current law states that unclaimed bank account proceeds escheated to the government of Guam as follows:

Savings accounts will be a ten-year waiting period, which allows the banks to contact the depositors. For checking accounts, it's a two-year wait, which also allows the banks to contact depositors. These deposits are transferred to the Treasurer of Guam for an additional five years before escheatment occurs and after that the funds go to the general fund.

Bill 79-32 seeks to do two things: (1) to reduce the period dormant and unclaimed bank deposits remaining in the government of Guam from five years to one year and (2) to transfer dormant and unclaimed bank accounts into the Housing Trust Fund to assist first time homeowner buyers.

Thank you very much.

Chairman Vicente Pangelinan. Thank you very much Speaker Won Pat. Mr. Blas?

(b) Testimony

Mr. Tony Blaz. Si Yu'os Ma'ase, Mr. Speaker, Madam Speaker and members of the Guam Legislature. My name is Tony Blaz and I am the Deputy Director of the Department of Administration. I am here to provide comments on Bill No. 79-32.

Chairman Vicente Pangelinan. Thank you Mr. Blaz. Mr. Florig?

Mr. Frank Florig. Thank you Mr. Chairman, Madam Speaker and Senators. Thank you for allowing me the opportunity to testify on this bill. My name is Frank Florig and I am the current Chairman of the Board for Guam Housing Corporation. My opinion, and this is strictly mine is that I am in support of this bill. This bill, 79-32 allows the means for us to continue the First Time Homeowner Assistance Program. The Homeowners Assistance Program provided us the means to help people that were on that fence line for ownership or continue holding a position of tenancy. This bill will provide the funds. Quite frankly, we did it with half million of our operating expenses and unfortunately we don't have the money to continue with this particular program. It's a great program and 70 families, today can testify to that. I saw some of them earlier today – they were here at 2:30pm; some of them had to leave. But, the program works.

Senator Pangelinan, I would like to thank you and the Legislature that passed the Homeowners Relief Act and Speaker Judith Won Pat, I would like to thank you for having the foresight to find a funding source. I would be remiss if I don't mention Senator Barnes because she is always on the forefront of helping us out with the affordable homes, as well as members of this Committee.

Again, thank you and I am in support of this bill.

Chairman Vicente Pangelinan. Thank you very much, Mr. Florig. Mr. Benavente?

Mr. Martin Benavente. Thank you for allowing us to testify. Members of the Committee, I would like to give a short testimony. This testimony is a combined testimony from the Guam Housing & Urban Renewal Authority (GHURA). We developed this testimony for the last public hearing and at that time GHURA was not able to attend because they had a board meeting. Today, I am not sure the reasons why they are not here, but we will submit this testimony on behalf of Guam Housing Corporation and GHURA.

I have already mentioned that we service 70 families, but Bill 79-32 will allow additional families to realize their dream and provide the much needed funds for this program. We need to start looking at how to fund our local programs as evident with the current sequestration with the federal government. We find ourselves reducing services in housing instead of increasing these services, which need. Almost immediately, we lost almost 200 slots for Section 8 when GHURA was told to cut. They have been cutting; they are still cutting. We can't just leave our people out

there. A lot of people are falling through the cracks and without the help of what the Legislature provides, we can never service these people – those people that are ready to afford a home and without the down payment assistance program, they would not have been able do this.

I applaud you, Senator Pangelinan for thinking about this program and the fact that we have proven it works. I think we should continue it. It's something that we have to do as part of our growing up here in Guam – we provide our own housing needs. With the help of the Legislature, we created this Housing Trust Fund over a year ago and has a tremendous possibility to expand to just about every program as it deals with providing people with homes. We want to look into bringing in metal buildings that are a lot cheaper and less expensive and becomes more affordable for the average person. We have been able to help finance people up to \$250,000, but we missed the people that can only afford \$40,000 or \$50,000 or \$30,000. With the use of alternative building systems, like metal I think we can provide people homes that are roughly about \$30,000-\$35,000. If you figure that out over a certain period of time, it comes out to be a very nominal cost and very affordable and that's one of the things we want to do. That, along with this down payment assistance we continue to provide to them, I think it's the answer to helping the people that we've missed. We have missed a lot. They are sitting out there in canopies, they are sitting there in tin houses and we need to find a way to solve that problem. This continued funding to the Housing Trust Fund is the way to do it. We feel this is the way to do it. We can control it ourselves because every expenditure that comes out of that has to go through this body.

Mr. Chairman, thank you for your insight, and your foresight. This could never have been possible for these 70 families if we didn't get it started. We've joined you in our investment and we put in what we thought we could afford. Now, it's time for the new funds to come in and help us continue the program and this [bill] will certainly get us going. Thank you very much and I will answer any questions you may have.

Chairman Vicente Pangelinan. Thank you very much, Mr. Benavente. Mr. Camacho?

Mr. Carlos Camacho. Mr. Chair, Speaker Won Pat, Senator Barnes, Senator Ada, Senator (Tony) Ada, Senator Duenas and Senator Morrison. The reason I mention all your names is that I would like to give a little historical perspective because it is very ironic today that based on the little memory I have prior to - further back, I am not sure - but I wanted to recognize Senator Pangelinan because this movement on the First Time Homeowner Relief Act started in the 24th Guam Legislature, as I recall when the Senator was trying to use one-tenth of a percent of the GRT as a source of funds to fund a down payment and closing costs for Guam Housing. That's when Guam Housing – Martin, you were Deputy then – and it's ironic that now the Deputy Director of DOA is endorsing this when he was one of the Senators who supported Senator Pangelinan's bill, which was then 24-180. That was 14 years ago.

As we go through this with Guam Housing ad the learning curve, we knew that source was not stable. We were not able to get a consistent funding source but I remember we did a lot of homes for those families at that point.

Chairman Vicente Pangelinan. It is stable. It's just that the Governors would never put the money in. One-tenth of the GRT is very easy. It's very stable. It's just that the Governors just did not do it.

Mr. Carlos Camacho. Thank you for that.

Chairman Vicente Pangelinan. We should just go back to that.

Mr. Carlos Camacho. It started from Bill 24-180. Fourteen years later, Senator Pangelinan, Senator Barnes, Speaker Won Pat, Senator Ada - and the Senators [Tony Ada, Duenas and Morrison] will hopefully be the new Senators to support this bill to pass, 79-32 – supported Senator Pangelinan's Public Law 31-166 that created the First Time Homeowner Fund. Guam Housing used their first \$500,000 as the seed money to do this. As Martin eluded that \$500,000 helped 70 families and developed close to \$12M of real estate transactions that became a multiplier affect for Guam's economy.

My organization played a major role because we are the HUD Certified Housing Counseling Program. We provide the pre-purchase counseling for these families. Before they get these grants, they have to go through an 8-hour course to understand what they are getting themselves into. We are seeing a huge demand based on these laws. When [Public Law] 31-166 was passed, it created the Housing Trust Fund to find a stable source. Thank you to Speaker Won Pat and Senator Barnes and the Housing Committee to identify this escheatment account. Today, we found out there are multiple escheatment accounts, at least in regards to the one we are familiar with - the bank dormant accounts - we knew that if did go to the Treasurer of Guam, it would go to the general fund and it would pay for general operations. If it goes to the Housing Trust Fund that Senator Pangelinan created, it would have a huge multiplier affect. I did the numbers real quick – assuming the numbers are correct [former] Senator Blaz had identified escheatment of \$2.1M - based on the formula in [Public Law] 31-166, an average of a \$10,000 grant, based on 250, up to that portion that would yield about 210 additional families or \$52M of real estate transactions to our economy. If you times that by the rate times 30 years, that would bring you close to \$100M of funds back into either the portfolio of the banks or through the secondary market if you went through Freddie Mac.

That sustains jobs and brings back money to our economy. It also increases our aggregate value when DRT goes in finds these new homes to be appraised and increase real estate taxes. There are huge multiplier affects. That's why when Martin, our Chairman for affordable housing and Senator Barnes, our Vice Chair decided to ask different people to join, I opted to join the Affordable Housing Council because I knew that, while we do help a certain group in society, we are also contributing into the economic activity to this government so that you, the policy makers can legislative funds for its appropriate use.

Therefore I do support Bill 79-32 and of course this is just one source of funds. I know that Senator Pangelinan is looking at way to fund a sustainable source and we at the 15 creative minds of the body to help us, help Guam Housing find these funds because – these funds will not be used until a home is built based on [Public Law] 31-66. The grant will only be given to John Doe unless the home is either purchased or there is a bank loan ready to go.

My final thought is that just two weeks ago, I ran an advertising campaign, which I did for Guam Housing and GHURA for a \$155,000 home in Dededo. Unfortunately, USDA is not available in Dededo, so we had to use a conventional 95-5 financing; that's 5% down plus closing costs. We tried to bring the house down as low as we could for \$155,000. We were inundated with first time homeowners. One of the things they lacked was the down payment and closing costs. This is why through your legislative intent from the 24th to today identified that and it's proven. But, the 4% based on the new formula of the \$155,000 will at least give these guys an edge for their down payment and closing costs. A lot of these guys are being creative – they will use their 401K, use their cash value from their insurance policies to assist them. These guys really wanted it and the \$6,000 based on this formula will give them an extra edge to ownership.

For all those who took [Bill] 24-180 from the original bill – maybe there is more from the past I could not recall and [Public Law] 31-166 – Senator Pangelinan, that you very much for your foresight and I look forward to you helping us pass [Bill] 79-32. Thank you very much,

Mr. Martin Benavente. May I make one more point - Bill 79-32 takes from a great funding source without raising taxes or charging any additional fees. There are several more that we have suggested and I call that the victimless source to provide some of the much needed housing here on Guam. I invite us to continue looking at some of the other source of funding that we have been recommending. It's being applied in 40 other states. The trust fund is not a new, we just learned about it from our neighbors in Hawaii and we are hoping it will work for Guam so we have more control over what we do here in housing, how we manage and allow the people that have slipped through the cracks an opportunity for that Guamanian dream. Thank you very much.

Chairman Vicente Pangelinan. Thank you very much. We try to identify a funding source that will not take away from resources that we need for other government operations. I think that's the challenge we find ourselves in. That's why we structure the second First Time Homeowner Program so that it would not impact the general fund and not impact the resources that we use to support education, GPD and all the other requirements of this government; the flooding issues that we heard earlier in another bill – \$700M we need to resolve for village flooding, \$200-\$500M for primary road flooding. The challenge is that are these monies being used now to support the operations and if they are, then how do we replace that money in order to provide the resources for the other government agencies for other government services.

Which brings me to my question to Martin; if you could perform an analysis for me. I know this program resulted in increasing the GHC loan portfolio by 17 loans. Can you run for me the spread you have between your loan rate and your cost of funds rate, and what your margin is on that, and then how much that yields in interest income for the agency? If you could, please send me an email with that information.

Mr. Martin Benavente. Yes, we will get that to you. Another point – I'd like to thank the GHC staff that has been here since 2:00 pm. I believe it would be worth it if we could pass this bill, because we have a big mission and we want to complete it.

Chairman Vicente Pangelinan. Thank you very much. Madam Speaker?

Speaker Won Pat. Asks if there are any home loans pending funding?

Mr. Martin Benavente. Yes, we continue to take in, even if we know we are exhausting our funds, we continue to take in names and we're prequalifying people. \$2.4M worth of loans that is ready to be doled out once we get funding for it.

Speaker Won Pat. For DOA, what is the current balance of unclaimed and dormant bank accounts?

Mr. Tony Blaz. Our staff is working on it, as well as with Senator Pangelinan's Office of Finance and Budget, and we can get you that information tomorrow. The dormant accounts, currently there is a balance of \$2,169,393. When this bill is passed we will have up to \$1,217,383.36, which will be available to be escheated. For fiscal year 2013, the revenues will be there additional \$436,057.35. For 2014, we have \$900K available after that.

Speaker Won Pat. One of the points of the bill is to reduce from five (5) years to one (1) year, and at least in some preliminary numbers, so if for the first year 2012 of about \$403K and keep going down the line, then that's all that's available, but when you add up, the 2nd, 3rd, and 4th year then the amount increases, probably yielding more than \$1M.

Mr. Tony Blaz. Yes, \$1.2M and than an additional \$413 on top of that.

Chairman Vicente Pangelinan. And again this is recognized in the financial statements of the Government of Guam and in the appropriations.

Mr. Tony Blaz. Yes that is right.

Chairman Vicente Pangelinan. Thank you very much. This concludes the testimony on Bill No. 79-32. There being no additional individuals to present any additional testimony, this Committee will continue to remain open for the acceptance of any additional information or public testimony on the bill discussed. 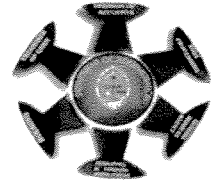

I understand the intent of Bill 79-32 relative to the authorization of dormant and unclaimed bank account funds for use as a revenue source for the First-time Homeowner Assistance Program.


Title 11 GCA Chapter 106 §106119 sets the requirements for the banks to transfer or "escheat" funds to the government. Under the law, after 10 years of inactivity in a Savings Account the funds are transferred to the Treasurer of Guam. After 5 years of inactivity in a Passbook Savings Accounts the funds are sent to the Government of Guam. Finally, for Checking accounts, after 2 years of inactivity, the bank is required to forward the money to the Government of Guam. This is the bank regulations specifying the period when the various accounts become dormant.

When the banks transfer these "dormant" accounts to the Government of Guam, the liability remains on our books for an additional five (5) years before it is escheated to the government. This law will change that holding period from five years to one year.

DOA supports the intent of this bill however we would like to point out that revisions to §106119 (M) and (O) should also be revised to reflect the change proposed in a §106119 (K) relative to the deposits of balances and to the proposed change relative to the escheat period respectively.

The Department of Administration fully supports Bill 79-32 with proposed changes.

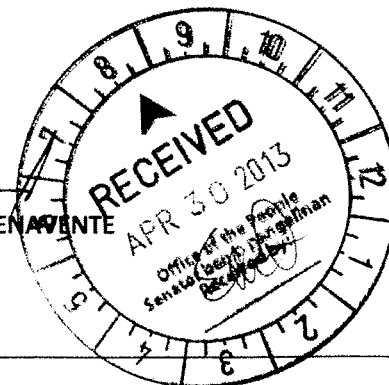



Comments on Bill No. 79-32 (COR)

This proposed legislation is seeking to transfer dormant and unclaimed bank accounts from the Treasurer of Guam to the Guam Housing Trust Fund. A review of the dormant account reflects a running balance of \$2.2 Million; however, the transfer of funds from the an account held in trust by The Treasurer of Guam to the General Fund is based on when an dormant account is transferred into the Treasurer of Guam and from that transferred date a period of four years must elapse before a cash transfer can be made, in accordance with Government Accounting Practice and Procedures (GAPP).

Assuming that all of the available cash dormant account is available for the transfer, the common practice was to transfer the cash dollars into the General Fund for the purpose of paying General Fund obligations such as vendor payments, Income tax refunds, etc. Should this proposed legislation pass, the General Fund's ability to pay its obligations would be reduced by the same amount being transferred into the Housing Trust Fund.



Comments on Bill No. 79-32 (COR)

This proposed legislation is seeking to transfer dormant and unclaimed bank accounts from the Treasurer of Guam to the Guam Housing Trust Fund. A review of the dormant account reflects a running balance of \$2.2 Million; however, the transfer of funds from the an account held in trust by The Treasurer of Guam to the General Fund is based on when an dormant account is transferred into the Treasurer of Guam and from that transferred date a period of four years must elapse before a cash transfer can be made, in accordance with Government Accounting Practice and Procedures (GAPP).

Assuming that all of the available cash dormant account is available for the transfer, the common practice was to transfer the cash dollars into the General Fund for the purpose of paying General Fund obligations such as vendor payments, Income tax refunds, etc. Should this proposed legislation pass, the General Fund's ability to pay its obligations would be reduced by the same amount being transferred into the Housing Trust Fund.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan*
3 finds that the implementation of P.L. 31-166, or the "*First-time Homeowner*
4 *Assistance Program Act*", which was enacted in January 2012, recognized
5 that the cost of a single-family home continues to be out of reach for a
6 number of potential first-time homeowners. The anticipated realignment
7 of U.S. Armed Forces in the region continues to invite potential growth in
8 Guam's housing industry. Such real estate activity, however, may leave
9 potential first-time homeowners with little to no options for realizing their
10 dream of owning a home.

1 *I Liheslatura* further finds that the *First-time Homeowner Assistance*
2 *Program Act* further recognized that additional legislation might be
3 required, specifically designating revenue sources for the program, in
4 order to assist as many qualified borrowers.

5 It is, therefore, the intent of *I Liheslaturan Guåhan* to provide an
6 additional source of revenue to assist potential first-time homeowners and

16 (k) All funds transferred to the Treasurer of Guam pursuant to the
