### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that the Guam Ancestral Lands Commission (GALC) is hampered by a lack of

1	authority to expend funds towards the development of its properties, more				
2	commonly known as "Crown Lands," which are lands that are not privately-owned				
3	and remain under the jurisdiction of the Guam Ancestral Lands Commission.				
4	Therefore, I Liheslaturan Guåhan intends to establish a GALC Survey,				
5	Infrastructure, and Development Fund that can be used for the survey, construction				
6	of infrastructure, and development of Crown Lands, and to pay for administrative				
7	costs of the Commission.				
8	Section 2. A new § 80104(h) is hereby added to Chapter 80, Title 21, Guam				
9	Code Annotated, to read:				
10	"(h) Guam Ancestral Lands Commission Survey, Infrastructure, and

- Development Fund.
  - **(1)** The Guam Ancestral Lands Commission shall create a special fund called the Guam Ancestral Lands Commission Survey, Infrastructure, and Development Fund (Fund), which shall be maintained separate and apart from any other funds, and shall not be subject to the transfer authority of I Maga'låhen Guåhan.
  - Notwithstanding any other provision of law requiring the (2) deposit of proceeds to other funds, the Fund shall receive the net proceeds of all leases of Apra Harbor Reservation F-12 and Parcel N14-1 (the Polaris Point parcels) under the jurisdiction of the Guam Ancestral Lands Commission.
  - The Fund shall be used for the surveying and mapping, purchase and installation of infrastructure, including paved access roads and commercial development, of Guam Ancestral Lands Commission properties, and for the administrative, operational, and financial support of these efforts.

(4) The Commission *shall* submit a report on a semi-annual basis to the Speaker of *I Liheslaturan Guåhan* of the revenues collected and expended from the Fund, and post the same on the website of the Guam Ancestral Lands Commission. The Fund *shall* be subject to audit by the Guam Public Auditor."
