

2	Section 1. Rescindment of Administrative Jurisdiction of Lot 7116-1-2-1.
3	Notwithstanding Document No. 509898, Transfer of Administrative Jurisdiction of
4	Government Lot Nos. 7116-1-2-1 and 7116-1-2-R2, Municipality of Yigo (dated May
5	26, 1994), administrative jurisdiction of Lot No. 7116-1-2-1, containing an area of
6	12,254 square meters or 3.03 acres as shown and delineated on land survey map
7	L.M. No. 358FY88, granted to the Office of the Mayor, Municipality of Yigo, is
8	hereby rescinded. Administrative jurisdiction shall rest with the Chamorro Land
9	Trust Commission.
10	Section 2. Severability. If any provision of this Act or its application to any
11	person or circumstance is found to be invalid, or contrary to law, such invalidity
12	shall not affect other provisions or applications of this Act that can be given effect
13	without the invalid provision or application, and to this end the provisions of this
14	Act are severable.
