AN ACT TO AUTHORIZE THE SALE OF A THREE HUNDRED SIXTEEN PLUS OR MINUS (316±) SQUARE METER PORTION OF THE *OLD DELA CORTE STREET* IN *OLD AGAÑA* CONTIGUOUS TO LOT 1058 NEW, LOT 1060-2 NEW, LOT 1041-1 NEW, AND LOT 1047 NEW IN THE MUNICIPALITY OF *HAGÅTÑA*.

### BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that the realignment of Route 1 rendered some Old Agaña streets and alleys
- 4 unneeded for public use, but that are valuable and usable to owners of the contiguous
- 5 lots.

I Liheslaturan Guåhan further finds that these streets and alleys, if
consolidated with contiguous lots, may become developable property and thus
increase the real property tax base of the government of Guam.

ILiheslaturan Guåhan further finds that such is the case with a three hundred sixteen plus or minus (316±) square meter portion of the Old Dela Corte Street in the municipality of Old Agaña in which it will benefit the government of Guam to dispose of the unneeded and abandoned portion of said street.

Section 2. Authorization to Sell Easement Not Needed for Public Use. I Mina'Trentai Kuåttro Na Liheslaturan Guåhan hereby authorizes I Maga'låhen Guåhan to sell approximately three hundred sixteen plus or minus (316±) square meters of that portion of the Old Dela Corte Street as shown on that sketch identified as RLSSKHAG-01 prepared by Registered Land Surveyor No. 73 (Exhibit A).

The Department of Land Management and the owner of contiguous Lot 1047 NEW in the municipality of *Hagåtña shall* complete the sale. Should the entirety of the *Old Dela Corte Street* in the municipality of *Old Agaña* be purchased solely by the owner of Lot 1047 NEW, said owner *shall not* cause a situation that would land lock the contiguous lots. If the owners of Lot 1058 NEW and Lot 1060-2 NEW express interest in purchasing a portion of *Old Dela Corte Street* in the municipality of *Old Agaña* contiguous to their lots, said owners *shall* be given the opportunity to do so within thirty (30) days of the enactment of this Act.

Exhibit A depicts the boundaries of the approximately three hundred sixteen plus or minus (316±) square meter left-over, irregular remnant portion of the *Old Dela Corte Street* to be purchased by the landowner of contiguous Lot 1047 NEW in the municipality of *Hagåtña*.

Section 3. Proceeds of Sale. Funds generated from the sale *shall* be deposited in the Chamorro Land Trust Survey and Infrastructure Fund, identified as

- 1 Chamorro Land Trust Revenue Account Number 3669-57001, CLT-Sale of
- 2 Government Land.

- Section 4. Appraisals. 2 GCA § 2107(b) relative to appraisals of land shall 4 apply to this Act.
- Section 5. New Assessment and Update of Real Property Tax Roll. Upon approval and recordation of the consolidation map for the irregular remnant portion of the Old Dela Corte Street and Lot 1047 NEW, the Real Property Division of the Department of Revenue and Taxation shall conduct a special valuation of the consolidated lot and the new tax assessment shall become due and payable in the succeeding year. The Tax Roll shall be updated accordingly.
  - Section 6. Severability. If any provision of this Act or its application to any person or circumstance is found to be invalid or contrary to law, that invalidity *shall* not affect other provisions or applications of this Act that can be given effect without the invalid provisions or applications, and to this end the provisions of this Act are severable.
