





**AN ACT TO AMEND § 9302 OF CHAPTER 9, ARTICLE 3,
TITLE 12, GUAM CODE ANNOTATED, RELATIVE TO
THE ANNUAL DEPOSIT INTO THE GUAM VISITORS
BUREAU "RAINY DAY FUND."**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 9302 of Chapter 9, Article 3, Title 12, Guam Code Annotated,
3 is *amended* to read:

4 **"§ 9302. Annual Deposit.**

5 An amount equal to one and one-half percent (1½%) of the adopted
6 revenue projection of the Tourist Attraction Fund for each fiscal year, or Two
7 Hundred Thousand Dollars (\$200,000), whichever amount is greater, *shall be*

1 set aside and allocated by the Department of Administration to the Guam
2 Visitors Bureau for deposit into the Fund established by this Section. Each
3 annual deposit *shall* be made over the course of the fiscal year as collections
4 are received.”
