



**AN ACT TO *AMEND* § 161.55 OF CHAPTER 161, TITLE  
8, GUAM CODE ANNOTATED, RELATIVE TO THE  
DEFINITION OF VIOLENT CRIMES AS IT RELATES  
TO CRIMINAL INJURIES COMPENSATION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 161.55 of Chapter 161, Title 8, Guam Code Annotated, is *amended*  
3 to read as follows:

4 **“§ 161.55. Violent Crimes.**

5 (a) The crimes to which this Chapter applies are the following:

6 (1) Aggravated Murder (9 GCA § 16.30);

- 1 (2) Murder (9 GCA § 16.40);
- 2 (3) Manslaughter (9 GCA § 16.50);
- 3 (4) Aggravated Assault (9 GCA § 19.20);
- 4 (5) Assault (9 GCA § 19.30);
- 5 (6) Kidnapping (9 GCA § 22.20);
- 6 (7) Felonious Restraints (9 GCA § 22.30);
- 7 (8) Child Stealing (9 GCA § 22.40);
- 8 (9) Custodial Interference (9 GCA § 22.50);
- 9 (10) Criminal Sexual Conduct in the First Degree (9 GCA § 25.15);
- 10 (11) Criminal Sexual Conduct in the Second Degree (9 GCA §
- 11 25.20);
- 12 (12) Criminal Sexual Conduct in the Third Degree (9 GCA §
- 13 25.25);
- 14 (13) Criminal Sexual Conduct in the Fourth Degree (9 GCA §
- 15 25.30);
- 16 (14) Assault with Intent to Commit Criminal Sexual Conduct (9
- 17 GCA § 25.35);
- 18 (15) Driving While Impaired (9 GCA § 92102);
- 19 (16) Driving While Impaired With Child On Board: Felony
- 20 Punishment (9 GCA § 92109), provided a child under the age of sixteen
- 21 (16) was injured as a result of an accident in which the vehicle operated by
- 22 the person charged with the above violation was involved;
- 23 (17) Vehicular Negligence: Bodily Injuries (9 GCA § 92108);
- 24 (18) Vehicular Homicide While Driving Impaired: Felony
- 25 Punishment (9 GCA § 92111);
- 26 (19) Drinking While Driving a Motor Vehicle: Misdemeanor:
- 27 Punishment (9 GCA § 92112);

1 (20) Stalking (9 GCA § 19.70);

2 (21) Family Violence (Third Degree Felony and Misdemeanor) and  
3 Violation of a Court Order (Misdemeanor) (9 GCA Chapter 30);

4 (22) Solicitation of Children and Child Pornography (9 GCA  
5 Chapter 25A);

6 (23) Robbery (9 GCA Chapter 40);

7 (24) Aggravated Arson and Arson (9 GCA §§ 34.20 and 34.30);

8 (25) Home Invasion (9 GCA §§ 37.210 and 37.220); and

9 (26) Carjacking (9 GCA §§ 37.310, 37.320, and 37.330).

10 (b) For the purpose of this Chapter, the operation of a motor vehicle,  
11 boat, or aircraft that results in an injury or death *shall not* constitute a crime,  
12 unless the injuries were intentionally inflicted through the use of such vehicle,  
13 boat, or aircraft or unless the conduct constitutes a violation of 9 GCA § 92101, et  
14 seq. (The Safe Streets Act).

15 (c) Any fine imposed pursuant to 9 GCA § 80.50 of for conviction of  
16 any crimes specified in Subsections (a)(1) through (14) and (20) through (26) of  
17 this Section *shall* be paid into the Criminal Injuries Compensation Fund  
18 established by § 161.90 of this Chapter.”
