

# 1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that the Guam Housing and Urban Renewal Authority (GHURA) developed Tract
- 4 240 in the Machanao area in the municipality of Dededo.

I Liheslaturan Guåhan further finds that Lot 31, Block 2, Tract 240, municipality of Dededo, is a six point zero nine six meter (6.096m) designated easement created to provide access to adjacent Lots 14, 16, and 27 of the Tract 240 Subdivision Master Plan developed by GHURA. Lots 14, 16, and 27 have been subsequently consolidated to become Lot 27NEW, Block 2, Tract 240 under one (1)


I Liheslaturan Guåhan further finds that the sale of Lot 31, Block 2, Tract 240, municipality of Dededo, if consolidated with contiguous lots, will become developable and taxable property, thus increasing the Real Property Tax Base for the government of Guam. The sale will also benefit the Chamorro Land Trust Commission as the sale proceeds will go to the Chamorro Land Trust Survey and Infrastructure Fund.

Authorization to Sell Government Land. I Mina'Trentai 13 Section 2. Kuåttro Na Liheslaturan Guåhan hereby authorizes I Maga'låhen Guåhan to sell 14 Lot 31, Block 2, Tract 240, municipality of Dededo, as said lot is described in that 15 Consolidation of Lots 10124-1, 10124-2, and 10124-R3 into Tract 240, and 16 Subdivision Survey Map of Tract 240, Department of Land Management Map 17 Number 377FY92, recorded under Instrument No. 482808 attached as "Exhibit A." 18 19 Said Lot 31, Block 2, Tract 240, municipality of Dededo, consists of approximately two hundred seventy-four (274)  $\pm$  square meters. 20

Lot 31, Block 2, Tract 240, municipality of *Dededo*, *shall* be purchased by the landowner of adjacent Lot 27NEW, Block 2, Tract 240, municipality of *Dededo*. A consolidation survey map *shall* be prepared by the purchaser and submitted to the Department of Land Management within ninety (90) days upon the completion of the sale.

The Department of Land Management and the landowner of adjacent Lot 27 NEW, Block 2, Tract 240, municipality of *Dededo*, *shall* complete the sale.

- 1 "Exhibit B," attached to this Act, depicts the boundaries of the two hundred seventy-
- 2 four (274) ± square meter lot to be purchased by the landowner of adjacent Lot
- 3 27NEW, Block 2, Tract 240, municipality of Dededo.
- 4 Section 3. Proceeds of Sale. Funds generated from the sale of Lot 31,
- 5 Block 2, Tract 240, municipality of Dededo, shall be deposited in the Chamorro
- 6 Land Trust Survey and Infrastructure Fund, identified as Chamorro Land Trust
- 7 Revenue Account Number 3669-57001, CLT-Sale of Government Land.
- 8 Section 4. Appraisals. 2 GCA § 2107(b) relative to appraisals of land shall
- 9 apply to this Act.
- 10 Section 5. New Assessment and Update of Real Property Tax Roll. Upon
- approval and recordation of the consolidation map for Lot 31, Block 2, Tract 240,
- 12 municipality of Dededo, and Lot 27NEW, Block 2, Tract 240, municipality of
- 13 Dededo, the Real Property Division of the Department of Revenue and Taxation
- 14 shall conduct a special valuation of the consolidated lots and the new tax assessment
- shall become due and payable in the succeeding year. The Tax Roll shall be updated
- 16 accordingly.
- 17 Section 6. Severability. If any provision of this Act or its application to any
- person or circumstance is found to be invalid or contrary to law, that invalidity shall
- 19 not affect other provisions or applications of this Act that can be given effect without
- 20 the invalid provisions or applications, and to this end the provisions of this Act are
- 21 severable.
