3	Liheslaturan Guåhan finds that during and after World War II and the subsequent
4	transformation and creation of NEW AGAÑA, numerous substandard Old Agaña
5	fractional lots, as well as abandoned easements, were the side effects of the
6	development of Hagåtña into the present day vibrant city. These numerous
7	substandard Old Agaña fractional lots are only useable to contiguous larger
8	landowners for consolidation purposes into a bigger and more useful standard lot.
9	Therfore, it is the intent of I Mina'Trentai Kuåttro Na Liheslaturan Guåhan
10	to authorize the subsequent consolidation of the additional square meters that will
11	create a larger lot, therefore increasing the real property tax base.
