

AN ACT TO AMEND SECTION 1(0)(4) OF CHAPTER V OF PUBLIC LAW 34-116, RELATIVE TO THE FISCAL YEAR 2019 APPROPRIATION FOR CONSERVATION OFFICERS OF THE DEPARTMENT OF AGRICULTURE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that the Department of Agriculture was appropriated an operating budget of Four
- 4 Million Twenty-five Thousand Three Hundred Twenty-three Dollars (\$4,025,323)
- 5 pursuant to Public Law 34-116. Of that amount, a total of Seven Hundred Forty

Thousand Four Hundred Forty-seven Dollars (\$740,447) was appropriated for 1

2 Conservation Officers.

3 I Liheslaturan Guåhan further finds that the Conservation Officers section of the Department of Agriculture sought to purchase new vehicles and upgrade their 4 current arms room; however, representatives of the Department of Agriculture were 5 6 informed by the Bureau of Budget and Management Research that those respective expenses are categorized as "capital improvements" and not authorized under Public 7

- Therefore, it is the intent of I Liheslaturan Guåhan amend language contained in Public Law 34-116 to authorize the Conservation Officers section of the Department of Agriculture to use their Fiscal Year 2019 budget appropriations for capital outlay and capital improvement expenses. 12
- 13 Section 1(o)(4) of Chapter V of Public Law 34-116 is hereby Section 2. 14 amended to read:
 - Conservation Officers. The sum of Six Hundred Twenty-two "(4) Thousand Thirty-nine Dollars (\$622,039) shall be allocated for the purpose of personnel and the sum of One Hundred Eighteen Thousand Four Hundred Eight Dollars (\$118,408) shall be allocated for operational, capital outlay, capital improvement, and equipment costs from the Fiscal Year 2019 General Fund appropriation in Subsection (o)(1) for the Conservation Officers in Fiscal Year 2019."
 - Section 3. Effective Date. This Act shall be effective upon enactment.
 - Severability. If any provision of this Act or its application to any Section 4. person or circumstance is found to be invalid or contrary to law, such invalidity shall not affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
