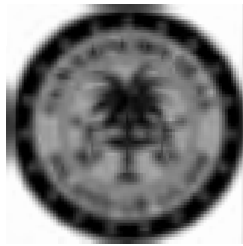





**AN ACT TO *ADD* A NEW ARTICLE 10 TO CHAPTER 18  
OF TITLE 22, GUAM CODE ANNOTATED, AND TO *ADD*  
A NEW § 181001 TO THE SAME, RELATIVE TO HEALTH  
INSURANCE COVERAGE FOR PROSTATE AND  
CERVICAL CANCER SCREENING.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** A new Article 10 is *added* to Chapter 18 of Title 22, Guam Code  
3 Annotated, to read:

4 **“ARTICLE 10**

1                   **HEALTH INSURANCE COVERAGE; SCREENINGS”**

2           **Section 2.** A new § 181001 is *added* to Article 10 of Chapter 18, Title 22,  
3 Guam Code Annotated, to read as follows:

4           **“§ 181001. Coverage for Prostate and Cervical Cancer Detection.**

5           (a) Except for a fraternal benefit society, a health care insurer that  
6 offers, issues for delivery, delivers, or renews in Guam, a health care insurance  
7 plan, *shall* provide coverage for the costs of prostate cancer screening tests as  
8 required under the schedule described in Subsection (b) of this Section, and  
9 *shall* provide coverage for the costs of cervical cancer screening tests as  
10 required under the schedule described in Subsection (c) of this Section. The  
11 coverage required by this Section is subject to standard policy provisions  
12 applicable to other benefits, including deductible or copayment provisions.

13           (b) The minimum coverage required under Subsection (a) of this  
14 Section for prostate cancer screening includes an annual prostate cancer  
15 screening test, by digital rectal examination, for a person who is forty (40) or  
16 more years of age.

17           (c) The minimum coverage required under Subsection (a) of this  
18 Section for cervical cancer screening is an annual pap smear cancer screening  
19 test for a person who is twenty-one (21) or more years of age.

20           (d) The coverage described by this Section *shall* be effective in the  
21 event that the United States Preventive Services Task Force, its  
22 recommendations, or the provisions of the *Affordable Care Act* or its  
23 successor acts, should cease to require such coverage.”
