1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Funding to the Guam Department of Education.
- 3 Notwithstanding any other provision of law, the sum of One Hundred Fifty

- 4 Thousand Dollars (\$150,000) from the General Fund appropriation in Fiscal Year
- 5 2017 to I Liheslaturan Guåhan (the Guam Legislature) is hereby de-appropriated.
- 6 The sum of One Hundred Fifty Thousand Dollars (\$150,000) is hereby appropriated
- 7 from the General Fund to the Guam Department of Education (GDOE) Operations
- 8 Fund for maintenance and repairs needed at GDOE schools.
- 9 Section 2. Reporting Requirement. Within sixty (60) days of the end of
- 10 Fiscal Year 2017, the Superintendent of Education or his designee shall submit to the
- 11 Speaker of *I Liheslaturan Guåhan* a report on the maintenance and repairs at GDOE
- schools made from the utilization of funds made available by this Act.
