#### **BE IT ENACTED BY THE PEOPLE OF GUAM:**

Section 1. Legislative Findings and Intent. *I Liheslaturan Guåhan* finds
 that Lot 5-R6, Block 15, Tract 2831 in the municipality of *Talofofo* is a community-

assigned lot under the jurisdiction of the Department of Land Management (DLM),
 and said lot consists of 5,315 square meters (1.31 acres) as shown on DLM Scheme
 No. M11-S003.

*I Liheslaturan Guåhan* further finds that Lot 5, Block 15, Tract 2831,
municipality of *Talofofo* may have been subdivided to accommodate residential
deeds or leases; and, *I Liheslaturan Guåhan* intends to recognize and sanction those
pre-existing residential deeds and leases on those portions of Lot 5, Block 15, Tract
2831, municipality of *Talofofo*.

9 *I Liheslaturan Guåhan* further intends to rescind administrative jurisdiction 10 of those portions of Lot 5-R6, Block 15, Tract 2831, municipality of *Talofofo* granted 11 to the DLM that are free of any pre-existing deeds or leases, and to vest the Office 12 of the Mayor of *Talofofo* and the *Talofofo* Municipal Planning Council with 13 adminstrative jurisdiction of the same for use as a community garden.

# Section 2. Rescindment of Administrative Jurisdiction of Lot 5-R6, Block 15, Tract 2831, Municipality of *Talofofo*.

(a) Administrative jurisdiction of those portions of Lot 5-R6, Block
17 15, Tract 2831, Municipality of *Talofofo*, that have not been previously
deeded or leased, granted to the Department of Land Management, is hereby
rescinded and *shall* rest with the Office of the Mayor of *Talofofo* and the *Talofofo* Municipal Planning Council for the purpose of developing a
community garden for use by the residents of *Talofofo*.
