

AN ACT TO AMEND § 26603(e) OF ARTICLE 6, CHAPTER 26, TITLE 11, GUAM CODE ANNOTATED, RELATIVE TO PROHIBITING THE AUTHORIZATION OF ANY WITHDRAWAL OR TRANSFER OF CASH OR FUNDS FROM THE GUAM CANCER TRUST FUND FOR ANY NON-PRESCRIBED PURPOSE, AND TO MAKE SUCH ACT A MISDEMEANOR.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 Section 1. § 26603(e) of Article 6, Chapter 26, Title 11, Guam Code

3 Annotated, is hereby *amended* to read:

"(e) Creation of the Guam Cancer Trust Fund. There is hereby created the Guam Cancer Trust Fund, which *shall* be used to provide financial assistance to organizations that provide patient directed services for the prevention of cancers, its treatment, diagnosis, and other services that may be required to access treatment, including, but not limited to, off-island transportation and temporary housing. The Guam Cancer Trust Fund *shall* be subject to the following:

8 (1) Fifteen percent (15%) of the Healthy Futures Fund into the 9 Guam Cancer Trust Fund, which *shall* be held in an account at a Guam 10 financial institution separate and apart from all other accounts and 11 funds of the government of Guam and *shall not* be subject to the transfer 12 authority of *I Maga'låhen Guåhan*.

The University of Guam, for each fiscal year, may allocate (2)13 up to seventy-five percent (75%) of the Guam Cancer Trust Fund's 14 15 balance to non-profit and charitable organizations providing cancer screenings, treatment, support services, cancer education, and outreach 16 17 programs; provided, however, no more than ten percent (10%) of the available funds shall be utilized for cancer education and outreach 18programs. The University of Guam shall promulgate rules and 19 regulations pursuant to 5 GCA Chapter 9 regarding the administration 20 21of the Guam Cancer Trust Fund, as well as the application, distribution, review and investigation of such funds. Such rules and regulations shall 22 be posted on the University's website. 23

24 (A) The initial rules and regulations governing the
25 Guam Cancer Trust Fund *shall* be submitted to *I Liheslatura*26 within ninety (90) days from the effective date of this Act.

(3) The Guam Cancer Trust Fund may receive additional appropriations, contributions, endowments, or gifts in cash or otherwise from any source, including the Territory of Guam, corporations or other businesses, individuals, and interested parties.

(4) The aggregate principal sum deposited in the GuamCancer Trust Fund *shall* be invested by the University of Guam, subjectto its investment policy as established by the Board of Regents.

8 (5) No authorization for the withdrawal or transfer of cash or 9 funds *shall* be made from the Guam Cancer Trust Fund account created 10 pursuant to § 26603(e)(1) for purposes other than those enumerated in 11 § 26603(e)(2) and § 26603(e)(4), and not in accordance with the rules 12 and regulations governing the Guam Cancer Trust Fund. Any person in 13 violation of this Subsection *shall* be guilty of a misdemeanor.

14 (6) If the Guam Cancer Trust Fund is terminated, the monies
15 remaining in the Trust Fund *shall* revert to the Healthy Futures Fund.

16 (7) The President of the University of Guam *shall* submit a 17 report on a quarterly basis to the Speaker of *I Liheslaturan Guåhan* of 18 the revenues collected, gained, and expended from the Guam Cancer 19 Trust Fund, the balance sheet or equivalent thereof, and monthly bank 20 statements and bank reconciliations (if any) over the three (3) months 21 of each quarter; and, *shall* post such reports on the University's 22 website."

Section 2. Severability. If any provision of this act or its application to any person or circumstance is held invalid, the invalidity *shall not* affect other provisions or applications of this act that can be given effect without the invalid provision or application, and to this end the provisions of this act are severable.
