AN ACT TO RESCIND **ADMINISTRATIVE** JURISDICTION OF LOT 1, BLOCK 14, TRACT 2831, TALOFOFO. MUNICIPALITY **OF PREVIOUSLY** GRANTED TO THE DEPARTMENT **OF** MANAGEMENT UNDER THE LAND FOR THE LANDLESS PROGRAM, AND TO VEST ADMINISTRATIVE JURISDICTION IN THE OFFICE OF THE MAYOR OF TALOFOFO AND THE TALOFOFO MUNICIPAL **PLANNING** COUNCIL FOR THE PURPOSE OF CONSTRUCTING A RECREATIONAL SPORTS FACILITY THEREIN.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that Lot 1, Block 14, Tract 2831 in the municipality of Talofofo is a "community

- 1 assigned" lot that is currently under the jurisdiction of the Department of Land
- 2 Management, and consists of 31,026 square meters (7.7 acres) as shown on DLM
- 3 Map No. 068FY91.
- 4 I Liheslaturan Guåhan further finds that in recent years, there has been a
- 5 dramatic increase in the number of youths participating in sports programs and
- 6 leagues. The development of sports facilities in our communities contributes to the
- 7 growth, development, and well-being of our residents, and is in the best interest of
- 8 Guam. The construction of sports facilities would promote and shape the intensity
- 9 and the popularity of sports in our community and will contribute to the healthy
- 10 formation of our youth.
- It is, therefore, the intent of *I Liheslaturan Guåhan* to provide the land area
- 12 for the development of sports facilities in *Talofofo*.
- 13 Section 2. Rescindment of Administrative Jurisdiction. Administrative
- jurisdiction of the Department of Land Management relative to Lot 1, Block 14,
- 15 Tract 2831 in the municipality of *Talofofo*, consisting of 31,026 square meters (7.7
- acres) as shown on DLM Map No. 069FY91, is hereby rescinded.
- 17 Section 3. Grant of Administrative Jurisdiction. Administrative
- Jurisdiction of Lot 1, Block 14, Tract 2831 in the municipality of *Talofofo*, consisting
- of 31,026 square meters (7.7 acres) as shown on DLM Map No. 069FY91, is hereby
- 20 granted to the Office of the Mayor of *Talofofo* and the *Talofofo* Municipal Planning
- 21 Council for the *sole* purpose of developing a sports facility.
- Section 4. Use and Access to Property. The Office of the Mayor of
- 23 Talofofo or the Talofofo Municipal Planning Council shall adopt rules and
- 24 regulations pursuant to the Administrative Adjudication Law that govern the use and
- access to the sports facility authorized by this Act.
- Section 5. Legislative Review and Concurrence. Notwithstanding any
- other provision of law, Lot 1, Block 14, Tract 2831, municipality of Talofofo,

- 1 consisting of 31,026 square meters (7.7 acres) as shown on DLM Map No. 069FY91
- 2 shall not be sold, leased, subleased, licensed, exchanged, or otherwise transferred,
- 3 without the prior approval of *I Liheslatura* by duly enacted legislation.
- 4 Section 6. Reversionary Clause. In the event Lot 1, Block 14, Tract 2831,
- 5 municipality of *Talofofo*, consisting of 31,026 square meters (7.7 acres) as shown on
- 6 DLM Map No. 069FY91 is not developed and utilized as envisioned herein within
- 7 ten (10) years of the enactment of this Act, said lot shall be transferred to the
- 8 Chamorro Land Trust Commission lands inventory.
- 9 Section 7. Storm Management. The Office of the Mayor of Talofofo, the
- 10 Talofofo Municipal Planning Council, and all relevant agencies shall ensure that
- 11 proper storm management is designed into the sports facility for water quality,
- 12 recharge, and storage requirements, and to prevent runoff from affecting the street
- on the east boundary, which is the lowest point on Lot 1, Block 14, Tract 2831,
- municipality of *Talofofo*, consisting of 31,026 square meters (7.7 acres) as shown on
- 15 DLM Map No. 069FY91.
- 16 Section 8. Severability. If any provision of this Act or its application to
- any person or circumstance is found to be invalid or contrary to law, that invalidity
- 18 shall not affect other provisions or applications of this Act that can be given effect
- without the invalid provisions or applications and to this end the provisions of this
- 20 Act are severable.
