



AN ACT TO TRANSFER TITLE OF OWNERSHIP OF LOT NO. 7054-1 IN THE MUNICIPALITY OF YIGO RESERVED FOR THE DEPARTMENT OF PUBLIC **LAND** THE **CHAMORRO** TRUST WORKS TO TO TRANSFER **COMMISSION**; AND ADMINISTRATIVE JURISDICTION OF LOT NO. 7054-4 IN THE MUNICIPALITY OF YIGO RESERVED FOR THE **GUAM** THE **POLICE** DEPARTMENT TO DEPARTMENT OF PUBLIC WORKS.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that Public Law 22-18 (enacted in 1993) reserved Lot No. 7054-4 in the municipality
- 4 of Yigo, consisting of three and a half (3.5) acres, for the Guam Police Department

- 1 (GPD) to construct a Sagan Policia within said lot. In addition, Public Law 22-18
- 2 reserved Lot No. 7054-1, consisting of two (2) acres, for the Department of Public
- 3 Works (DPW) to construct a Satellite Bus Station.

- 4 I Liheslaturan Guåhan further finds that DPW currently maintains and
- 5 operates a Satellite Bus Station on a portion of Lot No. 7054-4, which was originally
- 6 reserved for GPD. Recent public hearings have now indicated that GPD is no longer
- 7 in need of Lot No.-7054-1 and that a substitute and more desirous site has been found
- 8 for GPD's specific needs. DPW is also no longer in need of Lot No. 7054-1 as DPW
- 9 has constructed an existing Satellite Bus Station on Lot No. 7054-4.
- 10 Section 2. Transfer of Title of Ownership and Administrative
- 11 Jurisdiction. Notwithstanding the Government of Guam Reserved Lands List
- adopted in Public Law 22-18, the following land reservations *shall* be made:
- 13 (a) Title of Ownership of Lot No. 7054-1, municipality of Yigo,
- 14 consisting of approximately two (2) acres, is hereby transferred to the
- 15 Chamorro Land Trust Commission for its use as it so determines.
- 16 (b) Administrative Jurisdiction of Lot No. 7054-4, municipality of
- 17 Yigo, consisting of three and a half (3.5) acres, presently used by the
- Department of Public Works (DPW) as a satellite bus station, is hereby
- transferred to DPW.
- Section 3. Exemption. § 2107 of Chapter 2, Title 2, Guam Code
- 21 Annotated, and the Standing Rules of I Mina'Trentai Kuåttro Na Liheslaturan
- 22 Guåhan relative to the appraisals of land, shall not apply to this Act.
- Section 4. Severability. If any provision of this Act or its application to
- 24 any person or circumstance is found to be invalid or contrary to law, such invalidity
- 25 shall not affect other provisions or applications of this Act that can be given effect
- 26 without the invalid provisions or applications, and to this end the provisions of this
- 27 Act are severable.
