

**AN ACT TO RESCIND ADMINISTRATIVE  
JURISDICTION OF LOT NO. 5173-NEW-2-R2, KNOWN  
AS THE *TAMUNING* MULTI-PURPOSE FIELD,  
GRANTED TO THE *CHAMORRO* LAND TRUST  
COMMISSION, AND TO VEST THE OFFICE OF THE  
*TAMUNING-TUMON-HARMON* MAYOR WITH  
ADMINISTRATIVE JURISIDICION OF THE SAME.**

- 1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**  
2 **Section 1. Grant of Administrative Jurisdiction of Lot No. 5173-NEW-**  
3 **2-R2 from the *Chamorro* Land Trust Commission to the Office of the**

1 **Tamuning-Tumon-Harmon Mayor.** Notwithstanding any other provision of law,  
2 rule or regulation, *I Liheslaturan Guåhan* authorizes *I Maga'låhen Guåhan* to  
3 rescind administrative jurisdiction of Lot No. 5173-NEW-2-R2, as depicted on the  
4 Department of Land Management Map DLM Check No. 014 FY 92, from the  
5 *Chamorro* Land Trust Commission. Administrative jurisdiction of said lot *shall* vest  
6 with the Office of the *Tamuning-Tumon-Harmon* Mayor for the *sole* purpose of  
7 establishing sports or recreational facilities.

8 **Section 2. Legislative Review and Concurrence.** Notwithstanding any  
9 other provision of law, Lot No. 5173-NEW-2-R2 *shall not* be sold, leased, subleased,  
10 licensed, exchanged, or otherwise transferred without the prior approval of *I*  
11 *Liheslaturan Guåhan* by duly enacted legislation.

12 **Section 3. Reversionary Clause.** In the event Lot No. 5173-NEW-2-R2 is  
13 not used to provide facilities and services for community recreational activities and  
14 sports organizations without good cause, administrative jurisdiction of Lot No.  
15 5173-NEW-2-R2 *shall* revert to the *Chamorro* Land Trust Commission.

16 **Section 4. Use and Access to Sports or Recreational Facilities.** The  
17 Office of the Mayor of *Tamuning-Tumon-Harmon* *shall* adopt rules and regulations  
18 pursuant to the Administrative Adjudication Law that govern the use and access to  
19 the sports or recreational facilities authorized by this Act.
