





AN ACT TO DE-APPROPRIATE THE SUM OF ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150,000) FROM THE GENERAL FUND APROPRIATION IN FISCAL YEAR 2017 TO *I LIHESLATURAN GUÁHAN* (THE GUAM LEGISLATURE) AND TO APPROPRIATE SUCH SUM TO THE GUAM DEPARTMENT OF EDUCATION (GDOE) OPERATIONS FUND FOR MAINTENANCE AND REPAIRS NEEDED AT GDOE SCHOOLS.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Funding to the Guam Department of Education.**

3 Notwithstanding any other provision of law, the sum of One Hundred Fifty

4 Thousand Dollars (\$150,000) from the General Fund appropriation in Fiscal Year
5 2017 to *I Liheslaturan Guåhan* (the Guam Legislature) is hereby de-appropriated.
6 The sum of One Hundred Fifty Thousand Dollars (\$150,000) is hereby appropriated
7 from the General Fund to the Guam Department of Education (GDOE) Operations
8 Fund for maintenance and repairs needed at GDOE schools.

9 **Section 2. Reporting Requirement.** Within sixty (60) days of the end of
10 Fiscal Year 2017, the Superintendent of Education or his designee *shall* submit to the
11 Speaker of *I Liheslaturan Guåhan* a report on the maintenance and repairs at GDOE
12 schools made from the utilization of funds made available by this Act.
