





**AN ACT TO *AMEND* SECTION 11 OF CHAPTER XI,
PUBLIC LAW 33-185, RELATIVE TO EXPEDITOUSLY
PRODUCING SPECIAL RECOGNITION VETERANS
LICENSE PLATES.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that since the establishment of the special recognition veterans license plate for
4 veterans who reside on Guam who are recipients of a military award for acts of valor
5 (Medal of Honor, Distinguished Service Cross, Navy Cross, Air Force Cross, Silver
6 Star, Bronze Star w/"V" device, or Purple Heart), the Department of Revenue and

1 Taxation, the Guam Veterans Affairs Office, the Guam Veterans Commission, and
2 other stakeholders have been working tirelessly to finalize a license plate template
3 that truly provides honor and recognition to our distinguished veterans. Through the
4 hard work of the Department Revenue and Taxation Motor Vehicle Division staff,
5 the cost for the development of the different special recognition designs has been
6 kept to a minimum and under the initial Five Thousand Dollars (\$5,000)
7 appropriated. It is, therefore, the intent of *I Liheslaturan Guåhan* to utilize the
8 remaining balance to fund the initial production of special recognition veterans
9 license plates for our veterans.

10 **Section 2.** Section 11 of Chapter XI, Public Law 33-185, is *amended* to
11 read:

12 **“Section 11. Appropriation to the Department of Revenue and**
13 **Taxation for the Special Recognition Veterans License Plate.**
14 Notwithstanding any other provision of law, the sum of Five Thousand
15 Dollars (\$5,000) is hereby appropriated from the Fiscal Year 2017 Tourist
16 Attraction Fund to the Department of Revenue and Taxation, Motor Vehicle
17 Division, for the purposes of funding a template and production for the special
18 recognition veterans license plate authorized in § 7120.5 of Chapter 7, Title
19 16, GCA. After all of the special recognition veterans license plate templates
20 have been completed and funded, all of the remaining balance *shall* be used
21 for the production and delivery of license plates. The first batch to be produced
22 *shall* be pursuant to the registration list approved by the Guam Veterans
23 Affairs Office. In the event a non-profit organization, such as the *Military*
24 *Order of the Purple Heart*, offers to fund the template and production of the
25 Purple Heart license plate, the Department of Revenue and Taxation may
26 accept such offer to offset production costs. Should such an offer occur, a
27 Memorandum of Agreement (MOA) *shall* be executed by an official

1 representative of a non-profit organization and the Director of the Department
2 of Revenue and Taxation clearly indicating the terms and conditions of such
3 offer.”

4 **Section 3. Additional Funding Requirement.** Upon the initial order and
5 production of special recognition veterans license plates utilizing the funding source
6 per Section 2 of this Act, the Director of the Department of Revenue and Taxation
7 *shall* immediately submit a request to *I Liheslaturan Guåhan* for the additional
8 amount needed to produce the remaining special recognition veterans license plates,
9 which *shall* be included as an additional amount to the Department’s FY 2018 annual
10 budget request.

11 **Section 4. Effective Date.** This Act *shall* be effective upon enactment.
