**AN ACT TO AMEND § 18117(a)(2)(A); AND TO ADD A
NEW § 18120.1; AND TO AMEND § 18123(a); AND TO
ADD A NEW § 18128.6(c), ALL OF CHAPTER 18, TITLE
10, GUAM CODE ANNOTATED, RELATIVE TO
AMENDING THE BARBERING AND COSMETOLOGY
ACT.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guáhan* finds
3 that safety and proper barbering and cosmetology practices should be held to the
4 greatest standards to ensure that the products and practices in this profession are
5 performed in a manner that is not detrimental to the health and safety of our people.

1 New practices found nationwide and possibly in Guam have been found to be
2 conducted without authorization by public law and may violate the very health and
3 safety these laws are meant to protect. Additionally, *I Liheslaturan Guåhan* further
4 finds that in order to maintain standards with national requirements, Guam must
5 enhance requirements to fulfill reciprocity regulations that will provide for
6 opportunities for barbering and cosmetology professionals.

7 **Section 2.** § 18117(a)(2)(A) of Chapter 18, Title 10, Guam Code Annotated,
8 is hereby *amended* to read:

9 **“§ 18117. Eligibility and Qualifications for Manicurist License.**

10 (a) The Board *shall* administer examinations for a license as a
11 manicurist during a Board meeting duly held for the purpose of administering
12 examinations for applicants who have made the proper applications for such
13 license and who have qualified as follows:

14 (2) who has had one (1) of the following:

15 (A) completed a certified manicure program of *at least*
16 four hundred (400) hours extending over a school year of *not less*
17 *than* four (4) months in nail care from a school approved by the
18 Board;”

19 **Section 3.** A new § 18120.1 is hereby *added* to Chapter 18 of Title 10,
20 Guam Code Annotated, to read:

21 **“§ 18120.1. Guest Educator.**

22 (a) A Guest Educator may provide instruction with the supervision
23 of the instructor of record, and is responsible for performing teaching-related
24 duties to assist faculty members of the school of cosmetology. Duties may
25 include preparation of instructional materials, proctoring of exams, grading
26 tests, and recording of grades in a grade book. Guest Educators *shall* meet the
27 following qualifications:

1 (1) specialized competency in the fields of cosmetology, nail
2 technology, esthetics, or barbering, with at least one (1) year of
3 experience with license specialty; and

4 (2) certification in the field of instruction with at least three
5 (3) years of experience in the field of instruction in a post-secondary
6 school, or a Master's degree.”

7 **Section 4.** § 18123(a) of Chapter 18, Title 10, Guam Code Annotated, is
8 hereby *amended* to read:

9 **“§ 18123. Universal Precautions.**

10 (a) The Board *shall* promulgate rules and regulations in accordance
11 with the Administrative Adjudication Law within one hundred eighty (180)
12 days upon the enactment of this Act to address universal precautions
13 guidelines, which *shall* include, but *not* be limited to:

14 (1) cleanliness and sanitation of towels and/or linens;

15 (2) disinfecting requirements and standards of any articles,
16 tools (electrical and non-electrical), implements and equipment in
17 contact with a client;

18 (3) prevention of contamination of any materials and/or
19 solutions in contact with a client;

20 (4) proper storage of tools and implements;

21 (5) cleanliness of floor surfaces, walls and ceilings;

22 (6) general proper hygiene (i.e. properly washing hands,
23 proper use of gloves); and

24 (7) prohibited products and practices. The use of any product,
25 preparation or procedure that comes in contact with or penetrates the
26 dermis layer of the skin.”

1 **Section 5.** A new § 18128.6(c) is hereby *added* to Chapter 18 of Title 10,
2 Guam Code Annotated, to read:

3 “**§ 18128.6. Prohibited Instruments.**

4 (c) No establishment or school *shall* have on the premises any
5 micro-thin blade or blades or instrument of the like, which is used to perform
6 tattoo services or other similar procedures, except as further provided herein,
7 until such time as the Board promulgates rules and regulations pursuant to §
8 18123 of this Chapter relative to the use of these blades or instruments.”


9 **Section 6. Severability.** If any provision of this Act or its application to
10 any person or circumstance is found to be invalid, or contrary to law, such invalidity
11 *shall not* affect other provisions or applications of this Act that can be given effect
12 without the invalid provision or application, and to this end the provisions of this
13 Act are severable.

14 **Section 7. Effective Date.** This Act *shall* become effective upon
15 enactment.


