

Re: Substitute Bill No. 206-35 (COR) -An Act to Add a New § 25A204 to Article 2 of Chapter 25A, Title 9, Guam Code Annotated, Relative to Establishing the Offense of Production of Child Pornography as a First Degree Felony

Dear Madame Speaker:

The existing statutory scheme protecting Guam's children from sexual exploitation prohibits the possession or dissemination of child pornography. Substitute Bill 206-35, now known as *Public Law No. 35-122*, further protects minors by criminalizing the production of child pornography, and identifying such crime as a first degree felony. The behavior proscribed by this law harms our children, and this measure furthers our efforts as a community to ensure that our youth is safe from the substantial and long-term physical, emotional and mental trauma caused by such sexual exploitation, particularly when such behavior is memorialized in film and images and distributed. It is my hope that this law serves as an important deterrent to such conduct, and appropriately punishes those who engage in it.

AN ACT TO *ADD* A NEW § 25A204 TO ARTICLE 2 OF CHAPTER 25A, TITLE 9, GUAM CODE ANNOTATED, RELATIVE TO ESTABLISHING THE OFFENSE OF PRODUCTION OF CHILD PORNOGRAPHY AS A FIRST DEGREE FELONY.

- 1 BE IT ENACTED BY THE PEOPLE OF GUAM:
- 2 Section 1. A new § 25A204 is added to Article 2 of Chapter 25A, Title 9,
- 3 Guam Code Annotated, to read as follows:
- 4 "§ 25A204. Production of Child Pornography.

- A person commits the offense of production of child 1 (a) pornography if, knowing or having reason to know its character and content, 2 3 the person produces, manufactures, reproduces, copies, photographs, films, videotapes, video captures, creates, directs, promotes, advertises, publishes, 4 5 issues, or presents to show any visual depiction of child pornography as 6 defined in § 25A201 of this Chapter, or any pornographic material where: the production of such visual depiction involves the use of 7 (1)8 a minor engaging in sexual conduct; 9 such visual depiction is a digital image, computer image, (2)10 or computer-generated image that is, or is indistinguishable from, that of a minor engaging in sexual conduct; 11 such visual depiction has been created, adapted, or 12 (3) modified to appear that an identifiable minor is engaging in sexual 13 14 conduct: there is visual material containing the lewd or lascivious 15 (4) 16 display of a minor's intimate area underneath clothing or sexual 17 conduct of a minor; or there is visual material containing the display of a minor's 18 19 intimate area underneath clothing that is prohibited under 9 GCA § 70.35. 20 21 The fact that a person engaged in the conduct specified by this 22 Section is prima facie evidence that the defendant had knowledge of the 23 character and content of the material. The fact that the person who was employed, used, or otherwise contained in the pornographic material was, at 24 25 that time, a minor is prima facie evidence that the defendant knew the person
