AN ACT TO AMEND § 4302(c)(1)(D) AND (E) OF ARTICLE 3, CHAPTER 4, TITLE 4, GUAM CODE ANNOTATED, RELATIVE TO THE COMPOSITION OF THE GOVERNMENT OF GUAM HEALTH INSURANCE NEGOTIATING TEAM.

#### BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. § 4302(c)(1)(D) and (E) of Article 3, Chapter 4, Title 4, Guam
- 3 Code Annotated, are amended to read:

"(D) an employee representative from the Judicial Branch to be appointed by the Chief Justice of the Supreme Court of Guam. Should the Judicial Branch decide to enter into a health insurance contract separate from the Executive Branch as authorized in 4 GCA § 4301(c), an employee representative from the Executive Branch shall be appointed by *I Maga'hågan Guåhan* to replace the employee representative from the Judicial Branch on the Government of Guam Health Insurance Negotiating Team for the applicable fiscal year;

.....

- (E) an employee representative of the Legislative Branch to be appointed by the Speaker of *I Liheslaturan Guåhan*. Should the Legislative Branch decide to enter into a health insurance contract separate from the Executive Branch as authorized in 4 GCA § 4301(c), an employee representative from the Executive Branch shall be appointed by *I Maga'hågan Guåhan* to replace the employee representative of the Legislative Branch on the Government of Guam Health Insurance Negotiating Team for the applicable fiscal year;"
- **Section 2. Severability.** If any provision of this Act or its application to any person or circumstance is found to be invalid or contrary to law, such invalidity *shall not* affect other provisions or applications of this Act that can be given effect without the invalid provision or application, and to this end the provisions of this Act are severable.
