





AN ACT TO *AMEND* § 3133(b)(5) OF ARTICLE 1, CHAPTER 3, TITLE 17, GUAM CODE ANNOTATED, RELATIVE TO REMOVING THE IMPOSITION OF FINES FOR MEMBERS WHO ATTEND GUAM DEPARTMENT OF EDUCATION FINANCIAL SUPERVISORY COMMISSION MEETINGS.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that each member of the Guam Department of Education Financial Supervisory
4 Commission (EFSC) is fined Two Hundred Fifty Dollars (\$250) in any month the
5 Commission fails to meet.

1 It is the intent of *I Liheslaturan Guåhan* to clarify that the Two Hundred Fifty
2 Dollar (\$250) fine *shall only* apply to voting members not in attendance at an EFSC
3 meeting when such absence results in a lack of quorum.

4 **Section 2.** § 3133(b)(5) of Article 1, Chapter 3, Title 17, Guam Code
5 Annotated, is *amended* to read:

6 “(5) Failure of the EFSC to meet in any month *shall* result in a Two
7 Hundred Fifty Dollar (\$250) fine for each voting member absent from an
8 EFSC meeting. The fine *shall* be imposed on the absent member for every
9 meeting missed that resulted in a lack of quorum. Such fine *shall* be deposited
10 in the GDOE Interscholastic Sports Program. The fine imposed by this
11 Subitem *shall* apply to an absent member for a meeting that resulted in a lack
12 of quorum, unless the EFSC excuses such absent member pursuant to a
13 majority vote of its members at its next meeting. The reason for the absence
14 and the voting record *shall* be included in its meeting minutes and made
15 available to the public. The EFSC *shall* develop guidelines on excusing absent
16 members from meetings for unforeseen or other circumstances.”

17 **Section 3. Effective Date.** This Act *shall* be effective upon enactment.
