**AN ACT TO *AMEND* § 3115 OF ARTICLE 1, CHAPTER 3,
TITLE 5, GUAM CODE ANNOTATED; AND *AMEND* §§
77105 AND 77107(a) OF ARTICLE 1, CHAPTER 77,
TITLE 21, GUAM CODE ANNOTATED, RELATIVE TO
CLARIFYING THE APPOINTMENT PROCESS OF THE
DIRECTOR OF THE DEPARTMENT OF PARKS AND
RECREATION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 3115 of Article 1, Chapter 3, Title 5, Guam Code Annotated,
3 is hereby *amended* to read:

1 **“§ 3115. Department of Parks and Recreation.**

2 There is within the Executive Branch of the government of Guam a
3 Department of Parks and Recreation. The Director of Parks and Recreation is
4 the head of said department and is appointed by the Governor, pursuant to §
5 77107(a) of Article 1, Chapter 77, Title 21 GCA, with the consent of the
6 Legislature.”

7 **Section 2.** § 77105 of Article 1, Chapter 77, Title 21, Guam Code
8 Annotated, is hereby *amended* to read:

9 **“§ 77105. Commission: Purposes.**

10 The Commission is hereby established for the purpose of recommending to
11 the Governor the appointment or removal of the Director, and advising the Director.”

12 **Section 3.** § 77107(a) of Article 1, Chapter 77, Title 21, Guam Code
13 Annotated, is hereby *amended* to read:

14 “(a) To recommend to the Governor the appointment of the Director,
15 who shall serve at its pleasure, the affirmative vote of not less than four (4)
16 members being necessary to recommend his or her appointment or removal;”

17 **Section 4. Effective Date.** This Act shall be effective upon enactment.
