AN ACT TO APPROPRIATE UP TO THE SUM OF FOUR HUNDRED SIXTY-EIGHT THOUSAND THREE HUNDRED EIGHTEEN DOLLARS AND SEVENTY-SEVEN CENTS (\$468,318.77) FROM THE EARNINGS OF THE UOG HIGHER EDUCATION ENDOWMENT FUND, AS OF FISCAL YEAR 2019, TO THE UNIVERSITY OF GUAM FOR THE PURPOSES PURSUANT TO § 221305 OF ARTICLE 13, CHAPTER 22, TITLE 5, GUAM CODE ANNOTATED.

BE IT ENACTED BY THE PEOPLE OF GUAM:

- 2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds
- 3 that the University of Guam (UOG) is essential to developing, cultivating, and
- 4 producing educated citizens. UOG serves as a higher education institution with a
- 5 purpose of serving the people of Guam and the Micronesia/Pacific region.
- 6 I Liheslaturan Guåhan further finds that during FY 2006 and FY 2008, the
- 7 University of Guam utilized funds from the UOG Higher Education Endowment

- 1 Fund to make improvements to the RFK Public Library; and, also used the requested
- 2 funds to purchase library equipment and to modernize the necessary areas for
- 3 students, visitors and faculty.
- 4 Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate funds from
- 5 the UOG Higher Education Endowment Fund, as of Fiscal Year 2019, to the
- 6 University of Guam.
- 7 Section 2. Appropriation to the University of Guam. Up to the sum of
- 8 Four Hundred Sixty-eight Thousand Three Hundred Eighteen Dollars and Seventy-
- 9 seven Cents (\$468,318.77) is appropriated from the UOG Higher Education
- 10 Endowment Fund, as of Fiscal Year 2019, to the University of Guam for the
- purposes enumerated in § 221305 of Article 13, Chapter 22, Title 5, Guam Code
