

AN ACT TO APPROPRIATE UP TO THE SUM OF FOUR HUNDRED SIXTY-EIGHT THOUSAND THREE HUNDRED EIGHTEEN DOLLARS AND SEVENTY-SEVEN CENTS (\$468,318.77) FROM THE EARNINGS OF THE UOG HIGHER EDUCATION ENDOWMENT FUND, AS OF FISCAL YEAR 2019, TO THE UNIVERSITY OF GUAM FOR THE PURPOSES PURSUANT TO § 221305 OF ARTICLE 13, CHAPTER 22, TITLE 5, GUAM CODE ANNOTATED.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
3 that the University of Guam (UOG) is essential to developing, cultivating, and
4 producing educated citizens. UOG serves as a higher education institution with a
5 purpose of serving the people of Guam and the Micronesia/Pacific region.

6 *I Liheslaturan Guåhan* further finds that during FY 2006 and FY 2008, the
7 University of Guam utilized funds from the UOG Higher Education Endowment

1 Fund to make improvements to the RFK Public Library; and, also used the requested
2 funds to purchase library equipment and to modernize the necessary areas for
3 students, visitors and faculty.

4 Therefore, it is the intent of *I Liheslaturan Guåhan* to appropriate funds from
5 the UOG Higher Education Endowment Fund, as of Fiscal Year 2019, to the
6 University of Guam.

7 **Section 2. Appropriation to the University of Guam.** Up to the sum of
8 Four Hundred Sixty-eight Thousand Three Hundred Eighteen Dollars and Seventy-
9 seven Cents (\$468,318.77) is appropriated from the UOG Higher Education
10 Endowment Fund, as of Fiscal Year 2019, to the University of Guam for the
11 purposes enumerated in § 221305 of Article 13, Chapter 22, Title 5, Guam Code
12 Annotated.
