1 § 10100. Title. This Chapter may be cited as the Medical Malpractice Pre-
2 Screening Mandatory Arbitration Act.

3 § 10100.1 Legislative Statement. I Liheslaturan Guåhan finds that P.L. 21-
4 43, also known as the Medical Malpractice Mandatory Arbitration Act, raises the
5 costs of medical malpractice claims to prohibitive amounts. Such financial barriers
6 can prevent those who have suffered medical malpractice injuries from seeking
7 justice and reparations.

8 However, I Liheslaturan Guåhan also recognizes the unique medical climate
9 on Guam, where there has always been a shortage of medical practitioners. It is not
10 our intent to drive these numbers lower, but to find a fair and balanced solution for
11 all parties involved which prioritize patients protection.

12 The history of medical malpractice legislation on Guam is lengthy, originating
13 with Bill No. 441 in 1975, also known as the Malpractice Claims Mandatory
14 Screening and Mandatory Arbitration Act. Bill No. 441 was found unconstitutional
15 and struck down in the 1984 court case Awa v. Guam Memorial Hospital Authority,
16 finding "it impossible to construe the Act so as to give effect to its contradictory and
17 incomplete provisions." In 1991, the Committee on Health, Ecology, and Welfare
18 found that the medical malpractice problem had reached crisis levels in recent years.
19 In an effort to lower prohibitive medical malpractice insurance premiums, Bill No.
20 325 was introduced by the 21st Guam Legislature, which then became the Medical
21 Malpractice Mandatory Arbitration Act that stands today.

22 The goal of any legislation addressing medical malpractice claims should be
23 as follows: (1) to prevent the filing in court of actions against healthcare providers
24 for liability in situations where the facts do not permit a reasonable judgement of
25 malpractice; and (2) to make fair and impartial the proceeding of such claims that
26 are, or reasonably may be, well-founded.

27 It is, therefore, the intent of I Liheslaturan Guåhan to enact such legislation.

1 **§ 10101. Definitions.** For the purposes of As used in this chapter:

2 (a) *Arbitration* means any arbitration pursuant to the Guam
3 International Arbitration Law (Chapter 42A, Division 3, Title 7, of the Guam
4 Code Annotated).

5 (b) *Arbitral tribunal* means a sole arbitrator, or a panel of arbitrators
6 selected pursuant to the Guam International Arbitration Law.

7 (c) *Claimant* means the patient, his relatives, his heirs-at-law or
8 personal representative pursuing a claim, or any third party or other party
9 pursuing a claim against a health professional or healthcare provider.

10 (d) *Defendant* means the health professional or healthcare provider
11 defending a claim pursuant to this Chapter filed by a claimant.

12 ~~(a) Association means the American Arbitration Association or other~~
13 ~~entity organized to arbitrate disputes pursuant to this Chapter.~~

14 ~~(eb)~~ Health professional or healthcare provider means any person
15 licensed or certified to practice the healing arts within the territory of Guam.

16 ~~(c) Health care institution means any health care facility, health~~
17 ~~maintenance organization or independent practice association operated~~
18 ~~primarily to provide medical services.~~

19 ~~(fd)~~ *Malpractice* means any tort or breach of contract based on health
20 care or professional services rendered or which should have been rendered by
21 a health professional or a health care institution to a patient.

22 (g) *Informed Consent* is defined pursuant to the provision of § 11104,
23 § 11105, § 11106, and § 11107 of Chapter 11, Title 10, Guam Code
24 Annotated.

25 ~~(e) Petitioner means the patient, his relatives, his heirs-at-law or~~
26 ~~personal representative pursuing a claim in arbitration, or any third party or~~

1 ~~other party pursuing a claim in arbitration, against a health professional or~~
2 ~~health care provider.~~

3 ~~(f) Respondent means the health professional or health care provider~~
4 ~~defending a claim in arbitration filed by a petitioner.~~

5 **§ 10102. Mandatory Medical Malpractice Pre-Screening Arbitration.**

6 Any claim for damages for personal injury or death on account of alleged medical
7 malpractice of a healthcare provider that accrues or is being pursued in the territory
8 of Guam, whether in tort, contract, or otherwise, shall be submitted to mandatory
9 Malpractice Pre-Screening ~~arbitration~~ pursuant to the terms of this Chapter if it is a
10 controversy between the patient, his relatives, his heirs-at-law or personal
11 representative or any third party or other party, and the health professional or health
12 care institution, or their employees or agents, and is based on malpractice, tort,
13 contract, strict liability, or any other alleged violation of a legal duty incident to the
14 acts of the health professional or health care institution, or incident to services
15 rendered or to be rendered by the health professional or health care institution.

16 **§ 10103. Initiation of Complaint and Pre-Screening Arbitration.**

17 ~~Arbitration~~ A claim is initiated by a claimant or claimants' ~~petitioner or petitioners~~
18 filing a Pre-Screening Complaint in the Superior Court of Guam and serving Pre-
19 Screening Complaint ~~a written demand for arbitration~~ upon a ~~respondent or~~
20 ~~respondents~~ defendant or defendants in the same manner provided by law for the
21 service of summons in the Superior Court of Guam; except that the petitioner or his
22 agent may serve the Complaint ~~demand~~ without the necessity of it being served by
23 a Marshal of the Superior Court of Guam. The Complaint ~~demand for arbitration~~
24 shall ~~not~~ be filed in the Superior Court of Guam, ~~and arbitration shall not be filed in~~
25 ~~the Superior Court of Guam, unless~~ including when the claimant or claimants'
26 ~~petitioner or petitioners~~ require the appointment of a Guardian Ad Litem, as
27 provided for in § 10113 of this Chapter. ~~The demand for arbitration shall be filed~~

1 ~~with the Association. The Pre-Screening Complaint demand for arbitration shall~~
2 ~~state the name and address of the claimant or claimants' petitioner or petitioners,~~
3 ~~identify the defendant or defendants' respondent or respondents, and shall outline~~
4 ~~the factual basis of the claim and the alleged acts of negligence or wrongdoing of~~
5 ~~the defendant or defendants' respondent or respondents.~~

6 **§ 10104. Response to Demand.** Within twenty (20) days after service of a
7 Pre-Screening Complaint pursuant to this chapter ~~demand for arbitration~~, the
8 ~~respondent or respondents~~ defendant or defendants shall file an response Answer to
9 the Pre-Screening Complaint pursuant to this chapter ~~demand for arbitration~~ and
10 serve it upon the claimant or claimants' ~~petitioner or petitioners~~, or their attorney.
11 The response shall identify any defenses then known to the defendant or defendants'
12 ~~respondent or respondents~~. If a defendant ~~respondent~~ fails to file a response, then the
13 claimant or claimants' ~~petitioner or petitioners~~ may proceed in default to Pre-
14 Screening ~~appoint an arbitration panel pursuant to § 10108 of this Chapter.~~

15 **§ 10105. Applicability of Statute of Limitations.** A claim shall be waived
16 and forever barred as against a respondent if on the date the Pre-Screening Complaint
17 ~~demand~~ is served the applicable statute of limitations would bar the claim.

18 **§ 10106. Standard of Care.** The prevailing standard of duty, practice, or care
19 by a reasonable physician in the same field practicing medicine in the community at
20 the time of the alleged malpractice shall be the standard applied in the Pre-Screening,
21 arbitration, and trial.

22 **§ 10107. Medical Malpractice Pre-Screening Administration—of**
23 **Arbitration.** ~~The Association shall administer a proceeding filed under this Chapter.~~
24 ~~The administrative expense shall be as agreed to by the parties and the Association,~~
25 ~~or as may be provided by the Association. The administrative costs shall be equally~~
26 ~~shared by the parties subject to an award of costs by the panel as provided in § 10130~~
27 ~~herein.~~

1 (a) Prior to the filing for a Medical Malpractice Pre-Screening, a claimant
2 shall provide no less than a forty-five (45) day notification to a Healthcare Provider
3 for whom a complaint of medical malpractice is claimed against, of his or her intent
4 to file for a Pre-Screening.

5 (b) Nothing herein shall prohibit a healthcare provider from exercising his or
6 her right to expressions of sympathy or benevolence relating to the pain, suffering,
7 or death of a patient involved in the incident with the health professional, to the
8 patient or the family of the patient, which is inadmissible as evidence of an admission
9 of liability in any civil action or any arbitration proceedings pursuant to the Medical
10 Malpractice Reform Act of 1975 codified in §11112 of Chapter 11, Title 10, Guam
11 Code Annotated.

12 (c) Immediately following receipt of a Pre-Screening Complaint pursuant to
13 this Chapter, the Superior Court of Guam, shall seal the case and refer the matter to
14 a Judge for Pre-Screening.

15 (d) A Pre-Screening shall be conducted promptly upon notice in writing to all
16 parties and their counsel. The Pre- Screening shall be held *in camera*. Pre-Screening
17 shall examine, but not be limited to the following:

18 (1) Testimony of witnesses which may be taken remotely by telephone,
19 videoconference, or any other electronic means.

20 (2) Any findings of fact and decisions made by Guam health licensing
21 boards on the same subject of the complaint.

22 (3) Expert witness affidavits submitted by both claimant and defendant
23 from a medical professional in the same or similar field, licensed to
24 practice on Guam or any other U.S. jurisdictions, that attest to whether
25 or not there may be a breach in the standard of care pursuant to § 10104
26 of this chapter.

1 (4) Any records for examination to determine whether the defendant
2 acquired informed consent from the claimant prior to and during
3 treatment pursuant to the provisions of § 11104, § 11105, §11106, and
4 § 11107 of Chapter 11, Title 10, Guam Code Annotated.

5 (e) Upon consideration of the above records, the Judge shall decide whether:

6 (1) The evidence supports the conclusion that the defendant or
7 defendants failed to comply with the appropriate standard of care.

8 (2) The evidence does not support the conclusion that the defendant or
9 defendants failed to meet the applicable standard of care.

10 (3) The conduct complained of was or was not a factor in the resultant
11 damages.

12 (f) If the Judge finds that the evidence supports the conclusion that the
13 defendant(s) failed to comply with the appropriate standard of care and that the
14 conduct complained of was a factor in causing damages to claimants(s), the Judge
15 shall proceed to set a monetary settlement value on the claim, distinguishing between
16 economic and noneconomic damages.

17 (g) The record of Pre-Screening proceedings and the Pre-Screening decision
18 reached by the Judge shall remain sealed for thirty (30) days; however, the Pre-
19 Screening Judge may order the Pre-Screening Decision sealed temporarily or
20 permanently upon agreement by the parties, and permanently if a trial is not
21 pursued.

22 (h) Either party may pursue their right to a jury or a non-jury trial within 30
23 days after the Pre-Screening Judge renders its decision by notifying the court of the
24 party's intent to proceed to trial.

25 (i) The Pre-Screening Decision of the Judge shall be admissible as evidence
26 in the pending Superior Court action brought by the claimant, but such a decision
27 shall not be conclusive and can be refuted given admissible conflicting evidence.

1 § 10108. Authority to Enact Rules and Procedures ~~Selection for~~
2 ~~Arbitrators.~~

3 The Supreme Court of Guam is authorized to enact rules and procedures
4 implementing the Pre-Screening provisions of this Act.

5 ~~An arbitration under this Chapter shall be heard by a panel of three (3)~~
6 ~~arbitrators. The chairperson shall be decided by the three (3) panel members and~~
7 ~~shall have jurisdiction over pre-hearing procedures. The three (3) panel members~~
8 ~~shall include an attorney, a physician, preferably but not necessarily from the~~
9 ~~respondent's medical specialty, and the third shall be a person who is neither a~~
10 ~~doctor, lawyer, or representative of a health care institution or insurance company.~~
11 ~~A minimum of two (2) of the three (3) panel members shall be residents of Guam.~~

12 ~~(a) Except as otherwise provided in subsection (d), arbitrator candidates~~
13 ~~shall be selected pursuant to the rules and procedures of the Association from~~
14 ~~a pool of candidates generated by the Association. The rules and procedures~~
15 ~~of the Association pertaining to a selection of arbitrators under this chapter~~
16 ~~shall require that the Association send simultaneously to each party an~~
17 ~~identical list of five (5) arbitrator candidates in each of the three (3) categories~~
18 ~~together with a brief biographical statement on each candidate. A party may~~
19 ~~strike from the list any name which is unacceptable and shall number the~~
20 ~~remaining names in order of preference. When the lists are returned to the~~
21 ~~Association they shall be compared and the first mutually agreeable candidate~~
22 ~~in each category shall be invited to serve.~~

23 ~~(b) Where no mutually agreed upon arbitrator is selected for any~~
24 ~~category, a second list of that category shall be sent pursuant to subsection (a).~~

25 ~~(c) If a complete panel is not selected by mutual agreement of the~~
26 ~~parties pursuant to subsections (a) and (b) then under the applicable rules and~~
27 ~~procedures of the Association, the Association shall appoint the remainder of~~

1 the panel on whom agreement has not been reached by the parties. The
2 appointment by the Association shall be subject to challenge by any party for
3 cause which challenge may allege facts to establish that unusual community
4 or professional pressures will unreasonably influence the objectivity of the
5 panelists. A request to strike an arbitrator for cause shall be determined by the
6 regional director or comparable officer of the Association.

7 (d) The parties shall not be restricted to the arbitrator candidates
8 submitted for consideration. If all parties mutually agree upon a panelist
9 within a designated category, the panelist shall be invited to serve.

10 **§ 10109. Mediation Challenge for Bias.**

11 Parties may, at any time make a motion to the Pre-Screening Judge to hold
12 proceedings in abeyance upon mutual consent and pursuant to any agreed upon terms
13 and conditions, while the parties submit their dispute to Mediation pursuant to the
14 provisions of Chapter 43A, Title 7, of the Guam Code Annotated.

15 The Association shall make an initial screening for bias as may be appropriate
16 and shall require a candidate for a particular case to complete a current personal
17 disclosure statement under oath. In addition to other relevant information this
18 statement shall disclose any personal acquaintance with any of the parties or their
19 counsel and the nature of such acquaintance. If this statement reveals facts which
20 suggest the possibility of partiality, the Association shall communicate those facts
21 to the parties if the panelist is proposed by the arbitration association.

22 (a) Any party may propound reasonable questions to an arbitrator
23 candidate if such questions are propounded within ten (10) days of the receipt
24 of the candidate's name. Such questions shall be propounded through the
25 Association and the candidate shall respond to the Association promptly.

26 (b) A party shall not communicate with a candidate directly or
27 indirectly except through the Association at any time after the filing of the

1 demand for arbitration. Any candidate who is aware of such communication
2 shall immediately notify the Association.

3 **§ 10110. Application of Guam International Arbitration Law;**
4 **Decision shall be Final and Binding Rules of Arbitration.**

5 Parties may, at any time make a motion to the Pre-Screening Judge to hold
6 proceedings in abeyance upon mutual consent and pursuant to any agreed upon terms
7 and conditions, while the parties submit their dispute to arbitration pursuant to the
8 Guam International Arbitration Law provided for in Chapter 42A, Division 3, Title
9 7, of the Guam Code Annotated. The decision of an arbitral tribunal involving a
10 medical malpractice dispute submitted in accordance to the Guam International
11 Arbitration Law shall be final and binding.

12 ~~The arbitration proceeding shall be subject to rules promulgated by the~~
13 ~~Association in conformance with this chapter.~~

14 **§ 10111. Arbitration of Disputes Involving Sexual Assault and Sexual**
15 **Harassment Multiple Petitioners and Multiple Respondents.**

16 Notwithstanding any other provision of law, at the election of the person
17 alleging conduct constituting a sexual assault dispute or sexual harassment dispute,
18 or the named representative of a class or in a collective action alleging such conduct,
19 this chapter shall not apply.

20 ~~In cases involving a common question of law or fact, when there are multiple~~

26 ~~this chapter is deemed to be bound by the joinder of a new party.~~

1 **§ 10112. Offer of Reparation.** Prior to the institution of a proceeding ~~or~~
2 claim, or Pre-Screening Complaint by a patient, any offer of reparations and all
3 communications incidental thereto made in writing to a patient by a health
4 professional or health care institution are privileged and may not be used by any
5 party to establish the liability or measure of damages attributable to the offeror.

6 (a) Such an offer shall provide that a patient has thirty (30) days to
7 accept or reject the offer, or such lesser period of time as may be necessitated
8 by the condition or health of the patient.

9 (b) After any rejection or the lapse of the applicable time, any party
10 may file a Pre-Screening Complaint pursuant to this chapter ~~demand~~
11 ~~arbitration.~~

12 (c) Any such offer to a patient shall include a statement that the patient
13 may consult legal counsel before rejecting or accepting the offer.

14 (d) In a case where a potential claim is identified by a health
15 professional or health care institution where reparations, in its judgment, are
16 not appropriate, the professional or institution may, at its option, ~~file a demand~~
17 ~~for arbitration~~ file a Pre-Screening Complaint which ~~demand~~ shall identify the
18 potential claim and deny liability.

19 **§ 10113. Appointment of Guardian Ad Litem.**

20 (a) When a minor, or an insane or incompetent person is a petitioner,
21 he must appear either by general guardian or a Guardian Ad Litem appointed
22 by the Superior Court of Guam. A Guardian Ad Litem may be appointed ~~in a~~
23 ~~claim for arbitration under this chapter~~ when it is deemed by a judge of the
24 Superior Court of Guam expedient to represent the minor, insane, or
25 incompetent person in the ~~arbitration~~ proceeding, notwithstanding he may
26 have a general guardian and may have appeared by him. The general guardian
27 or Guardian Ad Litem so appearing for an infant, insane or incompetent

1 person in any ~~arbitration~~ proceeding shall have the power to compromise the
2 same and to agree to any settlement or decision ~~of the arbitrators~~ to be entered
3 therein against his ward, subject to the approval of the Judge. ~~a majority of~~
4 ~~the arbitrators~~.

5 (b) A Guardian Ad Litem appointed by the Superior Court of Guam to
6 pursue a claim ~~for arbitration~~ shall be appointed pursuant to §373 of the Guam
7 Code of Civil Procedure. Any petition to appoint a Guardian Ad Litem to
8 pursue a claim for arbitration shall have a copy of the Pre-Screening
9 Complaint ~~demand for arbitration~~ attached thereto.

10 **§ 10114. Stay of Proceedings When Suit Is Filed.** If any suit or proceeding
11 is brought in the courts of Guam upon any issue referable to arbitration under this
12 chapter, the court in which said suit is pending, upon being satisfied that the issue
13 involved in such suit or proceeding is referable to Pre-Screening ~~arbitration~~ under
14 this chapter, shall upon application of one of the parties, stay all proceedings in the
15 action until such Pre-Screening ~~arbitration~~ has been had in accordance with the terms
16 of this chapter.

17 **§ 10115. Failure to Arbitrate Under This Chapter.** The party aggrieved by
18 the alleged failure, neglect, or refusal of another to Pre-Screening ~~arbitrate~~ under this
19 chapter, may petition the Superior Court of Guam, for an order directing that such
20 Pre-Screening ~~arbitration~~ proceed in the manner provided for in this chapter. Five
21 (5) days' notice in writing of such application shall be served upon the party in
22 default. Service thereof shall be made in the manner provided by law for the service
23 of summons in the Superior Court of Guam. The court shall hear the parties, and the
24 court shall then make an order directing the parties to proceed to Pre-Screening
25 ~~arbitration~~ in accordance with the terms of this chapter.

26 ~~**§ 10116. Service of Documents upon Arbitrators; Ex Parte Contract.**~~
27 ~~Once the arbitration panel has been selected, each of the arbitrators shall be provided~~

1 with a copy of the demand for arbitration and any responses thereto by the
2 Association. Each of the arbitrators shall also be provided by the Association with
3 the parties' notices to each other identifying experts, witnesses, documents and
4 arbitration briefs as authorized in this chapter. Any motions or requests for additional
5 discovery shall also be served upon each of the arbitrators through the Association.

6 **§ 10117. Witnesses Before Pre-Screening Judge Arbitrators.** The Pre-
7 Screening Judge panel or its chairperson in the arbitration proceeding shall, upon
8 application by a party to the proceeding, and may upon its own determination, issue
9 a subpoena requiring a person to appear and be examined with reference to a matter
10 within the scope of the proceeding, and to produce books, records, or papers
11 pertinent to the proceeding. In case of disobedience to the subpoena, the Judge in
12 Pre-Screening may chairperson or a majority of the arbitration panel in the
13 arbitration proceeding may petition the Superior Court of Guam to require the
14 attendance and testimony of the witness and the production of books, papers, and
15 documents. The Superior Court of Guam, in case of contumacy or refusal to obey a
16 subpoena, may issue an order requiring that person to appear and to produce books,
17 records, and papers and give evidence touching the matter in question. Failure to
18 obey the order of the Court may be punished by the Court as contempt. The fees for
19 the attendance of any person to attend before the Pre-Screening arbitration panel as
20 a witness shall be the same as the fees for witnesses subpoenaed before the Superior
21 Court of Guam. The Superior Court of Guam shall order a witness to pay the cost of
22 the aggrieved party, to include attorney's fees, if it is determined that the witness
23 wrongfully failed to appear during Pre-Screening before the arbitration panel.

24 **§ 10118. Evidence and Testimony.** A hearing shall be informal and the Pre-
25 Screening Judge arbitrators shall be the sole judge of the relevancy and materiality
26 of the evidence offered.

1 (a) The Pre-Screening Judge ~~arbitrators~~ may receive and consider
2 evidence in the form of an affidavit but shall give appropriate weight to any
3 objections made. All documents to be considered by the Pre-Screening Judge
4 ~~arbitrators~~ shall be filed at the hearing.

5 (b) Testimony shall be taken under oath and a record of the proceedings
6 shall be made by a tape recording. Any party, at the party's expense, may have
7 transcriptions or copies of the recording made or may provide for a written
8 transcript of the proceedings. The costs of any transcription ordered by the
9 panel for its own use shall be deemed part of the costs of the proceedings.

10 (c) Expert testimony shall not be required but where expert testimony
11 is used, it shall be admitted under the same circumstances as in a civil trial
12 and be subject to cross-examination.

13 (d) The party with the burden of establishing a standard of care and
14 breach thereof shall establish such standards whether by the introduction of
15 expert testimony, or by other competent proof of the standard and the breach
16 thereof, which may include the use of published works as provided in
17 subsection (e).

18 (e) Authoritative, published works on the general and specific subjects
19 in issue may be admitted and argued from, upon prior notice to all other
20 parties.

21 (f) The Pre-Screening Judge ~~panel~~ shall accord such weight and
22 probative worth to expert evidence as it deems appropriate. The Pre-Screening
23 Judge ~~panel~~ may call a neutral expert on its own motion, which expert witness
24 shall be subject to cross-examination by the parties. The costs of the expert
25 will be deemed a cost of the proceeding.

26 **§ 10119. Identification of Expert Witnesses.** Within thirty (30) days after
27 receipt of defendants answer ~~the arbitrators have been selected~~, any claimant

1 ~~petitioner~~ pursuing a claim against a defendant ~~respondent~~ shall identify the expert
2 witnesses that the claimant ~~petitioner~~ will call at the Pre-Screening arbitration
3 hearing. When identifying such experts, the claimant ~~petitioner~~ shall provide the
4 name of the expert, the address of the expert, and shall state the subject matter on
5 which the expert is expected to testify, and state the substance of the facts and
6 opinions to which the expert is to testify and a summary of the grounds for each
7 opinion. Within thirty (30) days after the claimant ~~petitioner~~ has identified his
8 experts, the defendant ~~respondent~~ shall identify the expert witnesses that the
9 defendant ~~respondent~~ will call to testify at the Pre-Screening arbitration hearing. The
10 defendant ~~respondent~~ shall provide the name of the expert witness, the address of
11 the expert witness, and state the subject matter on which the expert is expected to
12 testify, and state the substance of the facts and opinions to which the expert is
13 expected to testify and a summary of the grounds for each opinion.

14 **§ 10120. Identification of Witnesses and Documents.** Within thirty (30)
15 days after the defendant ~~respondent~~ has identified defendant's ~~respondent's~~ expert
16 witnesses, the parties shall exchange a list of witnesses that they expect to call to
17 testify at the Pre-Screening arbitration hearing along with a summary of each
18 witnesses' proposed testimony. The parties shall also provide each other with copies
19 of all documents and material that they intend to introduce as evidence at the Pre-
20 Screening arbitration hearing.

21 **§ 10121. Additional Discovery.** Additional discovery, not otherwise
22 provided for in this chapter, such as depositions, interrogatories and requests to
23 produce, shall not be permitted unless:

- 24 (a) The parties stipulate to allow additional discovery; or,
25 (b) A Pre-Screening Judge at Pre-Screening may ~~A majority of the~~
26 ~~arbitrators at the pre-arbitration conference provided for in § 10122 of this~~
27 ~~chapter~~ authorize additional discovery for good cause shown upon the

1 application of a party to the Pre-Screening ~~arbitration~~ proceeding. The Pre-
2 Screening Judge ~~arbitrators~~ shall liberally authorize additional discovery if it
3 is necessary in order for a claimant or defendant ~~petitioner or respondent~~ to
4 more adequately present or defend a claim.

5 **§ 10122. Time and Place of Pre-Screening ~~Arbitration~~ Hearing.** Within
6 thirty (30) days after the parties have exchanged their lists of witnesses and provided
7 each other with the documents that the parties intend to introduce as evidence at the
8 Pre-Screening ~~arbitration~~ hearing, ~~the arbitrators shall meet at a place designated by~~
9 ~~the chairperson and~~ the Pre-Screening Judge shall conduct a pre-screening
10 ~~arbitration~~ conference for the purpose of deciding upon a date and place for the Pre-
11 Screening ~~arbitration~~ hearing, and for the purpose of deciding whether additional
12 discovery should be permitted pursuant to § 10121 of this chapter. ~~The arbitrators,~~
13 ~~or a majority of them, shall agree upon a date and place for the arbitration hearing.~~
14 The Pre-Screening ~~arbitration~~ hearing shall be conducted within ninety (90) days
15 after the pre-screening ~~arbitration~~ conference between the ~~arbitrators and the parties~~
16 unless agreed otherwise by the parties. Oral notice to the parties at the pre-screening
17 ~~arbitration~~ conference of the date, time and location of the Pre-Screening ~~arbitration~~
18 hearing shall be deemed sufficient.

19 **§ 10123. Pre-Screening ~~Arbitration~~ Briefs.** Any Pre-Screening ~~arbitration~~
20 brief to be filed by a claimant ~~petitioner~~ must be filed at least ten (10) working days
21 before the Pre-screening ~~arbitration~~ hearing. Any Pre-Screening ~~arbitration~~ brief to
22 be filed by a defendant ~~respondent~~ must be filed at least five (5) working days before
23 the Pre-Screening ~~arbitration~~ hearing. A claimant ~~petitioner~~ may file a reply brief,
24 which shall respond only to matters discussed in the defendant's ~~respondent's~~ Pre-
25 Screening ~~arbitration~~ brief, no later than two (2) working days before the arbitration
26 hearing.

1 (a) The Pre-Screening Judge panel may order submission of post-
2 hearing briefs within ten (10) calendar days after the closing of hearings. In
3 written briefs, each party may summarize the evidence in testimony and may
4 propose a comprehensive award of remedial or compensatory elements.

5 **§ 10124. Representation by Counsel.** Any party may be represented in
6 hearings ~~before the arbitration panel~~ by counsel. A party may appear without
7 counsel, and shall be advised of such right and the right to retain counsel in a manner
8 calculated to inform the person of the nature and complexity of a proceeding. ~~by a~~
9 ~~simple concise form to be distributed by the Association administering the~~
10 ~~arbitration.~~

11 **§ 10125. Attendance at Hearings.** Parties ~~to the arbitration~~ and their counsel
12 are entitled to attend all hearings. Non-party witnesses may be excluded by either
13 party upon request.

14 **§ 10126. Oaths.** The Pre-Screening Judge ~~arbitrators~~ shall require all
15 witnesses at the Pre-Screening arbitration hearing to testify under oath.

16 **§ 10127. Pre-Screening Arbitration in the Absence of a Party.** The Pre-
17 Screening arbitration may proceed in the absence of any party who, after due notice,
18 fails to be present. An award shall not be made solely on the default of a party. The
19 Pre-Screening Judge ~~arbitrators~~ shall require the attending party to submit evidence.

20 **§ 10128. Adjournments.** Hearings may be adjourned by the Pre-Screening
21 Judge ~~a majority of the arbitrators~~ only for good cause, and an appropriate fee will
22 be charged if the arbitrators determine that a party has wrongfully caused an
23 adjournment to take place.

24 ~~**§ 10129. Waiver of Statutory Rights.** Any party who proceeds with~~
25 ~~arbitration after knowledge that any provision of this chapter has not been complied~~
26 ~~with and fails to state his objections thereto in writing shall be deemed to have~~
27 ~~waived his right to object.~~

1 **§ 10130. Fees and Costs of Pre-Screening Arbitration.** Except for the
2 parties to the Pre-Screening arbitration and their agents, officers, and employees, all
3 witnesses appearing pursuant to subpoena are entitled to receive fees and mileage in
4 the same amount and under the same circumstances as prescribed by law for
5 witnesses in civil actions in the Superior Court of Guam. The fee and mileage of a
6 witness subpoenaed upon the application of a party to the Pre-Screening arbitration
7 shall be paid by that party. The fee and mileage of a witness subpoenaed solely upon
8 the determination of the Pre-Screening Judge ~~the arbitrator or the majority of a panel~~
9 ~~of arbitrators~~ shall be divided by the Parties or as decided by the Pre-Screening Judge
10 ~~paid in the manner provided for the payment of the arbitrators' expenses.~~

11 (a) The costs ~~of each arbitrator's~~ fees and expenses, together with any
12 administrative fee may be assessed against any party in the award or may be
13 assessed among parties in such proportions as may be determined in the Pre-
14 Screening arbitration award. Each party shall bear its own attorney's fees in
15 the Pre-Screening arbitration proceeding.

16 **§ 10131. Damages.** Damages shall be monetary only and shall be without
17 limitation as to nature or amount unless otherwise provided by law.

18 ~~**§ 10132. Timely Award.** The award of the arbitrators shall be rendered~~
19 ~~promptly by the arbitrators and, unless otherwise agreed by the parties, not later than~~
20 ~~twenty (20) business days from the date of the close of the hearing. However, if the~~
21 ~~arbitrators fail to render an award within twenty (20) business days from the date of~~
22 ~~the close of the hearing, the arbitrators' award shall not be vacated on this ground~~
23 ~~unless it can be proven that a party has been seriously prejudiced due to the fact that~~
24 ~~the arbitrators have not rendered an award within twenty (20) business days.~~

25 **§ 10133. Award of Pre-Screening Judge Arbitrators.** A Pre-Screening
26 Judge majority of the panel of arbitrators may grant monetary damages only deemed
27 equitable and just.

1 (a) The award in the Pre-Screening arbitration proceeding shall be in
2 writing and shall be signed by the Pre-Screening Judge arbitrators ~~or a~~
3 ~~majority of the panel of arbitrators. An award cannot be rendered unless it is~~
4 ~~signed by a majority of the arbitrators.~~ The award shall include a
5 determination of all the questions submitted to Pre-Screening arbitration by
6 each party, the resolution of which is necessary to determine the dispute,
7 controversy, or issue.

8 (b) The Pre-Screening Judge panel shall determine the degree to which
9 each defendant respondent party, if more than one, was at fault for the total
10 damages accruing to any other party to the Pre-Screening arbitration,
11 considering all sources of damage involving parties to the Pre-Screening
12 ~~arbitration~~, but excluding the damages attributable to persons not parties to
13 the Pre-Screening arbitration.

14 (c) The panel shall prepare a schedule of contributions according to the
15 relative fault of each party which schedule shall be binding on those parties,
16 but such determination shall not affect a claimant's right to recover jointly and
17 severally from all parties where such right otherwise exists in the law.

18 ~~§ 10134. Delivery of Award to Parties. The parties shall accept as legal~~
19 ~~delivery of the award the placing of the award or a true copy thereof in the mail by~~
20 ~~the arbitrators addressed to such party at its last known address or to the party's~~
21 ~~attorney, or personal service of the award on the party or the party's attorney.~~

22 **§ 10135. Confirmation of Award.** At any time within one (1) year after an
23 Pre-Screening award is made, any party to the Pre-Screening arbitration may apply
24 to the Superior Court of Guam for an order confirming the award and thereupon the
25 court must grant such an order unless the award is vacated, modified, corrected, or
26 appealed as prescribed in §§ 10136, 10137 and 10139 of this Chapter. Notice of the
27 application shall be served upon the adverse party, and thereupon the court shall

1 have jurisdiction of such party as though he had appeared generally in the
2 proceeding. If the adverse party is a resident of Guam, service shall be made upon
3 the adverse party as prescribed by law for the service of a civil action in the Superior
4 Court of Guam. If the adverse party shall be a non-resident, then the notice of the
5 application shall be served in like manner as other process of the Superior Court of
6 Guam served upon non-residents.

7 **§ 10136. Vacation of Pre-Screening ~~Arbitration~~ Award.** In any of the
8 following cases, the Superior Court of Guam may make an order vacating the Pre-
9 Screening award upon the application of any party ~~to the arbitration~~:

10 (a) Where the Pre-Screening award was procured by corruption, fraud
11 or undue means;

12 (b) Where there was corruption in any of Pre-Screening proceedings
13 ~~the arbitrators~~;

14 (c) Where the Pre-Screening Judge arbitrators exceeded his or her ~~their~~
15 powers and the award cannot be corrected without affecting the merits of the
16 decision upon the controversy submitted; or

17 (d) Where the rights of such party were substantially prejudiced by the
18 refusal of the Pre-Screening Judge arbitrators to postpone the hearing upon
19 sufficient cause being shown therefore or by the refusal of the Pre-Screening
20 Judge arbitrators to hear evidence material to the controversy or by other
21 conduct of the Judge arbitrators contrary to the provisions of this chapter.
22 Where an award is vacated, the court shall direct a Pre-Screening re-hearing
23 ~~by the arbitrators~~, or if the court deems it appropriate, shall direct the parties
24 to select a new Judge arbitrators for another Pre-Screening arbitration
25 proceeding.

1 **§ 10137. Modification of Award.** In any of the following cases, the Superior
2 Court of Guam may make an order modifying or correcting the Pre-Screening award
3 upon the application of any party to the Pre-Screening arbitration:

4 (a) Where there was an evident material miscalculation of figures or an
5 evident material mistake in the description of any person, thing, or property
6 referred to in the award.

7 (b) Where the Pre-Screening Judge ~~arbitrators~~ have awarded upon a
8 matter not submitted to them, unless it is a matter not effecting the merits of
9 the decision upon the matter submitted.

10 (c) Where the award is imperfect in matter or form not effecting the
11 merits of the controversy. The court may modify and correct the award so as
12 to effect the intent thereof and promote justice between the parties.

13 **§ 10138. Notice of Motion to Vacate or Modify.** Notice of a motion to
14 vacate, modify, or correct an Pre-Screening award must be served upon the adverse
15 party or his attorney within thirty (30) days after the award is served upon the party
16 seeking to vacate, modify or correct the award.

17 **§ 10139. Notice of Appeal and Request for Trial De Novo.**

18 (a) Within thirty (30) days after the Pre-Screening award is served upon
19 the parties, any party may file with the clerk of the Superior Court of Guam
20 and serve on the other parties ~~and the Association~~ a written Notice of Appeal
21 and Request for Trial De Novo of the action.

22 (b) After the filing and service of the written Notice of Appeal and
23 Request for Trial De Novo, the case shall be set for trial pursuant to applicable
24 court rules.

25 (c) If the action is triable by right to a jury, and a jury was not originally
26 demanded but is demanded within ten (10) days of service of the Notice of
27 Appeal and Request for Trial De Novo by a party having the right of trial by

1 jury, the trial de novo shall include a jury, and a jury trial fee shall be paid as
2 provided by law.

3 **~~§ 10140. Procedures at Trial De Novo.~~**

4 ~~(a) The clerk shall seal any arbitration award if a trial de novo is~~
5 ~~requested. The jury will not be informed of the arbitration proceeding, the~~
6 ~~award, or about any other aspect of the arbitration proceedings. The sealed~~
7 ~~arbitration award shall not be opened until after the verdict is received and~~
8 ~~filed in a jury trial, or until after the judge has rendered a decision in a court~~
9 ~~trial.~~

10 ~~(db)~~ All discovery permitted during the course of the Pre-Screening
11 ~~arbitration~~ proceedings shall be admissible in the trial de novo subject to all
12 applicable rules of civil procedure and evidence. The court in the trial de novo
13 shall insure that any reference to the arbitration proceeding is omitted from
14 any discovery taken therein and sought to be introduced at the trial de novo.

15 ~~(c) No statements or testimony made in the course of the arbitration~~
16 ~~hearing shall be admissible in evidence for any purpose in the trial de novo.~~

17 **§ 10141. Scheduling of the Trial De Novo.** Every case transferred to the
18 court shall maintain the approximate position on the civil trial docket as if the case
19 had not been so transferred, unless at the discretion of the court, the docket position
20 is modified.

21 **§ 10142. The Prevailing Party in the Trial De Novo; Costs.**

22 (a) The Prevailing Party in a trial de novo is the party who has (1)
23 appealed and improved upon the Pre-Screening ~~arbitration~~ award by forty
24 percent (40%) or more, or (2) has not appealed and the opposing party has
25 appealed and failed to improve upon the Pre-Screening ~~arbitration~~ award by
26 forty percent (40%) or more. For the purpose of this rule, improve or improved

1 means to increase the award for a plaintiff or to decrease the award for the
2 defendant.

3 (b) The Prevailing Party under these rules, as defined above, is deemed
4 the prevailing party under any statute or rule of court, and as such is entitled
5 to costs of trial ~~trial~~ and all other remedies as provided by law.

6 **§ 10143. Sanction for Failing to Prevail in the Trial De Novo.**

7 (a) After the verdict is received and filed, or the court's decision
8 rendered in a trial de novo, the trial court shall impose sanctions, as set forth
9 below, against the non-prevailing party whose appeal resulted in the trial de
10 novo.

11 (b) The sanctions to be imposed by the court are as follows: (1)
12 Reasonable costs and fees (other than attorneys' fees) actually incurred by the
13 party but not otherwise taxable under the law; (2) Costs of jurors; (3)
14 Reasonable attorneys' fees actually incurred by the prevailing party.

15 (c) Sanctions imposed against a plaintiff will be deducted from any
16 award rendered. Sanctions imposed against a defendant will be added to any
17 award rendered.

18 **§ 10144. Applicability to Claims.**

19 **(A) Government of Guam and Its Agencies.** Claims against the
20 government of Guam and its agencies are governed by the Government Claims Act.
21 Thus, this chapter does not apply to claims against the Guam Memorial Hospital
22 Authority or other health care institutions established by the government of Guam.

23 **(B) Small Claims.** Notwithstanding 7 GCA, Chapter 4, Article 2,
24 §4202, a claim against any defendant for the small claims statutory limit or less, or
25 any subsequently amended Small Claims Statutory limit, shall be exempt from this
26 Chapter if filed with the Small Claims Division.

1 **§ 10145. Prospective Effect of Chapter.** This chapter ~~may~~ shall not apply to
2 any claim that accrues before the date that the chapter becomes law, at the election
3 of any party or agreement by both parties.

4 **§ 10146. This Chapter to Prevail.** The provisions of Title 5, Chapter 32,
5 Guam Code Annotated, entitled, Deceptive Trade Practices - Consumer Protection
6 Act, shall not be applicable to this chapter and to the extent any of the provisions of
7 this chapter are inconsistent or conflict with the provisions of the Deceptive Trade
8 Practices - Consumer Protection Act or any other provision of law, the terms of this
9 chapter shall prevail and control.

10 **§ 10147. Reporting Requirement.** The Judiciary of Guam shall submit an
11 annual report of the number of medical malpractice claims filed, the number of cases
12 that opted for mediation or arbitration, the number of cases resolved through the pre-
13 screening process, the number of cases found to be meritorious, and the number of
14 and outcomes of cases that proceeded to trial.

15 **§ 10147~~8~~. Severability Clause.** If any section or sentence of this chapter is
16 deemed unconstitutional, then that section or sentence shall be severed from the
17 chapter and the remainder of the chapter shall remain and be of full force and effect.”

18 **Section 2.** A new § 42A101(i)(20) is *added* to Chapter 42A of Division 3,
19 Title 7, Guam Code Annotated, to read:

20 “(20) Medical Malpractice.”

21 **Section 3.** § 42A101(j) of Chapter 42A, Division 3, Title 7, Guam Code
22 Annotated, is *amended* to read:

23 “(j) This Chapter 42A shall not affect any other law of Guam by virtue of
24 which certain disputes may not be submitted to arbitration or may be submitted to
25 arbitration only according to provisions other than those of this Chapter 42A
26 ~~including, but not limited to, arbitrations conducted pursuant to 10 GCA §§ 10100-~~
27 ~~10147.”~~

1 **Section 4.** This Act shall be effective one hundred and eighty (180) days after
2 enactment.
