AN ACT TO AMEND SUBSECTIONS (a) AND (d)(1) OF § 6235, ARTICLE 2, CHAPTER 6, TITLE 4, GUAM CODE ANNOTATED, RELATIVE TO CERTIFICATION PAY DIFFERENTIAL FOR CERTIFIED PUBLIC ACCOUNTANTS, CERTIFIED GOVERNMENT FINANCIAL MANAGERS, CERTIFIED FRAUD EXAMINERS, AND CERTIFIED INTERNAL AUDITORS AT THE GUAM COMMUNITY COLLEGE.

BE IT ENACTED BY THE PEOPLE OF GUAM:

2 Section 1. Legislative Findings and Intent. I Liheslaturan Guåhan finds 3 that the government of Guam recognized the vital certified skills of many accounting, auditing, budget, and management professionals working for the line 4 agencies, the Office of Public Accountability, the University of Guam and the 5 6 Department of Education through the enactment of Public Law 33-18 in 2015, which 7 provided a pay incentive to employees with the certifications of Certified Public Accountant (CPA), Certified Government Financial Manager (CGFM), Certified 8 9 Fraud Examiner (CFE), and Certified Internal Auditor (CIA). I Liheslatura further finds that the certified employees at the Guam 10

Community College were not included in the list of employees eligible for the pay

incentive under P.L. 33-18. In order to encourage qualified professionals to obtain

1	such certifications, certified employees of the Guam Community College should be						
2	made eligible for the certified pay differential provided under Guam law.						
3	It is, therefore, the intent of I Liheslaturan Guåhan to include certified						
4	employees of the Guam Community College in the list of employees eligible for						
5	certification pay differential by amending Subsections (a) and (d)(1) of § 6235						
6	Article 2, Chapter 6, Title 4, Guam Code Annotated.						
7	Section 2. Subsection (a) of § 6235, Article 2, Chapter 6, Title 4, Guarr						
8	Code Annotated, is hereby amended to read:						
9	"§ 6235. Certification Pay Differential for Certified Public Accountant,						
10	Certified Government Financial Manager, Certified Fraud Examiner, and						
11	Certified Internal Auditor.						
12	(a) The Director of the Department of Administration shall ensure						
13	the following classified and/or unclassified accounting, auditing, budgeting,						
14	and management professional positions within government of Guam line						
15	agencies, the Office of Public Accountability, the University of Guam, the						
16	Guam Community College and the Guam Department of Education shall be						
17	given a one-time incentive pay compensation as provided pursuant to this						
18	Section, to include, as follows:						
19	POSITION COMPENSATION						
20	Certified Public Accountant (CPA)

24	Section 3. Subsection (d)(1) of § 6235, Article 2, Chapter 6, Title 4, Guam						
25	Code Annotated, is hereby amended to read:						
26	"(d) Certification Pay Differential, Established.						

(1) All government of Guam line employees, the Office of Public Accountability, the University of Guam, the Guam Community College, and the Guam Department of Education employees who have obtained a nationally recognized certification as a Certified Public Accountant (CPA), Certified Government Financial Manager (CGFM), Certified Fraud Examiner (CFE), or Certified Internal Auditor (CIA) shall be entitled to receive a single certification pay differential."

Section 4. Effective Date. This Act *shall* be effective upon enactment.
