

**AN ACT TO AMEND §§ 63103.1 (a) AND (f) OF ARTICLE  
1, CHAPTER 63, TITLE 5, GUAM CODE ANNOTATED,  
RELATIVE TO THE STIPEND OF THE CIVILIAN  
VOLUNTEER CONSERVATION OFFICER  
RESERVISTS AT THE DEPARTMENT OF  
AGRICULTURE.**

**BE IT ENACTED BY THE PEOPLE OF GUAM:**

**Section 1.** §§ 63103.1 (a) and (f) of Article 1, Chapter 63, Title 5, Guam  
Code Annotated, is *amended* to read:

**“§ 63103.1. Civilian Volunteer Conservation Officer Reserve.**

(a) Creation. There is hereby created within the Department of  
Agriculture of the government of Guam, the Civilian Volunteer Conservation  
Officer Reserve, which shall be headed by the Director of Agriculture,  
hereafter referred to as the Director. The Director, subject to the advice and  
control of *I Maga'hågan Guåhan*, shall carry out the purposes of this Chapter  
and shall have such additional duties and responsibilities as are authorized  
herein.

1 (f) Same: Allowance. Each member of the Civilian Volunteer  
2 Conservation Officer Reserve who successfully completes probationary  
3 requirements as established by the Director and who contributes a minimum  
4 of forty-two (42) hours or more per month, shall receive compensation in the  
5 amount of Five Hundred Dollars (\$500.00) per month, for duties performed  
6 as a part-time Civilian Volunteer Conservation Officer as duly authorized in  
7 Subsection (e) of this Section.

8 The Department of Agriculture shall identify funds within department  
9 appropriations or other appropriate funding sources to satisfy the requirements  
10 of this Section.”

11 **Section 2. Effective Date.** This Act shall be effective upon enactment.

12 **Section 3. Severability.** If any provision of this Act or its application to any  
13 person or circumstance is found to be invalid or contrary to law, such invalidity shall  
14 not affect other provisions or applications of this Act that can be given effect without  
15 the invalid provision or application, and to this end the provisions of this Act are  
16 severable.
