9 **WHEREAS**, in August of 1996, Ms. Jovita B. Tajalle was promoted to a Payroll
10 Clerk (III); and

11 **WHEREAS**, in November 2002, Ms. Jovita B. Tajalle transferred to the Guam
12 International Airport Authority (GIAA) as a Payroll Supervisor; and

13 **WHEREAS**, in 2011 Ms. Jovita B. Tajalle was nominated for the Governors
