Bill No. 65-36 (COR) is an act to amend subsections (a)(4), (c)(1), (d)(2), and (d)(4), all of § 7120.1, Chapter 7, Title 16, Guam Code Annotated, relative to removing the date of expiration on removable windshield placards and extending the period of time for physician certification on temporary removable windshield placards. Currently, there is no fee associated with the issuance of removable windshield placards.
