The Bureau requests that Bill No. 131-36 (LS) be granted a waiver pursuant to Public Law 12-229, as amended for the following reason(s):

Bill No. 131-36 (LS) is "AN ACT TO TRANSFER LOT NO. 10126-1, CONSISTING OF 11,929+ SQUARE METERS IN THE MUNICIPALITY OF *DEDEDO* TO THE GUAM REGIONAL TRANSIT AUTHORITY (GRTA) FOR THE PURPOSE OF DEVELOPING AND CONSTRUCTING A PARK AND RIDE FACILITY."

The Bill transfers Lot No. 10126-1 in the Municipality of Dededo to GRTA for the purposes of developing and constructing a Park and Ride facility. If said lot is not developed within sixty months or (5) years of the enactment of this Act, then the lot shall automatically revert back to the government of Guam.

Per GRTA, the Agency has federal funding for the design and construction of this facility. However, GRTA does not possess Government of Guam property to construct a Park & Ride Facility. As a result, Bill No. 131-36 (LS) was introduced for this purpose.

As such, the bill is administrative in nature and poses no fiscal impact upon any funds of the Government of Guam.
