The Bureau requests that Bill No. 150-36 (COR) be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Bill No. 150-36 (COR) is "An Act to Amend Section 4 of Part II, Chapter II, Education, Public Law 35-99, Relative to the Use of Unexpended Funds from Fiscal Years 2019 and 2020 Guam Academy Charter School Fund to Support the Payments of Guam Academy Charter Schools' Prior Year Obligations."

The Bill makes amendments to strengthen the current language of the noted section of the public law to ensure that upon request, the existing prior year obligations of the Guam Academy Charter Schools shall be paid. Other than the already specified fund sources to support the payment of the Guam Academy Charter School's prior year obligations, the Bill does not provide any other additional fund sources nor make an appropriation.

As such, the proposed bill is administrative in nature.
