The Bureau requests that Bill No. 66-36 (COR) as amended by the Committee be granted a waiver pursuant to Public Law 12-229 as amended for the following reason(s):

Legislative Bill No. 66-36 as amended by the Committee is an act to amend § 58206, § 58202, and § 58203 of Article 2, Chapter 58, Title 12 of the Guam Code Annotated, to enhance and extend the Special Hotel Qualifying Certificate Program. The Amendments in the proposed legislation will extend the program for an additional ten (10) years up to December 31, 2031 and include the costs for the renovation and/or expansion of existing hotel properties as being eligible for certain benefits of the program.

As the Bill is administrative in nature, it poses no fiscal impact upon any funds of the Government of Guam.
