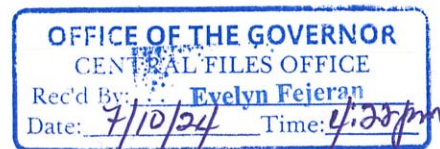

AN ACT TO APPROPRIATE TWO MILLION FOUR HUNDRED SIXTY-FIVE THOUSAND EIGHT HUNDRED ONE DOLLARS (\$2,465,801) FROM FISCAL YEAR 2024 GENERAL FUND REVENUES COLLECTED IN EXCESS OF THE ADOPTED LEVELS ENUMERATED IN PUBLIC LAW 37-42, AS AMENDED, FOR MERIT BONUS PAYMENTS OWED TO CURRENT AND FORMER EMPLOYEES OF THE GUAM MEMORIAL HOSPITAL AUTHORITY AND OTHER GOVERNMENT OF GUAM AGENCIES AND ENTITIES EARNED FROM FISCAL YEAR 2010 TO PRESENT.

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Findings and Intent.** Public Law 37-42 (“General
3 Appropriations Act of 2024”) contained a provision that required all merit bonuses

1 owed to government of Guam employees and retirees from Fiscal Year 2010 to the
2 present be paid by December 31, 2023. The provision required agencies to use funds
3 from their Fiscal Year 2024 allocations to make the payments.

4 On April 23, 2024, the Director of the Department of Administration reported
5 that merit bonuses remaining to be paid to active and former employees from
6 various agencies amounted to Seven Hundred Three Thousand Seven Hundred
7 Seventy-two Dollars (\$703,772). The report, however, did not account for the merit
8 bonuses earned by active and former employees of the Guam Memorial Hospital
9 Authority (GMHA). (see Attachment "A")

10 An inquiry with GMHA officials revealed that merit bonuses earned by the
11 hospital's active and former employees between 2012 and 2020 amounted to Eight
12 Hundred Fifty-nine Thousand Eight Hundred Twenty-nine Dollars and Fifty Cents
13 (\$859,829.50). It was further revealed that GMHA had no funds to pay their current
14 and former employees their earned bonuses and would be seeking assistance to
15 satisfy the debt. (see Attachment "B")

16 The employees of the government of Guam who earned meritorious pay for
17 their outstanding and exemplary performance have been made to wait far too long,
18 some for well over ten (10) years, for a payment they deserved. While the
19 government had failed to meet the statutorily imposed deadline to make all
20 payments, it is the intent of *I Liheslaturan Guåhan* to provide the necessary funding
21 (as reported by the Department of Administration and the Guam Memorial
22 Hospital Authority) to finally pay what is due to the deserving employees.

23 **Section 2. Appropriation.**

24 (a) Notwithstanding any other provision of law, the sum of Nine
25 Hundred Seventy-three Thousand Sixty-three Dollars (**\$973,063**) is hereby
26 appropriated from Fiscal Year 2024 General Fund revenues collected in
27 excess of the adopted levels enumerated in Public Law 37-42, as amended, to

1 the Guam Memorial Hospital Authority for the payment of merit bonuses
2 earned by active and former employees during the period of 2012 to 2020.
3 This appropriation shall be available until fully expended.

4 (b) Notwithstanding any other provision of law, the sum of One
5 Million Four Hundred Ninety-two Thousand Seven Hundred Thirty-eight
6 Dollars (\$1,492,738) is hereby appropriated from Fiscal Year 2024 General
7 Fund revenues collected in excess of the adopted levels enumerated in Public
8 Law 37-42, as amended, to the Department of Administration for the payment
9 of merit bonuses earned by active and former employees of executive branch
10 line agencies that lacked funding to satisfy the payments as per an April 23,
11 2024 report provided by the Director of the Department of Administration.
12 This appropriation shall be available until fully expended.

13 (c) The funds appropriated in this Section are not subject to *I*
14 *Maga'hågan Guåhan's* transfer authority and shall be expended only for the
15 purposes of this Act.

16 **Section 3. Severability.** If any provision of this Act or its application to any
17 person or circumstance is found to be invalid or inorganic, such invalidity shall not
18 affect other provisions or applications of this Act that can be given effect without
19 the invalid provision or application, and to this end the provisions of this Act are
20 severable.

21 **Section 4. Effective Date.** This Act shall be effective upon enactment.
