**AN ACT TO EXTEND THE FISCAL YEAR 2023
GOVERNMENT OF GUAM GROUP HEALTH
INSURANCE PLAN DOA/HRD/EB-RFP-GHI-23-001 TO
DECEMBER 31, 2023.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Intent.** It is the intent of *I Liheslaturan Guåhan* to
3 extend and rollover the current Fiscal Year 2023 Government of Guam Group Health
4 Insurance Plan DOA/HRD/EB-RFP-GHI-23-001 (Group Plan) to December 31,
5 2023.

6 **Section 2. Fiscal Year 2023 Government of Guam Group Health**
7 **Insurance Plan Extension.** Notwithstanding any other provision of law, the Fiscal
8 Year 2023 Government of Guam Group Health Insurance Plan DOA/HRD/EB-RFP-
9 GHI-23-001 is extended to December 31, 2023.

10 All payment terms, promises, requirements, conditions, provisions, and
11 representations contained and specified in the Government of Guam Group Health

1 Insurance Plan shall remain the same, survive, and continue under the Plan until
2 December 31, 2023.

3 **Section 3. Self-Funded Health Insurance Program.** Beginning on
4 January 1, 2024, the Exclusive Options selected by *I Maga'hågan Guåhan*, as
5 evidenced by her August 3, 2023 Memorandum of Approval, of SelectCare as the
6 Third-Party Administrator for Medical and Pharmacy, and NetCare as the Third-
7 Party Administrator for Dental shall be recognized by *I Liheslaturan Guåhan* in the
8 same manner as a bid award and gives it the same force and effect as a contractual
9 obligation.

10 **Section 4. Open Enrollment.** The Department of Administration shall
11 coordinate an Open Enrollment period of no less than three (3) weeks prior to
12 January 1, 2024 that provides multiple opportunities for government of Guam
13 Subscribers and their Dependents to learn of the differences in plan design and
14 provider networks for the Self-Funded Health Insurance Program when compared to
15 the extended Fiscal Year 2023 Government of Guam Group Health Insurance
16 Program. The Department of Administration shall publish and make available a Self-
17 Funded Health Insurance Program rate sheet that lists the employer and employee
18 premiums for all plans offered. This rate sheet shall be available on or before October
19 31, 2023.

20 **Section 5. Provider Orientation.** Each Third-Party Administrator
21 identified in Section 3 shall conduct provider orientations outlining any changes to
22 be expected in the Self-Funded Health Insurance Program as compared to the
23 extended Fiscal Year 2023 Government of Guam Group Health Insurance Program.
24 This orientation shall take place prior to January 1, 2024.

25 **Section 6. Effective Date.** Unless indicated otherwise, this Act shall be
26 effective upon enactment.
