**AN ACT TO GRANT *I MAGA'HÅGAN GUÅHAN*
TEMPORARY AUTHORITY OVER THE GUAM
DEPARTMENT OF EDUCATION.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Notwithstanding any other provision of law, effective
3 immediately until January 4, 2027, all duties, responsibilities, and authority of the
4 Guam Education Policy Board and the Superintendent of Education as provided in
5 Guam law shall be transferred to *I Maga'hågan Guåhan*.

6 **Section 2.** Notwithstanding any other provision of law, the Guam Education
7 Policy Board and the Superintendent of Education shall have such duties,
8 responsibilities, and authority as delegated by *I Maga'hågan Guåhan*.

9 **Section 3.** This Act should not be construed to affect existing compensation
10 and tenure of the Guam Education Policy Board and the Superintendent of
11 Education, nor the manner of selection of the Guam Education Policy Board as
12 provided by Guam law.

1 **Section 4.** Notwithstanding any other provision of law, effective immediately
2 until January 4, 2027, the powers of the Guam Department of Education Financial
3 Supervisory Commission shall be suspended.

4 **Section 5. Severability.** If any provision of this Act or its application to any
5 person or circumstance is found to be invalid or inorganic, such invalidity shall not
6 affect other provisions or applications of this Act that can be given effect without
7 the invalid provision or application, and to this end the provisions of this Act are
8 severable.

9 **Section 6. Effective Date.** This Act shall be effective upon enactment.
