**AN ACT TO ADD A NEW § 40145 TO ARTICLE 1
CHAPTER 40, TITLE 5 GUAM CODE ANNOTATED
RELATIVE TO REQUIRING THE AVAILABILITY OF
AUTOMATED EXTERNAL DEFIBRILLATORS IN ALL
SENIOR CENTERS AND RECREATIONAL FACILITIES
OPERATED BY VILLAGE MAYORAL OFFICES BY
JUNE 30, 2024.**

BE IT ENACTED BY THE PEOPLE OF GUAM:

Section 1. A new § 40145 is added to Article 1, Chapter 40, Title 5, Guam
Code Annotated to read as follows:

**“§ 40145. Access to Automated External Defibrillators (AEDs)
for Community Facilities.**

(a) Each mayoral office, that operates a senior center or recreational
facility (gyms, sports fields, courts etc.), provide access to an automated
external defibrillator AED. The AED shall be available during hours that the
facilities are open to the public. The Mayors Council of Guam may, by
resolution, create the provisions for deployment and use of AEDs to include,
but not be limited to, the following:

(1) the locations and quantities in their facilities of AEDs,

(2) the training requirements for staff and volunteers to use

the AEDs,

1 (3) Monitoring AEDs to ensure the devices will function
2 correctly as needed, and

3 (4) Security and protection of the AEDs from theft, criminal
4 mischief (vandalism) and damage or destruction from acts of nature.

5 (b) Access to AEDs, as required by paragraph (a), *supra*, must be
6 completed by June 30, 2024.

7 (c) The Mayors Council of Guam, shall annually, request from *I*
8 *Liheslaturan Guåhan* additional funding or amendments to the law herein as
9 may be necessary.”

10 **Section 2. Request for Appropriation.**

11 The Mayors Council of Guam shall submit a request for appropriation *to I*
12 *Liheslaturan Guåhan* fund Section 1 of this Act no later than June 30, 2023.
