**AN ACT TO *AMEND* § 22101 OF DIVISION 2, CHAPTER 22, TITLE 10, GUAM CODE ANNOTATED, RELATIVE TO EXTENDING THE VALIDITY OF HEALTH CERTIFICATES FROM TWELVE (12) MONTHS TO THIRTY-SIX (36) MONTHS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** § 22101 of Division 2, Chapter 22, Title 10, Guam Code  
3 Annotated is hereby *amended* to read:

4 **“§22101. Who Shall Have Health Certificates.**

5 Every person listed hereinafter in this Section *shall* obtain from the  
6 Director every ~~twelve (12)~~ thirty-six (36) months a health certificate:

7 (a) any person employed as a handler of food or drink in any  
8 eating and drinking establishment or at any food service establishment,  
9 as defined in Chapter 23; or in any food establishment, as defined in  
10 Chapter 24;

11 (b) all persons employed in institutional facilities, as defined  
12 in Chapter 25;

13 (c) all persons employed in barber shops, beauty shops and  
14 massage parlors, as defined in Chapter 26; and

15 (d) all other persons as may be required by law or as may be

1 required by the Director, in his discretion, by regulation. This Chapter  
2 shall not apply to any person by reason of his selling (1) fresh,  
3 unprocessed fruits, vegetables, nuts, eggs, live poultry or live pigs; or  
4 (2) canned or bottled drinks, including alcoholic beverages, in the  
5 original container of their manufacturer; or (3) candies or other  
6 confections in the original container of their manufacturer.”
