**AN ACT TO AMEND SECTION 29101 AND SECTION
29103 OF CHAPTER 29 OF TITLE 10 OF THE GUAM
CODE ANNOTATED RELATIVE TO SWIMMING
POOLS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1.** Paragraphs (c) and (d) of Section 2901 of Chapter 29 of Title 10
3 of the Guam Code Annotated are amended to read:

4 (c) *Public swimming pool* means any swimming or wading pool that is
5 not a private swimming pool as defined in this act. ~~available for public use, whether~~
6 ~~for a fee or free of charge; or any~~
7 ~~swimming or wading pool owned or used by any business, partnership,~~
8 ~~corporation or person for the use of their customers, clients, guests or~~
9 ~~employees including but not limited to a commercial pool, a community~~
10 ~~pool or a pool at a hotel, motel, resort, auto park, trailer park, apartment~~
11 ~~house or other multiple rental unit, private club, public club, public or~~
12 ~~private school, gymnasium or health establishment; and~~

1 (d) *Private residential swimming pool* means any swimming or wading
2 pool located on private residential property and under the direct control of
3 the homeowner, the use of which is limited to swimming or bathing by
4 ~~members of his family or guests~~ which is constructed in connection with or
5 appurtenant to single family dwellings, condominiums, townhouses, or apartment
6 complexes, and which is used solely by the persons maintaining their residence
7 within such dwellings, condominiums, townhouses, or apartment complexes and
8 the guests of such persons. Private pools are exempt from these regulations.

9 **Section 2. Severability.** If any portion of this Act is for any reason held
10 invalid or unconstitutional by any court of competent jurisdiction, such portion
11 shall be deemed a separate provision and shall not affect the validity of the
12 remaining portions of the Act.

13 **Section 3. Effective Date.** This Act shall take effect on the date of
14 enactment.
