3 **WHEREAS**, Leonel Crisostomo Arcangel was born on September 8, 1962 in  
4 Batac City, Ilocos Norte, Philippines to Lorenzo and +Ester Arcangel. He is married to  
5 Maria Theresa Lara Arcangel and is the father of three children; His eldest son, Lorenz  
6 Leomar L. Arcangel, his only daughter Marienel Liza Arcangel-Grino, and his youngest  
7 son, Lorie L. Arcangel; and

8 **WHEREAS**, Leonel earned his Bachelor of Science Major in Zoology from the  
9 University of Santo Tomas, Manila, Philippines in 1983 and then went on to earn his  
10 Associate of Science in Nursing Degree from the Excelsior College, Albany, New York

2 1989 as a Triage Specialist with the Guam Memorial Hospital Authority (GMHA); and

3           **WHEREAS**, Leonel then moved to the Department of Public Health and Social  
4 Services (DPHSS) in October 1990 as a Claims Processing and Utilization Review  
5 Officer; and

6           **WHEREAS**, he returned to the Guam Memorial Hospital Authority in June 2008  
7 and began his position as Staff Nurse I and then later returned to the Department of  
8 Public Health and Social Services (DPHSS) in January 2009 and worked as a  
9 Community Health Nurse; and

10           **WHEREAS**, Leonel has dedicated many years of service and has earned  
11 outstanding performance awards from Fiscal Year 1993 to Fiscal Year 2019 including  
12 the Outstanding Nurse with Adult Health, Emergency Care Nursing, Immunizations  
13 with Children and Adults, with Tuberculosis Care, STD, and Women and Child Health  
14 Outpatient Nursing Care and the Silent One Award during the Mag Pro Awards, and he  
15 was always willing to brainstorm, trouble shoot and provide expert advice when  
16 working with the Bureau of Family Health and Nursing Services (BFHNS) Nursing
